

**ADOPT-A –TRUCK PROGRAM:**

Residential: \$12.00 + state sales tax

Commercial: \$33.30 + state sales tax

The fee shall be paid in advance at City Hall Utility Billing Department 592-5281.

A City brush truck will be parked at your home by 4:00 P.M. and left overnight. The next business day between 7:00 A.M. and 8:00 A.M., City personnel will pickup the truck. **The truck can be filled with one of the following only:**

1. Brush ONLY
2. Lumber, roofing material, construction material and bulky items ONLY (no liquid, no concrete with rebar, no dirt, no large rocks, no asbestos, no tires)
3. Metals ONLY (Appliances not included)

It shall be unlawful for a residential customer to pay residential truck rental rates for work performed by a commercial user or contractor. Penalty is subject to prosecution in the Municipal Court.

**PLEASE NOTE:**

- **MIXED DEBRIS WILL BE REMOVED FROM THE TRUCK AND PLACED BACK ONTO RESIDENT’S PROPERTY.**
- **DO NOT LOAD CONCRETE, TIRES, BATTERIES, OR DEAD ANIMALS INTO TRUCK.**
- **DO NOT OVERLOAD TRUCK (DAMAGE RESULTING FROM OVERLOADING WILL BE THE RESPONSIBILITY OF CITIZEN RENTING TRUCK)**
- **NO BRUSH OR DEBRIS IS ALLOWED TO BE HANGING OVER SIDES, BACK OR TOP OF TRUCK.**
- **FEES FOR THIS PROGRAM ARE NON-REFUNDABLE. ONE RESCHEDULE ONLY.**

The truck will be used only for non-profit type deposit of waste. **I agree to assume all responsibility/liability for the use of the “brush truck”** and release, relinquish, discharge and shall save and hold harmless the City of Kingsville its employees, agents, representatives and officers, of and from any and all claims, demands, damages or causes of action asserted for damages to or loss of property, arising out of or attributed, directly or indirectly, to the operation of the “Adopt-A-Truck” program or the performance of the City of Kingsville under this agreement. **I further agree to accept all charges resulting from overloading the brush truck.**
