Sanitation Division – Public Works

The City of Kingsville is accepting applications for a Temporary Equipment Operator II in the Sanitation Division. Under direction operates sanitation vehicles, either residential, commercial, brush trucks, tractors and/or other equipment. Responsible for daily and minor maintenance on vehicles. Performs other duties as assigned.

### **Essential Duties:**

Drive truck for up to 10 hours daily, get in and out of truck several times daily; When delivering waste to landfill responsible for observing as truck unloads and identifying problem wastes; must be able to maneuver truck on narrow streets and alleys including backing up safely; speaks courteously to customers and reports route issues promptly; communicates on 2-way radio; may move roll-out containers; must be able to read street signs and addresses; must be able to remember routes and designated pick-up days; must clean out small compartments in trucks and keep truck clean; may be required to work Saturdays; and performs other duties as required for the daily operation of the division. Ability to use rake or shovel; clean, repair and/or deliver garbage containers; able to keep written records; answer phones; and attend training classes. Performs other assigned duties as required.

### **Training, Experience, and/or Other Requirements**

Valid Commercial Driver's License (CDL); Two (2) years experience operating one or more kinds of equipment specified for the class. Knowledge of proper care and skillful/safe operation of light/heavy equipment. Ability to follow written and oral instructions.

**Physical Requirements:** Ability to lift and carry up to 50 lbs several times daily; climbs, crawls, kneels, squats, stoop, stands, sits, and bends when driving or maintaining equipment; hear and see clearly when working around equipment or in traffic. Driving, using telephone, simple and power grasping, extension head and neck movements, up, down, right, and left field vision. Works outdoors in extreme temperatures and inclement weather with some exposure to dust, fumes, noise, mechanical, electrical and chemical hazards while using proper safety precautions.

### **Employee Behavior and Conduct**

City employees shall conduct themselves in a professional manner and shall exhibit and extend such professional conduct appropriate for the circumstances to those with whom they come into contact both internally and externally during the performance of their duties. Examples of professional conduct include, but are not limited to, being communicative, informative, fair, honest and respectful.

All City employees are required in the course and scope of their employment to provide services for the benefit of the general public during emergency situations that threaten the safety of Kingsville's citizens. City employees must be able to work immediately before, during, and/or immediately after an emergency.

All positions require the following: 1) Valid driver's license 2) satisfactory driving record and 3) proof of eligibility to work in the U.S. The successful applicant will be required to pass a pre-employment physical examination, drug screen and background investigation.
