The training facility hosting the training is managed by the Brownsville Police Department. GREAT COLLABORATION OF RESOURCES!!!










KTF Agent McGee Renders Aid to Flooded Stranded Motorist

On Tuesday, April 14, 2015, at approximately 6:30 AM Kingsville Task Force Agent McGee left his home in route to work. Agent McGee was driving eastbound on FM 234 towards Edroy, Texas when he noticed the roadway had flooded over and was under water for approximately 100 yards. Agent McGee observed that a Chevrolet Blazer had stalled in the middle of the

roadway and had water up to the center of the vehicle's door windows. Agent McGee noticed another vehicle, a Ford F-150 pickup that had been taken over by the water and the driver was waving at him through the truck's driver window. The high water took the Ford pickup into the trees and disappeared. Agent McGee turned on his police unit's take down lights and he grabbed his flash light. Another driver identified as Mr. Joey Mata pulled in behind McGee's patrol unit and Agent McGee asked that driver to call 911 Emergency Dispatch. Agent McGee removed his shoes and socks and walked into the water. At approximately 50 yards into the chest high water Agent McGee checked the status of the Chevrolet Blazer. After he was assured the Blazer was unoccupied, he walked to the Ford pickup that was off into the tree line and in neck high water. Agent McGee coaxed the male driver, later identified as Mr. Gernal Mann, to exit the Ford truck. Once Mr. Mann was out of the Ford truck, Agent McGee helped walk him back to his patrol unit. Those involved waited for approximately 45 minutes for emergency rescue. However, because of the ongoing flooding events they were not able to get to the scene. Agent McGee left



his patrol unit on the north east corner of his property and Mr. Mata drove him across another creek in his one ton Dodge 4X4 pickup back to his home. Mr. Mann stayed with Mr. Mata until the flood waters subsided and then they returned to their homes. Unselfish efforts by Agent McGee in those dark waters helped others in their time of need and prevented a catastrophe. GREAT WORK!!!

Task Force Narcotic Agents and K-9 Partners get Re-certified by NNDDA

On Friday, April 17, 2015, Kingsville Task Force Agents Kirkpatrick and Villalobos with their K-9 Partners (Apollo and Nitro respectively) went through the annual recertification required by the National Narcotic Detector Dog Association (NNDDA). 

Major Events during the period: April 7, 2015, Business Fire, Hurricane Car Wash: First arriving units found heavy smoke issuing from door on side of the building. The smoke began drifting across King Street and the street was closed by KPD. Firefighters knocked down the fire in the electrical room, but had difficulty in accessing the main power shutoff. Sparking electrical wires were observed throughout the building until the power was cut. There were no serious injuries reported by personnel. The fire appears to be electrical in nature.



April 9, 2015, Detached Garage Fire, Henrietta: First arriving fire department units found a detached garage fully involved in fire. The garage was located behind three homes, but was kept from spreading. Firefighters quickly knocked down the fire and began mop up and investigation. No injuries reported.





April 14, 2015, Severe Weather: The fire department responded on approximately 30 emergency calls during a 24 hour period. Responses included numerous down or arching power lines, tree and shrub fires caused by arching power lines, and other daily emergency responses. Several members of the fire department reported off duty for overtime and several volunteer firefighters reported to stand by in case of large incidents.

A/C System Update: Final Phase

With the installation of the thermostats, the balancing and adjusting of the air handlers, and the circulating of oil and Freon throughout the air conditioning (A/C) system, the final phase of the

A/C project is now complete. During the week of April 6, 2015, technicians with Ramos Refrigeration spent their time testing and fine-tuning the A/C system, and monitoring the cooling and humidity levels throughout the library. On April 14, 2015, Mr. Rudy Ramos, Jr. conducted a walk-through tour of the system with City and County officials: Mr. David Mason (Purchasing Director, City of Kingsville), Mrs. Melissa Perez (Risk Manager, City of Kingsville), and Mrs. Veronica Hare (Insurance Coordinator, Kleberg County). The officials wanted to check and view the placement of the new air handler units and dehumidifier system. They also wanted to gauge the efficiency of the equipment in each



zone, and to receive a final update from Ramos Refrigeration. The City and County officials were pleased with the A/C system and the performance of the equipment. Go team!

Carpet Update

The library is still working with Mrs. Veronica Hare regarding the replacement of the library's carpet prior to reopening. County Commissioners are considering several bids for the carpet and installation. At their next meeting on Monday, April 20, 2015, they will select a company for the carpet purchase and installation. It will take approximately one week for the carpet purchased to arrive, and another



three to five days for the carpet to be installed. Once the installation is completed, Mrs. Hare

will contact GCI Remediation (Gerloff Company), so they can bring back the library's books and furniture, which are currently housed in a clean storage suite at the Wild Horse Desert Mall. The next step will be to call back the reassigned employees, so that the entire staff can organize the book collections, clean the library, and plan for the grand opening. Because of the collaborative efforts of City and County officials, the mold remediation, the A/C installation, and the carpet installation are proceeding smoothly. If the carpet project continues as scheduled, the reopening of the library is tentatively set for Tuesday, June 9, 2015. Stay tuned for more information.

Library Beautification

Because the library is temporarily closed, the lawn maintenance staff has been unavailable. To



remedy the situation, Mr. Luke Stevens (Sanitation Supervisor, City of Kingsville) had members of his crew mow the front lawn on Monday, March 30, 2015. The Library's Board and Director would like to extend a special thanks to not only Mr. Stevens and his crew for all their hard work, but also to Mrs. Alice Byers and Keep Kingsville Beautiful (KKB) for their assistance in beautifying the library. KKB has assisted in sustaining the floral landscaping in the patio area, at the front entrance, and in the Poetry Garden. The library has been very appreciative of KKB's commitment to the library and looks forward to working with this organization. When possible, the library's core staff is lending a helping

hand in maintaining the lawns by raking leaves and cleaning debris on the premise. Special thanks also goes out to them for all their efforts.

Food Service Division

Food Service Inspections

Food Service inspections are conducted on a quarterly schedule per year based on the risk category to insure compliance with the Texas Food Service Establishment Regulations and local food sanitation ordinances. Risk levels include low, moderate and high risk. Establishment scoring is based on a demerit system, as per The Texas Food Establishment Rules. There are two types of violations. Critical violations are 5 and 4 points demerits per violation and non-critical violations are 3 points demerit violations. Critical Violations are improper practices and actions that directly contribute to food contamination and temperature abuse that may pose a potential risk to the public health, resulting in food borne illness. Critical violations must be corrected immediately or as directed by the Health Department.

Non critical violations are unacceptable practices that normally relate to the physical condition of an establishment, including equipment, cleaning and storage. Non Critical violations must be corrected before the next routine inspection or as directed by the Health Department.



The Corral Park Project continues. All equipment has been ordered and staff is waiting on the weather to clear so that we can start setting the trail in place and begin installing equipment as it arrives. The Doggie Cleanup station has arrived and the Pharmacy students (shown right) came out and put it together. Staff received a layout of the park from City Engineering which will assist in laying the trail and setting the elements around the proposed parking area and future amenities. Staff contacted AEP about



adding additional lighting to the park, which will be discussed soon.

The continued rains and recent big storms left the Parks with the loss of a very large mesquite tree that sat at the entrance to JK Northway. Some of the smaller wood was cut off and picked up by a veterans' group to be used for a fundraiser for the new American Legion Hall. The remainder of the large trunk of the tree is going to be used for landscaping around some trees in the Rec Hall Courtyard. Some of the trunk



wood from the many other trees will also be used for this landscaping project. The park had some minor damage to a couple of structures in Dick Kleberg Park (DKP) and has reported those to Risk Management.

Staff still has a lot of work in the parks to deal with trees and brush and look forward to the upcoming week with the return of the inmates from San Diego so they can assist in catching up.



In between rains we received assistance from City Staff to move the mulch and dirt left from the Flato Park Project. The remaining dirt and sand was used to fill some of the playground beds and to fill some low spots in the area where patrons are currently parking which is actually the old alley that ran in between the school and the park.

The roofing project at the Brookshire Pool has been completed. It looks great. The area still has a long way to go to get the pool ready for a June opening. The pool has been drained and will be prepped for refill. Additional work to get the pool ready includes installing new lighting under the new roofing, painting the building and storage rooms, demo of the existing shade structures and placing new poolside furniture, signage and design elements. Our target opening day would be June 1.

Staff has been meeting with County Extension staff to plan our summer activities. The number of days that programming will be offered has been reduced from five to four days to better fit within the funding available. The program will stay much the same this summer and will include two days a week for kids from ages 5-8 and two for kids ages 9-13. The morning camps will include daily exercise, nutrition, anti-drug and bullying education along with outdoor recreational, recycling, and artistic instruction to local and area attractions. Staff is currently taking applications for summer staff. They are also soliciting sponsorships to help fund our Cinema Summer Outdoor Movie Series. The program is very popular and a lot of fun, but the

licensing is expensive at \$350.00 per movie. Staff is hoping to share the cost of each movie with a local sponsor who would be highlighted on the big screen that is provided by the Kingsville Boxing Club at each event.

Once the program planning is complete is will be distributed to all the Kleberg County Schools in the Parks Department's Summer Activities Brochure that has been published for many years. The info will also be available on the pages staff is working on to be added to the City's website. They are also planning to provide registration opportunities at National Kids to Parks Day to be celebrated in DKP on May 16th.

The Parks & Recreation Manager just returned from a 3 day trip to Austin where her main objective was to recertify as a Certified Public Pool Operator, which is required of any public pool in the State of Texas. This was her third certification for the operation of public pools in our community. A new certification is required every 5 years.

While in Austin, she visited the Grants Division of Texas Parks & Wildlife to discuss the existing Parks Master Plan which was adopted by both Kleberg County and City of Kingsville back in 2011. It still has a couple of more years before it has to be redone but staff does need to do an update to the plan probably later this year. The criteria and instruction for the update is detailed by the Texas Parks & Wildlife. Parks and City staff can complete this in-house to meet our obligation and then discuss working on grant applications and a new master plan. The update can set new priorities that will meet changing needs of our Parks System. Staff will certainly be visiting with City and County Commissions, as well as the public, to get their input on priorities.

Call Before You Dig. It's The Law!

Because even relatively minor excavation activities like landscaping or fencing can cause damage to a pipeline, its protective casing, and/or buried utility lines, always contacts your state's One-Call Center before engaging in any excavation, construction, farming, or digging. Most states require two working-days' notice to the One-Call center to allow the utility companies to mark their pipelines and utilities at your proposed digging site. In fact, most serious damage done to pipelines is done when a third party inadvertently excavates, blasts, or drills



within a pipeline right-of-way. By contacting the One-Call Center first, this type of damage can be prevented. Sometimes pipeline companies will require a representative to be present to

monitor the safe excavation. One easy, free phone call to 811 starts the process to get your underground pipelines and utility lines marked. When you call 811 from anywhere in the country, your call will be routed to your state's One-Call Center. Once underground lines have been marked for your project, you will know the approximate location of your pipelines and utility lines and can dig safely. City of Kingsville and Its Residents Get a Taste of Severe Thunderstorms



Severe Thunderstorms are issued when either a severe thunderstorm is indicated by the WSR-88D radar or a spotter reports a thunderstorm producing hail one inch or larger in diameter and/or winds equal or exceed 58 miles an hour; therefore, people in the affected area should seek safe shelter immediately. Severe thunderstorms can produce tornadoes with little or no advance warning. Lightning frequency is not a criteria for issuing a severe thunderstorm warning. They are usually issued for duration of one hour. They can be issued without a Severe Thunderstorm Watch being already in effect. Like a Tornado Warning, the Severe Thunderstorm Warning is issued by your National Weather Service Forecast Office. Severe Thunderstorm Warnings will include where the storm was located, what towns will be affected by the severe thunderstorm, and the primary threat associated with the severe thunderstorm warning. If the severe thunderstorm will affect the nearshore or coastal waters, it will be issued as the combined product--Severe Thunderstorm Warning and Special Marine Warning. If the severe thunderstorm is also causing torrential rains, this warning may also be combined with a Flash Flood Warning. If there is an ampersand (&) symbol at the bottom of the warning, it indicates that the warning was issued as a result of a severe weather report.

City of Kingsville Will Be Receiving Assistance from Ernestine Glossbrenner Unit Community Squad April 20th through the 23rd





The City of Kingsville may possibly once again be bringing the assistance of Offender Labor from one of our neighboring Correctional Facilities. The Risk Manager has suggested that the City request the E. Glossbrenner Unit for assistance from their Community Squad. The TDCJ Community Squad provides offender labor for the purposes of developing, improving, and restoring public land and buildings, as well as providing vocational programs for offenders to enhance rehabilitation and aid in reducing recidivism. Offender labor is utilized in order for certain offenders to fulfill community service court requirements while saving taxpayer dollars with no displacement of jobs currently held in the community.

City of Kingsville Continues Its Progress with City/County Parks and Golf Course





The Kingsville - Kleberg County Parks Department currently operates and maintains three major park areas. and eight smaller neighborhood parks. On April 25, 1958, Robert J. Kleberg, Jr. and Richard M. Kleberg Jr., trustees of the Alice G.K. Kleberg Foundation donated 184.5 acres of land to Kleberg County. The park was named after Dick Kleberg Sr., a congressman and Chairman of the Board of King Ranch from 1950-1955. The Dick Kleberg Park is the main park within our park system. The park hosts a wide variety of activities and facilities for all ages of recreation enthusiasts. The park is home to two baseball fields, 3 little league baseball fields, 2 softball fields in addition to one -three field multi-purpose softball complex and one - three field adult softball complex. Staff has recently been assessing windstorm insurance coverage for the parks and other City properties.

ignition hazards have specialized installation requirements, raising the installation cost and complexity of wired networks. Consequently many deployments utilize both wired and wireless technologies, often combining licensed and unlicensed spectrum across a number of different frequencies. Until this recently hybrid patchwork communication technologies was the best achievable solution, particularly for mobile, data-intensive clients such as rugged handheld terminals and vehicle-mounted terminals. Still, the final results fall short of both IT requirements and user expectations.

Many organizations require data and voice industrial communications in and outdoor environments. Historically, these needs have been met by a patchwork of copper or fiber-optic cable in the ground, low-bandwidth 900 MHz and 2.4 GHz wireless links, and depending on the particular site, satellite networks too. While wireline networks can support high data rates with high reliability, it is not always feasible or costeffective to dig trenches or string overhead wire across chemical plants, container ports or offshore oil platforms. Manufacturing plants and storage facilities with explosive atmospheres and



Wireless signal quality and available bandwidth is often highly variable across an industrial or

outdoor site, resulting in user complaints. For the IT group, fault management and performance monitoring can be especially difficult; the lack of homogeneous monitoring and management for the diverse wireless links results in disparate alarm and reporting consoles. Indeed, many organizations find they must support separate, overlaid communication networks, each with its own infrastructure, resulting in duplicate management systems and IT effort. Worse yet, overlaid networks using legacy and new equipment on the same frequencies can result in unintentional interference. Many communication services in industrial and outdoor environments require low bandwidth: telemetry and SCADA applications generate only a few kbps on average, easily within the range of any wireless technology today. Finally, many applications such as power generation, water treatment and chemical plants intend to add real-time wireless video surveillance for security purposes, driving even higher data rates and predictable quality of service (QoS). In recent years these new requirements on outdoor and industrial communications have increasingly stressed communications infrastructure designs. Meanwhile, a number of developments in Wi-Fi for enterprise customers have reached the stage where, with a small number of additional features, the technology is able to profoundly improve the outdoor experience and, in so doing, consolidate, simplify, and flatten the traditional patchwork and overlay of disparate communications networks.

Wireless technology began outdoors to help industrial customers meet business needs where they could not run cable. As this technology was standardized as Wi-Fi, dramatic cost reductions fuelled by economies of scale made it accessible to the consumer and enterprise markets. Enterprise Wi-Fi technology has evolved over the last ten years to the extent that it has now solved many issues involving management, scale, reliability and performance: many enterprises now rely on their indoor Wi-Fi networks as the primary means of connecting to the corporate LAN for PC users, and organizations such as hospitals, retail stores and universities rely on Wi-Fi for voice communications for mobile workers. Video surveillance is another important service today leveraging the Wi-Fi network, and benefits from Wi-Fi's high bandwidth and quality of service capabilities. Role-based WLANs can support a mix of sophisticated, capable devices such as PCs, as well as low-complexity devices such as bar-code scanners, without compromising security. A recent addition to state-of-the-art enterprise Wi-Fi is mesh technology, where access points can use wireless links for their backhaul connection rather than wired Ethernet. Since many enterprise access points include two radio units, it is possible to maximize performance by using one radio for backhaul while the other serves local users. This combination of Wi-Fi technologies is now capable of serving outdoor and hazardous environments. Ruggedized access points can be used to drive point-topoint and point-to-multipoint links over distances of several miles, offering comparable performance to previous specialized radio equipment at very cost-effective price points due to Wi-Fi's high production volumes. The networks formed from these links may be used to bridge wired LAN segments, or to light up remote areas with Wi-Fi coverage, enabling a variety of Wi-Fi terminals including telemetry, ruggedized PCs, Wi-Fi phones, and video surveillance cameras. The new generation of outdoor access points is versatile, with many options for mounting and power, and provides installation options such as integral signal strength meters for antenna alignment. The units are small, lightweight, and have modest power requirements compared to their predecessors, while they are specified for harsh conditions such as explosive and corrosive atmospheres. By using Wi-Fi, organizations can consolidate the current patchwork of communications links and services onto a single Wi-Fi network, with central management, reporting, and alarms. The networks can be self-organizing in RF channel selection and connection routing, reacting automatically to remedy failures. Quality of service features across all products assures multi-service capability throughout the network. The wide availability of inexpensive, ruggedized Wi-Fi terminals allows new options for a mobile workforce, providing a level of services on the move that was previously only available when workers returned to their offices. These new capabilities will be of special interest in the upstream and downstream petroleum industry, for chemical plants, power and water treatment facilities and many other applications where networks must cover distances of several miles with offered data rates of several Mbps.




The event was ended when lights were broken and lit to symbolize breaking the chain with child abuse and neglect.

Patrol Division Activity April 1 – April 15

The Patrol Division responded to hundreds of calls and wrote at least 180 reports. The Patrol Division issued 112 citations and 70 written warnings. Over the past two weeks, patrol officers took fifteen assault reports and two aggravated assault reports. One burglary of a building was reported, while three residential burglaries and seven vehicle burglaries were reported. Four criminal mischief reports were taken while two reports for criminal trespass were made.

Two unattended deaths were investigated; one report of Fraudulent Use of Identifying Information was taken; and, three reports were made for Harassment. There were thirteen reports of theft, two vehicles were reported stolen, and officers responded to several fights.

CALL SAMPLE:



On April 1, an officer observed a vehicle disregard the stop sign at 7th and Yoakum. In addition, the driver was talking on a cell phone. After the vehicle was stopped, the male was arrested for being in possession of "synthetic" marijuana.

On April 4, an officer stopped at Brookshire Park to speak with a male in the parking lot. In plain view, the officer observed marijuana baggies and

cigars on the center console. The male was arrested for Possession of Marijuana.

On April 5, a motel manager reported a suspicious male had just entered an upstairs room. Officers arrived as the male was leaving the room, carrying a flat screen TV. The male had outstanding warrants and was arrested. It was determined that he wasn't staying at the motel and had no key. He was also charged with Burglary of Building. The manager believes that the same male is responsible for burglaries of other rooms in prior months.

On April 10, a female reported that her father's vehicle was missing from the 800 block of East Lee. The father arrived and said that he had not sold the vehicle, had not lent it to anybody, and there was no lien on it. A neighbor reported that a truck with a trailer had pulled up and towed the vehicle away. The vehicle was entered into a nationwide database as stolen.

On April 11, a female reported that she is receiving text messages from unknown people who are sending her photos of penises. She suspects and ex-boyfriend may be responsible for this.

On April 13, a church pastor reported that his church had been broken into within the previous two days. Stolen was about 80 feet of wire. Two wooden rails were also knocked off the church's wheelchair ramp.

On April 14, after a heavy thunderstorm, a resident called the PD because his neighbor's dumpster had been knocked over, presumably by the storm, and trash was in the resident's yard. The resident contacted the neighbor who refused to pick up the trash. The responding officer simply began picking up the trash. The resident then became angry with the officer for picking up the trash and not making the neighbor pick it up.

On April 15, a 17 year-old male was leaving a local high school when he lost control of his vehicle and struck a garage in the 900 block of West Richard. There were no injuries.

All patrol officers completed the required TML online training courses for this period.

Corporal Ochoa and Corporal Crawford are attending the "New Supervisor" course, a 32-hour course at the Del Mar Regional Police Academy.

Cadet Ybarra has successfully completed the shooting portion of his basic police academy at the Del Mar Regional Police Academy and is expected to graduate on May 21st.



Criminal Investigations Bureau Activity Report

Detectives Supervisor assigned 174 cases and inactivated 52 cases as of April 15, 2015. Along with these cases there were also 2 DWI's and 13 Crash reports.

We have started having several burglaries again. Most of which are vehicles. So make sure you don't leave any valuables in open view, and secure your vehicles.

Detectives are conducting an over whelming amount of interviews at the CAC (Crimes Against Children). Help our children stay safe. Talk with them about things going on in their lives.

Detective Contreras did an outstanding job. A lady has had a male subject stalking her for several weeks. Detective Contreras was conducting surveillance in the area. He observed the male subject pass back and forth by the residence. The subject was arrested for stalking.

Another Detective was able to obtain a warrant for a female that had stolen a vehicle and struck other vehicles afterwards.

For the last couple of weeks there have been no major events to report. Though there are still an overwhelming number of burglaries.

If you see anything or anyone out of place in your neighborhood please call it in. With everyone's assistance, we can get more of these types of people off the street. This will make everyone feel safer in their own homes.

Detectives have filed 75 cases during this period. There were 17 cases filed in District Court, 46 cases filed in County Court, 7 cases filed in City Court, and 5 cases filed in Juvenile Court.

The last couple of weeks have actually been mild. Each Detective is currently working a case load of about 50 to 70 active cases.

All the Detectives are doing a great job on working on their cases in attempt to better serve our community.

On 04-16-15 at approximately 1:13 pm the Kingsville Police Department SWAT Team along



with the Street Level Operations Team served a narcotics search warrant at 1300 W. Corral Apartment #232 (Javelina Station Apartment Complex). Trevor Allen a 20 year old male was arrested for the following offenses: (1) Money Laundering > \$1,500 < \$20,000 which is a State Jail Felony, (2) Possession of Marijuana > 4 ounces < 5 pounds which is a State Jail Felony, (3) Possession of a Controlled Substance Penalty Group 2 < 1 gram which is a State Jail Felony, and (4) Possession of a Controlled

Substance Penalty Group 3 < 28 grams which is a Class A Misdemeanor.

4147 Jamlie – Search Warrant

During the last two months, the Kingsville Police Department's Street Level Operations Team has executed four search warrants inside the City limits of Kingsville. The last being on the morning of April 8th at approximately 7:45 am when the Kingsville Police Department's SWAT unit entered the residence at 4147 Jamlie Street. Mark Anthony Mendoza (36 years of age) and his girlfriend, Bianca Mata (21 years of age) were both arrested. Mark Mendoza was



arrested for Manufacturing, Delivery of a Controlled Substance Penalty Group #1 - 1 gram but under 4 grams (Cocaine) which is a Second Degree Felony and for Manufacturing, Delivery of a Controlled Substance Penalty Group #2A - 4 grams but under 400 grams (Synthetic Marijuana) which is a First Degree Felony. Bianca Mata was arrested for Possession of Controlled Substance Penalty Group #1 - 1 gram but under 4 grams (Cocaine) which is a Third Degree Felony and for Possession of Controlled Substance Penalty Group #2A - Under two ounces (Synthetic Marijuana) which is a Class B Misdemeanor. This is the second narcotics investigation conducted by the Kingsville Police Department's Street Level Operations Team involving Mark Mendoza. The first investigation took place in 2010 in which Mark Mendoza was arrested for Manufacturing, Delivery of a Controlled Substance Penalty Group #1 - 4 grams but under 400 grams (Cocaine). Mark Mendoza was convicted and sentenced to prison time. Mark Mendoza is currently on Parole for that conviction. Mark Mendoza and Bianca Mata were residing in Mendoza's mother's residence. Ms. Mendoza was not home at the time of the search warrant execution. All evidence related to criminal activity was located on the second floor of the residence where Mark Mendoza and Bianca Mata resided.




volunteers man cell phones and water stations along the route to check on the safety of the cyclists during the ride.


Golf Division (4/1-4/17)




Leave Accrual Information

Payroll Specialist, Norma Cavazos, sent an email to all City employees regarding recent changes to Time Clock Plus. They will now notice, at the bottom left hand corner of the edit hours screen, their leave accrual information. Each employee will have their leave accrual balances displayed in this window. This information will be updated every Friday before a payroll week to show the most up to date leave available. As leave is used, the employee will notice those hours displayed under the Usage Forecast column and the Remaining Balance will be reduced. This will replace the leave accrual reports, so they will no longer be sent to each department.

REMINDER:

Negative sick and vacation balances are not allowed.

Sick leave is available to new employees after 90 days and vacation is available after 180 days.



Utility Billing Division

Part of March and most of April have proven to be a very rainy time. With the rain and at times some high winds related to the storms we have experienced some concerns about storm water drainage, tree branches falling into people's yards and into the streets, plus missing rollouts that get carried away due to high winds and rain. The Utility Billing Department would encourage all citizens to bring in their roll-outs after they have been serviced by the Sanitation Department. For missing roll-outs after a storm please call Sanitation at 361-595-8040. Any brush that is located in the street can be called into the Public Works Department at the same number 361-595-8040. Any brush located inside the property owner's property is the owner's responsibility. A reminder to all citizens, the Sanitation schedule is posted on the City website. The schedule explains which zone they will be picking up brush at. For additional information, please call that department directly. In order to control the storm water that runs off when it rains, make sure that trash is not being swept into the drainage system. Keep that area clear of trash and debris to ensure flooding does not occur in your street.

Here is just one suggestion on how to control your storm water and save you money:

Did you know that <u>lawn and garden watering make up nearly 40% of total household water use</u> <u>during the summer</u>? Rain barrels provide free water to use during these high water usage periods, saving most homeowners about 1,300 gallons of water as well as saving money and energy. A rain barrel collects and stores rainwater from your roof that would otherwise be lost to runoff and diverted to storm drains and streams. Usually a rain barrel is a 55 gallon drum with a vinyl hose, PVC couplings, and a screen grate to keep debris and insects out, and other off-the-shelf items.

Beginning in April, customers will see a different logo on their water utility bills. All timelines as far as when bills are due have not changed.

Reminders: Any payments dropped off in the night drop need to be in check, money order, or cashier check form. A utility bill stub should be included in order to process your payment to your account or a referenced service address and account number will suffice. If you are in jeopardy of having your services disconnected for non-payment on Tuesday and Thursday, then your payment in full, including penalties, needs to be dropped off before 8 a.m. that Tuesday or Thursday to avoid a disruption in water service as well as additional penalties. This information is also listed on the red notices. ***no temporary checks accepted***

All roll outs must be out by 7 a.m. for trash pickup. Once your roll out has been serviced, it must be removed immediately from the curb or street and moved out of public view.

The City owns this building and has a lease with the Border Patrol. Staff will be working with that agency on their desire to use it in the future. They have been in town to visit the site and are determining what to do about the rood. They believe that the roof needs more repair to it more than they have funds available. They are still considering their options.

Torres Estates

There were 2 items on the Planning and Zoning Agenda for April 8th regarding this project. There were 4 items on the April 13th City Commission agenda pertaining to this development. If the items are all approved at the time of final passage, Mr. Dizdar will be able to develop the property.

La Quinta Hotel

At this time, a full permit has been approved for them. They hope to break ground very soon. The hotel will be located at 2151 S. Highway 77, between Phil Neeson Chevrolet and the Hampton Inn.

Wells Apartments

This is a project with eleven 2-bedroom units to be located at 625 W. Avenue F. The completion date is the end of April.

FEMA Domes

The estimated completion date is January 2016. Things are going well.

Wildwood Trails

A number of homes have been started in the subdivision. With dry weather work on the homes can make some progress.

Lake View Villas

A preliminary plat was approved in June of 2013. A final plat was never submitted. Too much time has passed so the developer had to start the plat process over. Both plat items were approved on the Planning and Zoning April 8th agenda and were thereafter approved on the April 13th City Commission agenda.

New City Hall

Nathan Swinney of AGCM gave the City Commission a brief update at their April 13th meeting. Things are going well. Public Works will be working on sewer and storm drainage in the month of April.

Joint Airport Zoning Board

At the last meeting Brad Womack was named the fifth member and chair of the group. Ramon Perez was named Vice Chair. The board caught up on other items and the pond on the Schubert property. Staff will be meeting with him prior to the next meeting to determine future action.

Cayetano Villages of Kingsville

The development company decided to pull the rezoning agenda items that were scheduled for the March planning and zoning agenda. They need to be awarded the tax credits for this project to happen which they probably won't know until June. If they are awarded the tax credits, then they will continue with the project.

Flato School Project

Staff has heard that as a part of the deed requires an education component, so that is being worked on to

continue with redevelopment of the property. Historic Board member Maggie Salinas has been working with the owners on how to achieve that.

Legends of Kingsville

As was reported in the paper in March, the property is 100% leased for the upcoming school year. We have met with their engineer on Phase II. They hope to submit a site plan sometime in May. Phase II will have 486 beds with 207 units. Once both phases are done they can have approximately 1,000 students living there when 100% occupied.

Top 30 Initiative

As the beautification effort of our city continues, the Planning and Development Services Department has implemented a new list of the city's Worst 30. The Worst 30 are categorized in three different categories of ten each. The purpose of this new Worst 30 initiative is to eradicate unsightly and unhealthful property conditions. The first category of ten is businesses that do not have hard surface parking or the parking lot in is disrepair. The second category of ten will focus on unfinished exterior of buildings. The third category of ten will be comprised of various types of property code, building and other violations that are especially intractable and will need the coordinated efforts of various departments. Some, perhaps most, of the Worst 30 will take months or years to resolve. The length of time allowed for repairs will depend on the nature of the project and approval by the Planning and Development Services Director. It should also be noted that if necessary the City will take the property owner to Municipal Court if we receive no response or action from the letters that we have mailed out.






Keep Kingsville Beautiful:

9316 was returned to the Landfill by the City Garage. The dozer however has a radiator leak. We have had a lot of rain and high winds in the past two weeks.
