Food Service Division

Food Service Inspections

Food Service inspections are conducted on a quarterly schedule per year based on the risk category to insure compliance with the Texas Food Service Establishment Regulations and local food sanitation ordinances. Risk levels include low, moderate and high risk. Establishment scoring is based on a demerit system, as per The Texas Food Establishment Rules. There are two types of violations. Critical violations are 5 and 4 points demerits per violation and non-critical violations are 3 points demerit violations.

Critical Violations are improper practices and actions that directly contribute to food contamination and temperature abuse that may pose a potential risk to the public health, resulting in food borne illness. Critical violations must be corrected immediately or as directed by the Health Department.

Non critical violations are unacceptable practices that normally relate to the physical condition of an establishment, including equipment, cleaning and storage. Non Critical violations must be corrected before the next routine inspection or as directed by the Health Department.



Utility Billing Division

Six things everyone should know about watering efficiently

- 1. Apply only enough water to moisten the root zone of your plants (6 to 8 inches deep), then allow the soil to dry before watering again. This means: In clay soils, water no more than one inch per week. This is enough to moisten your plants' roots. In thin Hill Country soils, apply a maximum of $\frac{1}{2}$ inch of water twice a week. See recommended water schedule.
- 2. Water when the sun is down. No sun and less wind means that the water reaches the roots of your plants rather than evaporating before it hits the ground.
- <u>3. Use low-angle sprinklers</u> that produce droplets of water. Sprinklers that spray water high into the air or produce a mist lose water through evaporation.
- 4. Use multiple start times or a "cycle and soak" feature. This allows water to be applied a little at a time, eliminating run-off, and is especially helpful for sloped areas and areas with clay soil.
- 5. Aim before you shoot Direct sprinklers toward your lawn and away from sidewalks and driveways.
- <u>6. Use drip irrigation</u> for shrub beds, gardens and trees. Drip irrigation systems apply water directly to the root, where it does the most good, and reduces water loss from evaporation. Make sure you slow the flow so the water has time to soak into our region's tight clay and caliche soils —instead of running off.

Watering Do = DO use a drip irrigation or soaker hose to water shrubs and trees.

Watering Don't= DON'T operate an automated irrigation system with broken sprinkler heads; it will waste water and cost you money.

Employee Cross-Training

Recently, the Collections Manager and both Billing Specialists have been observing how service orders are processed out in the field by both Meter techs. This cross-training will be helpful in better answering any questions customers may have as far as how a check for leak is processed, how a meter test is performed, what the meter techs look at when reading the meters for billing purposes, and how repairs are done out in the field on meters. This information is being brought back and shared with other staff in order to better answer those types of questions/concerns.

All safety precautions were taken when observing the techs while they are processing the service orders.

Reminders

Any payments dropped off in the night drop need to be in check, money order, or cashier check form. A utility bill stub should be included in order to process your payment to your account or a referenced service address and account number will suffice. If you are in jeopardy of having your services disconnected for non-payment on Tuesday and Thursday, then your payment in full, including penalties, needs to be dropped off before 8 a.m. that Tuesday or Thursday to avoid a disruption in water service as well as additional penalties. This information is also listed on the red notices.

All roll outs must be out by 7 a.m. for trash pickup. Once your roll out has been serviced, it must be removed immediately from the curb or street and moved out of public view. See the following City Ordinance:

Sec. 5-1-35. When collections made.

B) For customers served by city roll-out containers, the time for placement of city roll-out containers shall be 7:00 a.m. on the date of collection and removed from the street or curb by 8:00 p.m. on the date of collection.

Municipal Court Division

Court Business during the period of April 3, 2014 through April 15, 2014

There were 170 new cases filed with the city court. Of these, there were 116 traffic violations, 48 FTA (failure to appear) and 6 Health Department violations. Aside from the new cases, there were 150 cases resolved; 86 warrant orders executed and 10 new arrest orders published in the local newspaper and the worldwide police website. There were collections of \$28,718.84 from settlements of payment plans and all other executed orders.



Pre-Trial Session on April 8, 2014

During the 9:00 o'clock session, there were three people scheduled to meet with the State and City Attorney, Mrs. Alvarez. Of these, the dispositions are as follow: two individual cases dismiss due to compliance of the law and the last individual settled out of court by accepting the state's plea bargain.

Court Session on April 10, 2014

Inmate Court Hearing, during the 2:00 o'clock session, there were nine inmates transported to the Municipal Court Alcorn Chambers by the Kingsville Police Department. One individual receive jail time credit for the full of the fine and ordered to work 8 hours of community service at City Public Works Warehouse and provide proof of completion of an Alcohol Awareness class. Four individuals were committed to the Kleberg County Jail for the full amount owe to the court, and the other three individuals were release upon a payment plan court order and the last individual was release on a three month payment plan, 8 hours of community service to be preform at the City Public Works Warehouse. In addition, file with the court by the ninth day a certification of Alcohol Awareness completion.

During the 3:00 o'clock court session, this consisted of 126 people (202 cases); prior to the court hearing, 18 people requested another court date. There were 30 people who made their court appearance and these are the depositions of these cases: 24 cases were set on payment plans and thirty day extensions. There were 25 cases were closed upon full payment, 4 cases were dismissed due to compliance of the law and justice, 42 cases are set for continuance for further review and 3 cases are to be set for trial.

For the remaining who did not make their court appearance, 38 individual driver's licenses reported to the Omnibase (Department of Public Safety) for suspension, and 68 records of arrest and failure to appear charges for non-appearance and contempt of court. One Juvenile case is set aside for Adult prosecution.

Planning Division

Kingsville GIS Website

Robert Isassi was invited to speak to the Kingsville Realtors' Association on Friday, April 11th. At the meeting, Robert introduced and taught local realtors the workings of the KingsvilleGIS.com website. He explained how to best use the site and what tools were available.

Recycling Center and Community Appearance Building

Robert has been working with the City Engineer, Charlie Cardenas, to estimate and design a fence enclosure around the City-owned vacant lot behind the recycle center (SW corner of Alice Ave. & 5th St). The project will allow for additional storage space and other recycling opportunities while also providing

parking space availability for employees who are resorting to parking across the street from the building due to lack of parking.

Website Upgrades

Website designer, Johnathan Swindle, met with Robert on April 9th to discuss the upcoming work on the City website. Johnathan has been working on the site and discussed with Robert the web needs of the Planning & Development Service Department. We are expecting to see a website redesign in the coming weeks but it will not be ready for public view. We are keeping things quiet while we work in the background and are ready to release it to everyone.

Tree-Lined Inventory and Design

On April 11th, Robert and Master Gardener, Anse Windham, drove the 6th St. corridor from the northern to southern city limits and inventoried the existing trees. As part of the inventory, they surveyed the open spaces and estimated the number and types of native trees that could be planted to create a tree-lined corridor along 6th St., between 6th St. and the railroad tracks. Anse and Robert agreed that wild olive, anacua, and mesquite trees would make an excellent addition to the existing hackberry and anacuas that currently line the corridor.

Leadership Kingsville

The Leadership Kingsville group is excited to be moving forward with the Disc Golf at Dick Kleberg Park project. Robert and Charlie met with group members Thursday, April, 17th, to discuss the clean-up plans scheduled for April 26th. Robert stated that he would be buying breakfast for all participants in the cleanup. The cleanup consists of trimming existing tree branches and piling them up for pick-up. Charlie will be asking Commission for support on this project. We all look forward to a successful outcome.

Economic Development Commission

Robert attended the EDC meeting on Wednesday, April 16th, to get an update on local development growth and challenges. At the meeting, Brian Connelly, with Celanese, briefed the board on a recent announcement that they are submitting a permit application for an \$800-million dollar methanol plant. They anticipate breaking ground in 2017, once permits are all approved. Also, Celanese will be breaking ground next year on an \$80-million dollar addition to the plant's compounding unit. Mr. Connelly stated that the Bishop location has become the "favored site" for the corporation.

State of Agriculture in Kleberg Co.

At the April 16th, EDC, Dave Delaney, King Ranch vice president in charge of farming and ranching, told the board that too often people forget how important agriculture is to the local economy. He said that since King Ranch has 75 to 80% of the 100,000 acres in Kleberg County dedicated to agriculture, the impact is significant. Delaney said that most of the land in cultivation is planted in grain and cotton, but the feeder cattle and wildlife industries employ a large number of people locally. He pointed out that hunting leases on King Ranch employ a large number of workers, and provide a hedge against downturns in farming and ranching. Even with the current drought, agriculture employs an estimated 450 workers in Kleberg County.

Mr. Delaney said that King Ranch operates the feed lot but most of the cattle in the feed lot are not owned by King Ranch. Recent changes in federal regulations impacting cattle from Mexico have impacted the costs and feed lot operations. Droughts and increased feed costs across the country have decreased the number of cattle to 22-24-million, lowest in recent history.



Delaney did say that the new farm bill was critically important to the agricultural industry. With mega trends doubling the need for protein production in the world, and the cost of crop and cattle production doubling, the future of agriculture is changing.

Agriculture is a great partner for Kleberg County's two largest industries – Naval Air Station Kingsville and Texas A&M University – Kingsville.

Local Developments

Staff reported that Domus Development had closed on the 20+ acre piece of land they plan to development into student housing. Kingsville ISD rejected the one bid they received on the Flato School Bldg. The lone bidder planned to develop the property into student housing. The city, TAMUK and Kingsville Industrial Foundation will meet next week to discuss converting the former call center into the TAMUK Eagle Ford Center for Research, Education and Outreach (EFCREO). Kleberg County Commissioners Court approved the incentive program for Lake View Villa Town Homes at their meeting earlier this week. The \$81,000 incentive from the county equals the incentive from the city, and both were critical to moving this project forward.

Illegal Parking in Front and Side Yards


Code Officers have been directing their attention to front/side yard parking violations. Code has recently acquired membership with the Texas Dept. of Motor Vehicle to gather registered owner information. The process of this violation would mirror Officer Perez's efforts on junk vehicles. While proactively inspecting for other city code violations, Code Officers will add this to their list. Previously a notice of non-compliance was sent to the property owner, however after researching this violation and comparing it to other cities we were redirected to citing the registered owner of the vehicle instead of the property owner. A citation will be issued to the registered owner; the owner will then need to contact our municipal court to pay for the citation. The amount of the citation fee is being discussed with legal and municipal court departments.

Criminal Investigations Bureau

We have three new Detectives in the Division as of April 6th. They all seem to be working hard and learning the new position. The New Detectives have been assigned several cases so far and have figured out some of the investigative procedures. Everyone is working as a Team to help each learn and adjust to the new arrangements.

<u>Det. #5</u> has been assigned this case 14-0007592 Sexual Assault. On 03/25/14 the Patrol Division was dispatched to a house located on Birchwood in reference to a sexual Assault. Contact was made with the victim, who advised she was sexually assaulted by her fiancé's friend. The victim advised the assault occurred on 3/23/2014 at approximately 5:30am. <u>Det#5</u> along with the Crime Scene Tech were called out to the scene to process evidence. The victim was then taken to the Police Department where she was questioned about the incident. <u>Det #5</u> then questioned the suspect a few days later. Det. # 5 had to reexamine the victim because he had evidence proving the suspect is innocent. While talking with the victim, she advised the sexual intercourse was consensual, and she was not sexually assaulted. The victim advised she was scared and she panicked because she had never had an affair. Det. # 5 filled on the victim for false report to a Peace Officer. This case will be filed with the Kleberg County Attorney's Office.

<u>Det. #2</u> was assigned Aggravated Sexual Assault case. <u>Det. #2</u> worked with the Child Advocacy Center and Driscoll's Children Hospital and was able to get the child examined and interviewed the same day. After the interview <u>Det. #2</u> was able to obtain a Felony warrant and the offender was arrested. <u>Det. #2</u> did a great job in working hard to get this case solved and the offender arrested in a timely manner. Good Job!

Det. # 5 had one call out, and the information is posted above.

The CIB Supervisors read, assigned, and inactivated 197 cases.

Engineering/GIS

Engineering has been surveying the Escondido ditch and have been drawing the new ditch plans so that the Kleberg County can grade the ditch.

Purchase Orders

The last two weeks Purchasing issued 130 Purchase Order valued at \$835,571.23. P-Card reviews have been concluded. 99 P-Cards statements came in with a total of \$52,297.06. Errors this month included wrong coding, late, tax charges, missing receipts and over the limit fees. If you are unsure if you are almost at your limit feel free to contact Purchasing and we can assist you with that information.

While it seems that the coding errors are getting better it seems that the tax issue is on an increase. Everyone is strongly encouraged to check and double check their receipts before leaving an establishment to make sure no taxes were charged. If taxes were charged the establishments are really good about redoing the transaction so no taxes are charged and/or giving you a credit. If the P-Card holder fails to ask for the credit they will be responsible for paying those taxes out of pocket.

Another misconception about P-Cards is that meals purchased will be for the total of the days per diem. If the total for the area is \$71 for example, it does not mean you can use the \$71 for a single meal, unless you received a cash advance in which you can use it as you desire. If you didn't request a cash advance check then the standard method will apply. Employees' doing same day travel training are authorized to use the P-Card for their meals according to the GSA.gov table and all original receipts and itemized receipt must accompany the monthly P-Card statement.

Commission Approves Acquisition of Oil Distributor and Related Lease Agreement

On another note City Commission gave their final approval for the acquisition of the Oil Distributor and corresponding lease agreement. All corresponding documents have been finalized and sent to the leasing company for signatures. We would like to give a big **Thanks** to Melissa Perez for her assistance in insurance documentation it was greatly appreciated.

Training

Purchasing/ IT—Purchasing/IT Administrative Assistant, Thelma Trevino, and IT Administrator, Tony Verdin, have just returned from the Tyler Technologies 2014 Tyler Connect Training in San Antonio. Tyler

Technologies training was very informative. It also gave us a better understanding of what all Incode X is capable of and of how under-utilized we have it. Our hope is to learn more of it and pass on that information to everyone here at the City of Kingsville. We met people from all over the United States with 2900 people attendance and 450 Tyler Technologies employees on hand to help and answer any questions you might have. It was also nice to help those that were, either in Incode 8 or Incode 9, by answering their questions on Incode X.

This training provided valuable information along with the ability to ask questions and get feedback. It also provided networking opportunities and allowed us to publicly voice our questions and concerns over the software. Everyone that went found the meeting very informative and are willing to look at new ways to utilize the software. I myself was very impressed by the reporting capabilities and the software in general.

Mobility/Tablets

We have moved forward with mobility tablets for the Community Appearance Division. These tablets will take advantage of the inexpensive mobile internet provided by Verizon. These tablets along with the web based interface provided by GovQA will allow the inspectors to work more effectively out in the field.

GovOA

We have begun to implement the final design phases of the GovQA system. We have brought the Public Works Division online with this system. We are working through some issues with payments but we hope to have this resolved by the next staff report. In addition, we are organizing with the website design team to give everyone the best possible product at launch date.

To encourage non-residents to explore Kingsville, the library provided these visitors with coordinates and hints to seek out the library's "Jet Noise" geocache, a GPS-based scavenger hunt. The library filled the geocache with Air Show-specific items. Throughout the weekend, the library posted various updates on the library's Facebook account to help keep the public informed of the various Air Show happenings and library giveaways. Those Facebook postings had 821 views. In addition, the library provided free Wi-Fi access at the event. Nearly 700 attendees connected to the mobile hotspot. The library's involvement in this event was extremely successful and was a good experience for the library.

PirateBox Project

With the recent increase in patrons accessing the Wi-Fi network, the library is re-launching PirateBox as a part of its electronic services. The library reactivated the current pilot PirateBox at the beginning of April



2014. PirateBox is a freestanding, file-sharing 24/7 network where patrons become the curators of what everyone sees and shares. PirateBox is not connected to the Internet and does not require a password. The device does not track, identify, or store the user's information. This network consists of only a router and an information-storing device. Users within range of the device can join PirateBox's open wireless network from any Wi-Fi-enabled device. All users have to do is connect to it, launch their web browser, and start uploading or downloading files. PirateBox users can post messages and chat anonymously with other users. The library wants the PirateBox to serve as an educational and informational depot where patrons can store or retrieve personal stories, poems, documents, and other digital content. With this equipment, the library hopes to make the PirateBox a digital hub where patrons can share

and express their creative ideas. Because the device is portable, the library is also making PirateBox available on the bookmobile during its outreach trips to Kenedy County. The library wants to give Kenedy County patrons the opportunity to share their materials, thoughts, and ideas with other locals. 

Request for K-9 Search within the Celanese Bishop Facility


On Tuesday April 1, 2014 Mr. Bill Chidester, Celanese Bishop Facility Security Leader, requested the assistance of the Kingsville Task Force. Mr. Chidester needed a K-9 search of a certain section within the Celanese Plant. On Wednesday April 2nd, Agent Ruben Villalobos and his K-9 Partner "Nitro" traveled to the Celanese Plant and conducted a K-9 search of the Oxea-Identified areas within the plant. No contraband was located during the search.

Two Kingsville Task Force Investigations Result in Money Seizures

On Tuesday April 8, 2014 Special Agent Mike Tamez spotted a suspicious vehicle travelling South on Highway 77 through Kingsville. Before Agent Tamez could develop probable cause for a traffic stop, the vehicle pulled into the Stripes Convenience Store at Highway 77 and 285. When Agent Tamez circled around to check on the vehicle, it had left the store and had disappeared into southbound traffic. Agent

Tamez notified an ICE Task Force Agent in Pharr Texas who was able to located the vehicle and develop the probable cause to stop it. As a result of that stop \$490,186.00 was found inside an old hot water heater in the bed of the truck. Since the Kingsville Task Force was the instigating agency in the case we will be able to DAG into the money seizure.

On Wednesday April 9, 2014 Special Agent Ruben Villalobos conducted a traffic stop on a 2011 Chevrolet passenger vehicle travelling southbound on Highway 77 at CR 2160. The driver, a 52 year old male from the valley, was acting very nervous and Agent Villalobos noticed inconsistencies in his story concerning his travels. Agent Villalobos was given consent to search the vehicle and upon doing so found anomalies in the rocker panels and an aftermarket panel attached to the fire wall. When He tapped into the false compartment with a drill, shrouds of currency was found on the drill bit. The access panel was found when the driver's front quarter panel was removed. A total of 32 bundles were found concealed in the false compartment. A total of \$375,440 was located and confiscated. The driver was arrested for money laundering and Unlawful Use of a Criminal Instrument. The vehicle was also seized and stored at the Task Force Impound Lot.

Undercover Task Force Agents set up surveillance on the vehicle and observed a 27 year old male get into the vehicle and attempt to leave the hotel. Agent Loftin was able to stop the vehicle as it travelled West on King Street and arrested the driver for Vehicle Theft. A local wrecker service stored the stolen vehicle until it was released to the proper owner on April 17, 2014.


Outreach to Alice
