New Advertisement to Market South Texas Birding Species

The Tourism department has partnered with the King Ranch Visitor Center to advertise in birding magazines in an effort to bring visitors to Kingsville. There have been over 360 species of birds recorded on the Ranch. The Green Jay happens to be the Kingsville bird and is one of the most colorful birds in existence. They have feathers of yellowishwhite with blue tips on the top of the head, cheeks and nape, though some taxa have more blue than others. The breast and underparts range from bright yellow in the south to pale green in North Texas. The upper parts are rich green. It has large nasal bristles that form a distinct tuft in some subspecies, but are less developed in others. The color of the iris ranges from dark brownish to bright yellow depending on the subspecies. The information of the Green Jay was obtained from Wikipedia.



The City of Kingsville's FY 15-16 Budget was adopted by the City Commissioner's on September 16th. Now that the budget has been adopted it will be published on the City's website and copies will be distributed to the City Secretary's office and the County Clerk's office for public viewing. Department directors will also receive an updated budget book. This year the Finance Department will be submitting the FY15-16 budget document to the Government Finance Officers Association's (GFOA) Distinguished Budget Presentation Award Program.

Save Water, Save Money

The average family spends \$1,100 per year in water costs, but can save \$350 from retrofitting with WaterSense labeled fixtures and ENERGY STAR[®] qualified appliances. Also, when we use water more efficiently, we reduce the need for costly investments in water treatment and delivery systems.

Drops to Watts: Save Water, Save Energy

It takes a considerable amount of energy to deliver and treat the water you use every day. For example, letting your faucet run for five minutes uses about as much energy as letting a 60-watt light bulb run for 14 hours.

Heating water for bathing, shaving, cooking, and cleaning also requires a lot of energy. Homes with electric water heaters, for example, spend one-quarter of their electric bill just to heat water.

With climate change concerns, pervasive droughts, and high energy prices across the country, nearly everyone is looking for ways to conserve resources and cut costs. The good news is that by using a little "water sense" we can all save water, energy, and money.

Toilets

If you can hear the water in your toilet making noise, even when no one flushed recently, you have a running toilet that could be wasting 200 gallons of water or more a day! Sometimes you just need to jiggle the handle to fix it, but sometimes a part needs to be replaced.

Many toilet leaks are caused because the "flapper" is decayed or broken. The flapper is a rubber piece that opens up to let the water flow from the tank into



the bowl when you pull down on the

toilet handle. This part is easily replaced and is relatively inexpensive; but could save you a lot in water cost.

The City of Kingsville offers online pay (at a minimal cost), automatic bank draft (free service), over the phone payments with a Visa or MasterCard (free service), cash, check, or money order payments. The Utility Billing office also has a convenient night drop located at the corner of our Municipal Building facing Kleberg Street. Our business hours are from 8:00 a.m. to 5:00 p.m., Monday through Friday except on City approved holidays.

A reminder that brush truck rental applications are located at Utility Billing. Any interested water utility account holder must apply in person at the Utility Billing Department. All rentals are on a first- come first –serve basis. For additional information call this department at 361-592-5281.

Reminders: Any payments dropped off in the night drop need to be in check, money order, or cashier check form. A utility bill stub should be included in order to process your payment to your account or a referenced service address and account number will suffice. If you are in jeopardy of having your services disconnected for non-payment on Tuesday and Thursday, then your payment in full, including penalties, needs to be dropped off before 8 a.m. that Tuesday or Thursday to avoid a disruption in water service as well as additional penalties. This information is also listed on the red notices. ***no temporary checks accepted***

All roll outs must be out by 7 a.m. for trash pickup. Once your roll out has been serviced, it must be removed immediately from the curb or street and moved out of public view.

<u>Engineering and GIS</u> – Engineering has partnered with Finance and Development Services to create a funding plan for the 20 year Street Maintenance Improvement Plan (SMIP). El Nino Could Bring an Early End to Atlantic Hurricane Season El Nino has kept the Atlantic hurricane season quiet. How will El Nino effect the coming seasons? The current strong El Nino, in addition to other potential impacts, may also shorten the Atlantic hurricane season. A weather.com analysis of NOAA's best-track dataset from 1950-2014 finds that Atlantic hurricane seasons during a strong El Nino see the last named storm end two to three weeks earlier – a mean date of Oct. 18 – than the long-term average date of Nov. 5. Four of the five previous Atlantic hurricane seasons with a strong El Nino since 1950 – 1997, 1987, 1982 and 1965 – saw the season-ending named storm fizzle by Oct. 18 or earlier. Only 1972 had a later end during a strong El Nino, only due to a pair of subtropical storms. "El Nino normally peaks in late November and December, so, on average, it has a greater effect on the second half of the hurricane season. But that just means that the odds of a named storm are lower. On any one day, there are many still pockets in the Atlantic Ocean or Gulf of Mexico that are favorable for tropical development. "Furthermore, while the Atlantic may struggle to maintain long-lived tropical cyclones from the deep tropics during this strong El Nino, more systems spinning up much closer to the U.S., such as we saw with Ana and Bill early in the season, could still occur into October.

Flood and Flash Flood Facts

During recent years, floods and flash floods have caused billions of dollars in damage each year. They are among the most common and widespread of all natural hazards. Even more importantly, they're the number one weatherrelated killer. A flood can happen anywhere along the

Mississippi, in New England, even in the desert. A Flood (commonly called river flood) is a high flow or overflow of water from a river or similar body of water, occurring over a period of time too long to be considered a flash flood. Flooding is caused in a variety of ways. Winter or spring rains, coupled with melting snows, can fill river basins too quickly. Torrential rains from decaying hurricanes or other tropical systems can also produce river flooding. Coastal Flooding occurs when strong onshore winds push water from an ocean, bay or inlet onto land. This can take the form of storm surges associated with tropical storms and hurricanes, or can be associated with non-tropical storms.

How Weather Impacts Spring Allergies



Weather plays an important role in how much pollen is produced, its distribution and how much pollen is in the air at a given time. Allergy symptoms are often reduced on rainy or windless days because pollen does not circulate as much during these conditions. Pollen tends to travel more with warm, dry and windy weather,

which can increase your allergy symptoms. Pollen counts vary by time of day, season and weather conditions. Rain, wind and temperature are all important factors to consider when determining if pollen counts will be high, moderate or low on a particular day. Overall, pollen counts tend to be higher in the morning, as well as on warm, dry and windy days. Conversely, lower pollen levels are also typically observed during a stretch of cold and wet days. The National Institute of Heath Medline Plus recommends saving outside activities for late afternoon or after a heavy rain, when pollen levels are lower.

Wireless Project Minor Delays

Due to inclement weather we have had to push the initial timeline back a few days. However, we are still on schedule to finish this month. Technology staff has worked diligently with the third-party service providers to ensure the success of the project.

Old HM King Building/New City Hall Wiring HM King

With the room configurations finalized, we are in the process of having the wiring placed in the building. The wireless radios are already ordered and configured. For the incoming fiber, the contract awardee is going to begin the site preparation. The electricity seems to have come together in the timeframe that we need it to in order to get our portion completed.

Changes to the City Hall Phone System

As part of the overall project to reduce the cost of communications, which consumes a large portion of our operating budget, we have begun to roll out a new communications system. This system plus the on-going communications audit should conservatively cut communications cost by 1/3. Additionally, the phones have a sleuth of business class features that allow us to more effectively conduct business. For example, the IT department is now able to contact a support line with the end-user on the phone. It takes the guess work out of having to contact the vendor then contact IT and then maybe have them schedule together. We have been able to solve issues much more accurately and timely as a result of this feature. Additionally, it has the most common business features such as voice mail and call ID.

The most noticeable change is the call tree at the public works building. It is an automated system voiced by Stephanie the Administrative Assistant at the waste water plant. This allows people calling to more accurately direct their calls. If citizens/employees wish to talk to a real person rather than an automated system there is a zero for operator button. This is a big advancement to say the least as it will help resolve issues speedily and accurately.

Training on the system is provided via a web portal.



Food Service Division

Food Service Inspections

Food Service inspections are conducted on a quarterly schedule per year based on the risk category to insure compliance with the Texas Food Service Establishment Regulations and local food sanitation ordinances. Risk levels include low, moderate and high risk. Establishment scoring is based on a demerit system, as per The Texas Food Establishment Rules. There are two types of violations. Critical violations are 5 and 4 points demerits per violation and non-critical violations are 3 points demerit violations. Critical Violations are improper practices and actions that directly contribute to food contamination and temperature abuse that may pose a potential risk to the public health, resulting in food borne illness. Critical violations must be corrected immediately or as directed by the Health Department.

Non critical violations are unacceptable practices that normally relate to the physical condition of an establishment, including equipment, cleaning and storage. Non Critical violations must be corrected before the next routine inspection or as directed by the Health Department.

Puppies between 13-16 weeks should have a Physical Examination, vaccinations for Distemper Hepatitis, Parainfluenza and the Parvo Virus. They should get their rabies vaccination 1 year Bordetella, also be dewormed if needed, dispense ear wash have their third Heartworm/Flea preventative shots. Kittens between 12-14 weeks should have a Physical Examination, vaccinations for Rhinotracheitis, Calica, Panleukopenia and Chlamydia. They should get their rabies vaccination 1 year, also be dewormed if needed and their second Heartworm/Flea preventative 12 month supply. Make an appointment for spay or neuter.

Library Visits with Local Students

As part of the library's Public and Academic Outreach Programs, Mr. Joey Garcia, Information & Technology Librarian, and the *Library-on-the-Go* bookmobile made several stops within the last few weeks.

On August 21, 2015, the library participated in the Fourth Annual Kingsville Independent School



District's (K.I.S.D.) Community Fair. Mr. Garcia shared with students, parents, and educators the various services and resources available at the library. In addition to the information, visitors to the library's booth had an opportunity to interact with *the Maker's ZONE*-mini, a miniature, hands-on version of *the Maker's ZONE*. The Maker's Zone-mini included Snap Circuits® and Hexbugs®, which encourage students to learn more about simple circuitry.

On September 1, 2015, Mr. Garcia visited the Kingsville

Leadership Academy Open House.

On September 10-11, 2015, middle school students with Santa Gertrudis Independent School District (S.G.I.S.D.) also received a visit from the library. Mr. Garcia shared with the students the importance of libraries and a few best practices to help them succeed with their homework. Some of the services that students saw first-hand included Mango® Languages, a language-learning program; OverDrive®, the library's eBook platform; Discovery Texas (TexShare Database), an online collection of academic databases, articles, and journals; and LearningExpress Library® 3.0, a collection of homework tutorials, ebooks, and practice exams. In addition, the library took along *The Make's ZONE*-mini. As part of *The Maker's ZONE*-mini experience, the library introduced students to eBooks that related to building circuits and simple robotics.

With all of the outreaches, over 200 students, parents, and educators discovered more about the library's resources and services. Plans are under way for the library to bring this academic outreach to K.I.S.D. students in the coming weeks and to Academy High School students at the beginning of 2016.

Administrative Notes

In remembrance of September 11, 2001 all officers were authorized to wear their commemorative badges throughout the month of September 2015 in recognition of those who gave the ultimate sacrifice in the performance of their duties and the citizens who gave their lives as a result of the terrorist acts perpetrated against our country. Those officers who did not purchase a commemorative badge wore a mourning band to cover their shields during the days of September 11th, 2015 and September 12th, 2015.

On September 11th, 2015 all personnel took a moment to remember the Americans who died during the attacks as listed below:

- **8:46:40**: Flight 11 crashes at roughly 490 mph (790km/h or 219m/s or 425 knots) into the north face of the North Tower (1 WTC) of the World Trade Center, between floors 93 and 99.
- **8:46** to **10:28**: At least 100 people (some accounts say as many as 250), primarily in the North Tower, trapped by fire and smoke in the upper floors, jump to their deaths.
- **9:03:04**: Flight 175 crashes at about 590 mph (950 km/h) into the south face of the South Tower (2 WTC) of the World Trade Center, banked between floors 77 and 85.
- 9:37:46: Flight 77 crashes into the western side of the Pentagon and starts a violent fire.
- **10:08**: Air Traffic Control System Command Center in Herndon reports to FAA headquarters that Flight 93 may be down near <u>Johnstown, Pennsylvania</u>; at 10:17 the Command Center concludes it is so.

As citizens of our great country we should do all we can so these types of actions are never again repeated on American soil.

Turcotte-Piper Mortuary hosts 9/11 remembrance event

We would also like to thank our friends at Turcotte Piper Mortuary for hosting a 9/11 remembrance ceremony honoring the fallen officers from 9/11 and also to celebrate law enforcement, fire personnel, and EMS personnel who serve in our community. The service was followed by a lunch at the KC Hall on General Cavazos Blvd. Thanks you again for the wonderful service and a nice meal!

Patrol Division Period Activity

Patrol officers responded to hundreds of calls during the two-week period. Patrol officers wrote 59 citations and 19 warnings during the two-week period. Officers responded to 12 collisions, seven "hit and run" collisions and several private property accidents. Four people were arrested for DWI.

There were three residential burglaries and three vehicle burglaries reported, along with seven criminal mischief reports and one count of credit card abuse. There were nine Assaults reported and one Aggravated Assault. Officers also investigated two unattended deaths and one apparent suicide. Six people were issued criminal trespass warnings and two runaway reports were made.

On September 2, officers were dispatched to the alley in the 900 block of E. Alice, in reference to a suspicious vehicle. Officers contacted a nervous male. The male was arrested for one felony warrants and seven Municipal Court warrants.



On September 2, an officer observed a car pass a stop sign, then crash into a passing car. The driver was arrested for DWI and Possession of Controlled Substance.

On September 3, officers arrived in the area of a reported gun shot that was heard. Officers could not locate anything. Minutes later, the local Emergency Room calls about a male with a gunshot wound to his leg. Officers interviewed the male who said that he accidentally shot

himself in the leg while sitting in his pickup near the area where the officers had searched. He described what happened and it was consistent with the injury and the physical evidence inside the pickup.

On September 3, officers found an intoxicated male urinating on trash bags that were outside the back door of a restaurant. Employees put the trash bags just outside the door until they can carry them to the dumpsters. The male was arrested for Public Intoxication.

On September 6, officers contacted a male at a night club, in reference to a verbal disturbance. The male gave a false name to officers. After being arrested for that offense, cocaine was found in his possession. He was transported to jail.

On September 11, officers responded to a fight. Two females were fighting over one male. The male joined the fight and assaulted one of the females, who made the report. The other two left the scene.

On September 11, officers were dispatched to 16th and Avenue A in reference to an unconscious male. Officers observed a male lying, face first, in the street. An ambulance was summoned. Drug paraphernalia was found in the male's hand. It was determined that the male had just ingested "synthetic marijuana" and had passed out. A baggie of the "synthetic" was found in his pocket and he was taken to jail.

On September 14, an officer observed a male walking towards a convenience store after midnight. As he



approached the front door, he pulled up a bandana to cover his face. The officer called out to him and he lowered the bandana. The officer asked if he had a weapon and the male admitted to having a pistol. The male was taken down at gunpoint. A CO2 pellet pistol was found in his pocket. During questioning, he refused to explain what his intentions were and requested an attorney. He was arrested for Public Intoxication and the investigation continues.

On September 14, officers responded to West Santa Gertrudis and Seale, in reference to a pedestrian struck by a vehicle. Officers determined that the female university student crossed, at an angle, wearing headphones and looking down at her phone. She was transported to the local hospital.

On Sunday, September 13, 2015 at approximately 1:15am, a Robbery occurred at The Day And Night Club, located at 304 E. Richard in Kingsville, TX. A 52 year old female walked out of the Club with a male friend. As they exited the club, an unknown male subject wearing a hoodie sweater ran up to both subjects and hit the male subject in the back of his head with a beer bottle. The unknown male subject then pushed the 52 year old female to the ground and took her purse and ran. The 52 year old female sustained injuries on her head, and could not recall or identify the male subject. It was said the male subject was accompanied with a female in her early twenties. Detectives were the first Officers to arrive on scene the investigation is still in its infancy stage; however a person of interest has been identified.

The Accident investigator is working a case with the Corpus Christi Police Department in reference to an Accident Causing Death incident that occurred at the new Veterans Memorial High School. On 9/08/2015 there was a fatal accident near Veteran's Memorial High school in Corpus Christi. According to the news media a 26 year old male, killed the Assistant Band Director. On 9/11/2015 the Accident Investigator (AI) was advised that he worked a case on the 26 year old suspect. On 2/01/2015, the suspect was involved in a similar crash in Kingsville. The suspect crashed in the 700 N 6th with his one year old daughter in the vehicle. The suspect caused major damage to his vehicle, and he was arrested for endangering a child. The AI went to the scene and caudated the yaw marks before impact and confirmed the speed was 57 mph in a 30 mph zone. While investigating the case the suspect said that he "blacked out" and did not remember what had happened. A medical advisory statement was prepared and mailed off to Austin, TX.

The AI called CCPD and advised them that the suspect was involved in a similar crash in Kingsville, and offered his assistance. On 09/14/2015 CCPD Officer made contact with the AI in reference his case in CC. CCPD Officer advised the suspect was going about 82mph when he crashed into the victim's vehicle. CCPD Officer advised the suspect stated that he "blacked out". CCPD Officer advised the he was going to file Manslaughter on the suspect. The AI has been assisting the CCPD Officer with the case.

Detectives were called out to the hospital for a disturbance that occurred at 903 Hall. Upon arrival contact was made with a male subject who had a laceration on his left hand and left ear. The male subject advised his daughter called him and told him she was fighting with her husband. The male subject advised he arrived to his daughter's house, and while on location he and his soon to be ex- son-in-law got into a physical altercation. The son-in-law advised during the altercation he noticed a knife on the floor, however never noticed the knife in the possession of his father-in-law. During the altercation the son-in-law received a laceration on his chest and behind his arm. The father-in-law was arrested for Aggravated Assault w/ Deadly Weapon.

The CIB Corporal worked a case a few weeks back in reference to two male subjects who were from Alice, Texas. The two subjects entered a vehicle a stole a purse and used the victim's credit cards at several businesses in Kingsville. The CIB Corporal identified the two subjects and they were arrested on the felony warrants. It was also discovered the two subjects were involved in burglaries in Corpus Christi, Texas. The CIB Corporal provided the information with CCPD, and CCPD advised they were able to write a felony warrant for their arrest out of Corpus Christi, TX.

The following cases were filed: 41 cold cases, 3 Municipal, 35 County Attorneys, 15 District Attorney, 3 Juvenile Court, 18 pended, 1 prosecution rejected, 7 unfounded, and 2 X-Cleared.

Two Detectives are assigned to register and monitor the local sex offenders in the area on Tuesdays and Wednesdays.

Two detectives are assigned on the night shift. Each detective has conducted approximately 5 interviews.





5th and Henrietta

The City owns this building and has a lease with the Border Patrol. Staff has been working with that agency on their desire to use it in the future. They have been in town to visit the site and submitted a scope of work that they would like to have done to the building. A quote was obtained and the Border Patrol is willing to go ahead with the quote.

Torres Estates

The City Commission has approved all of the necessary administrative tasks for developer Mark Dizdar to start his single family residential development project.

La Quinta Hotel

The Development Review Team reviewed the revised plans which reduced the number of hotel rooms from 80 to 72. It is designed for a four story hotel. Staff learned that the owner of the hotel was able to obtain financing for the project. The engineer stated that they hope to break ground by the end of the year. A conditional permit was given to them for the purpose of their commitment to the area that the lender was wanting. The revisions have been submitted and approved by the Development Review Team, so they were eligible for a full permit. Staff recently issued a permit after receiving a check for \$10,301.00. The property is valued at \$3.5 million.

Wells Apartments

They have been granted a Certificate of Occupancy and are ready to go into business. This is an 11-unit 2-bedroom residential development at 625 W. Avenue F.

FEMA Domes

KISD's contractor has an estimated completion date of January 2016. Things are going well.

Wildwood Trails

A number of homes have been started in the subdivision. In the last month, the City has issued 10 permits. Three builders have submitted plans for homes in this subdivision.

Lake View Villas

A number of homes have been started in the garden home subdivision. In the last month, the City issued 3 permits; one home has already been sold.

New City Hall

Things are going well. It is on budget and on schedule.

Joint Airport Zoning Board

Ken Moses has been voted as the 5th member and Chair of the Joint Airport Zoning Board. The City Commission will need to appoint another member to the JAZB to fill a vacancy.

Cayetano Villages of Kingsville

The developer was recently notified that they were not awarded the tax credits they were hoping for in in order to develop their project. Staff has been told that the project ahead of theirs is in Gregory and there are some challenges which could cause the credits to come back to Cayetano before December. The developer will let us know if anything changes.

Flato School Project

In the Kingsville Record this summer, there was an article about the Flato Building. The issue of the clause regarding the use of the property for educational purposed seems to be a sticking point slowing the transfer of the land. Whether or not this issue gets worked out is hard to tell from reading the article. While staff hasn't been in contact with the architect or the Zaragosa family lately, we will monitor the situation and assist if asked.

Legends of Kingsville

Legends now has residents living in buildings 1, 2, 4 and 5. The General Contractor is working on finishing building 3.

Legends II of Kingsville

They have been issued a building permit for Phase II. It will be 486 beds with 207 units. The permit was approximately \$55,000.

Domino's

Domino's submitted a development plan in September of 2014. They have broken ground for the new building. This Domino's will have some limited inside dining. They plan to be done in November of 2015.

University Center

Ali Samadi who owns all of the Subways in town has submitted a development titled University Center. This will be a three tenant commercial building located at 702 W. Santa Gertrudis. One of the tenants will be a Subway. This is the vacant lot east of the IBC Bank, at the corner of Wells and Santa Gertrudis. He plans to close the Subway that is around the corner on Armstrong, facing Santa Gertrudis. He doesn't know at this time what the other two tenants will be in the building. The project is valued as \$420,000 dollars. He hopes to have it done by the end of the year. He was granted a permit to start construction. A change in contractor and the rains have also delayed the work on the project.

Advance Auto Parts

A third party doing pre site work has been inquiring about codes and other information pertaining to the building of an Advance Auto Parts store. The location being looked at is the ground next to the O'Reilly Auto Parts store. At this time we have not received a special use permit application from them to build a store there.

Christus Spohn Hospital

They have submitted a development plan to turn the second floor of the Colston Occupational Building into a wellness center. The Development Review Team has reviewed the plans and has authorized them to obtain a building permit. A permit has been issued.

Neessen Chevrolet

They have submitted a development plan to remodel a part of the building and to add a freestanding Chevrolet tower. The Development Review Team has reviewed the plans and has authorized them to obtain a building permit. A permit has been issued.

Christus Spohn Community Action Dental Clinic

They have submitted a development plan to remodel suite c into a Community Action Dental Clinic. The Development Review Team has distributed the plans to all the members for review. They have been approved for a building permit. A permit has been issued.

Café 5

Ramy Nassar, owner of Café 5 has submitted plans to move his restaurant Café 5 from the current location of 634 E. King to 1106 N. Armstrong. They have been authorized to obtain a building permit. A permit has been issued. They started construction and should be completed by mid-October.

Nuevo Santa Gertrudis Apartments

These apartments will be located at 1414 W. Santa Gertrudis. There are 56 efficiency units in the development. Plans have been reviewed and there is still a point to discuss with them concerning the location of a driveway. Staff hopes to talk to them this week to resolve that issue. It is also staff's understanding that the apartments next door and this development could be purchased by another company. That company is doing their due diligence regarding this transaction.

Enterprise Rent a Car

Staff heard back from them and was informed that the sale of the ground went through, so they plan to pursue a special use permit. The land they purchased is on the west side of US 77 and the north of Caesar Blvd.

Planning and Zoning Commission

At the past meeting of the Planning and Zoning Commission, the Commission had discussions regarding fence regulations, accessory buildings and carports. The Commission determined that they did not want to make any changes for those three items as they relate to the code of ordinances.
