*** For traffic violations within a school zone add \$25.00 to the court cost. Violations specific to school zones have the fee added to the court cost already.

For any violations issued to a juvenile (16 years of age and younger), the case must be set for court and they **must** appear with a parent/guardian. All minor in possession (Tobacco & Alcohol) and Minor DUI citations issued to those age 16 years and younger **must** also be set for court (with parent/guardian). Those age 17-20 with alcohol violations **must** see a judge (parent/guardian not required).

All Assault cases require the accused to appear in person in open court to enter a plea.
