This project will be in front of St Martin's Church.

Commissioner Laskowski stated that putting the handicap on the street is fine, but it's not enforceable unless the sign is visibly in front of the vehicle. Mr. Khan stated Mr. Springer met with the Street department regarding the signs.

Commissioner Wilson made a motion to authorize Mr. Springer to move ahead with this project, seconded by Commissioner Garcia. The motion was passed and approved by the following vote: Fugate, Laskowski, Pecos, Garcia, Wilson voting "FOR".

# **AGENDA ITEM #2**

### A RESOLUTION OF THE CITY OF KINGSVILLE SUPPORTING BULLYING AWARENESS.

WHEREAS, bullying is defined as "aggressive behavior that is intentional and that involves an imbalance of power or strength" and bullying has many forms: (1)physical- such as hitting, punching, tripping, etc.; (2) verbal- such as teasing or name calling; (3) non-verbal/emotional- such as intimidation using gestures or social exclusion; (3) cyber- such as sending insulting messages via email; and

WHEREAS, the stress from being bullied can interfere with student's engagement and learning in school. Victims (children) are more likely than others to be depressed, lonely, and anxious, have low self-esteem, feel unwell and contemplate suicide. Victims may fear going to school, using the bathroom (while at school), and/or riding the school bus; and

WHEREAS, characteristics of a bully include: tendency to be impulsive, hot headed and dominant; easily frustrated; lack of empathy; have difficulty following rules; and view violence in a positive way; and

WHEREAS, warning signs of victims include: comes home with torn, damaged or missing pieces of clothing or other belongings; has unexplained cuts, bruises and scratches; has few, if any friends with whom they spend time; seems afraid of going to school, walking to and from school, riding the bus, or taking part in organized activities with peers (school clubs, dances, etc.); appears sad, moody, teary or depressed when they come home from school; complains frequently about headaches, stomachaches, or other physical ailments; has trouble sleeping; appears anxious or suffers from low self-esteem. Children with disabilities may have a higher risk of being bullied than other children; and

**WHEREAS**, the 2010 statistics state that bullying is one of the strongest motivations for school shootings. More than 160,000 children miss school out of fear of being bullied and one out of ten students drops out of school or changes schools because of bullying. One out of twenty students has seen students with guns at school; and

WHEREAS, the remedies for bullying include: (1) schools with more security (indoors and outdoors) such as City Police or other security, (2) surveillance cameras mounted outside of school restrooms and blind spots, (3) making people aware and enforcing consequences of their actions (formal charges), (4) dedicating one week as a stand against bullying (Bully Awareness Week) to raise community awareness, (5) Anti-Bully Billboards in our community, (6) encouraging local radio stations, television stations and newspapers to release public service announcements, and (7) training school staff on bullying prevention.

**NOW, THEREFORE BE IT RESOLVED** by the City Commission of the City of Kingsville, Texas:

**THAT** the City Commission asks the citizens of Kingsville to be aware of the characteristics, consequences, warning signs, and remedies of bullying in an effort to end this social problem.

Re: KCVB Charity Bike Ride 2012

The Kingsville Convention and Visitors Bureau is seeking the City's sponsorship in the Annual Ride on the Wild Ride charity bike tour through the King Ranch on April 21, 2012. Last year's ride was successful and this year is expected to be even better.

The KCVB requests the City participate by allowing the use of city streets for the tour, providing cones and one police officer to escort the riders as they go through town (if needed), and having an ambulance on stand-by for the event. The City's participation will allow the KCVB to obtain an insurance rider, which is required by the Ranch. The bike route will be well staffed with Noon Lion's Club volunteers and other volunteers as well. Proceeds from this charity bike ride benefit the Lion's Disabled Children's Camp in Kerrville, of which Kingsville children directly benefit.

Also, as was done previously, the King Ranch is requesting the City execute the attached Permission and Indemnity Agreement for this year's bike ride as well.

#### PERMISSION AND INDEMNITY AGREEMENT

In consideration for King Ranch, Inc.'s permission (evidenced by its execution below) for a portion of the Ride On The Wild Side Charity Bike Ride (or similarly named event) ["Bike Ride"] (with participation/sponsorship by the Kingsville Convention and Visitors Bureau) to be held on the premises of King Ranch, Inc. in or about April of 2012, the sufficiency and adequacy of which consideration is hereby acknowledged, the City of Kingsville, Texas, hereby unconditionally and irrevocably agrees to defend, indemnify and hold harmless King Ranch, Inc., its directors, employees, shareholders and agents from and against any and all claims based on, or arising out of, personal injury (including death) to, and/or property damage of, any of the participants, support personnel or other individuals participating in, observing as by-stander of, or providing organizational or other support or safety services for, the above Bike Ride, including the arrival to or departure from the above Bike Ride and all other ancillary and related activities related to the Bike Ride. The foregoing defense, indemnity and holding harmless shall apply in full force and effect despite any sole, joint or concurrent negligence, strict liability or other fault of any of the above indemnified persons.

At least 30 days prior to the Bike Ride, the City of Kingsville shall provide a certificate of insurance to King Ranch, Inc. in a form and from an insurer acceptable to King Ranch, Inc. showing contractual indemnity insurance coverage in the amount of at least \$5,000,000 per claim or occurrence for general liability, automobile liability and law enforcement liability, to cover this contractual indemnity agreement. Such certificate shall require the insurer to provide King Ranch, Inc. at least 30 days prior written notice of any change, deletion or expiration to such coverage and terms and such insurance and certificate shall indicate that such coverage for the contractual indemnitees is primary and shall respond without contribution from any other insurance of such indemnitees.

The Bike Ride's sponsors shall obtain and provide King Ranch, Inc. waivers of liability, on forms approved by King Ranch, Inc., executed by all Bike Ride participants in the Bike Ride.
