#### Kingsville Day in Austin

The City Manager enjoyed his first trip to the Texas Statehouse on February 26<sup>th</sup>. City government was well represented by Mayor Sam Fugate, Commissioner Dianne Leubert, Planning Director Mike Kellam and Vince. The Statehouse was bustling with activity (wall to wall visitors) and a good time was had by all.

#### **Special Meetings**

The City Commission had two special meetings / workshops to discuss two of its highest priorities – housing opportunities and condition of city streets.

<u>Housing</u> – On February 27<sup>th</sup> the City Commission heard from City staff and the developer of a proposed 184 home housing development. The Commission is considering entering into an economic development agreement with developers of the Wildwood Trails subdivision where 184 new homes would be constructed in a 52 acre tract between Caesar and Sen. Carlos Truan Blvd. Attracting more residents to Kingsville will help grow the City's tax base and ultimately lessen the upwards pressure on property tax rates. The City would recover its incentive in about 10 years and at full build out, also in about ten years, the development would generate an additional \$280,000 in annual property tax revenues for the City and \$250,000 for Kleberg County (in today's dollars at today's tax rates).

<u>Streets</u> - On March 4<sup>th</sup> the City Commission heard from the City Manager and Public Works Director about the City streets inventory and proposed revisions to the City's paving plans. Staff will continue to work in the development of a street paving and maintenance plan that will also incorporate storm water drainage improvements needed for the street to last its full expected life. The City Manager thanks everyone who assisted with this effort.

## Annual Environmental Health & Safety Day at Celanese and TML Region 11 Quarterly Meeting and Work Shop in Victoria on March 7<sup>th</sup>.

The Mayor, Commissioners, City Manager, Planning Director and Risk Manager and a few other City staff attended the Celanese Safety Day on March 7<sup>th</sup> in the morning and early afternoon before heading to Victoria for the TML Region 11 Quarterly Meeting and Workshop later that same afternoon and evening. The workshop dealt with "Riding the Financial Wave of the Eagle Ford Shale."

#### **Finance Administration Division**

Every year since 1935, a team of CPAs has spent an average of 1,700 hours prior to Oscar night counting the Academy Awards ballots by hand. Two tuxedoed accountants from the Academy's accounting firm traditionally make an appearance during the live performance.



<u>Fixed Assets</u> - All City Departments were in compliance with providing their data back to the Finance Office by February  $22^{nd}$ . Thank you for your efforts. Arturo Moreno will be providing an update of the status of each department's fixed assets reconciliation at the next Director's Meeting on March  $13^{th}$ .

<u>Time Clock Plus</u> - Norma Cavazos in the Payroll Department has now completed the final step in implementing Time Clock Plus data upload into the Incode Accounting Program. The payroll data to be turned in on March 11<sup>th</sup> should be the Time Clock Plus information. Departments will finish phasing out the use of actual time cards within the next few weeks.

<u>Debt</u> - The Finance Department is currently reviewing Debt Policy industry standards. The Federal Debt instability as a result of debt ceiling limits and massive budgetary cuts that are being automatically triggered March 1<sup>st</sup> by political instability in Washington have brought this subject to the forefront with Bond Credit Rating Agencies. The debt policy ensures that the organization remains in compliance with the terms of its other debt agreements. An organization that borrows too much may breach the contract it has with its lenders. The types of projects which are acceptable to finance using loans are defined in the debt policy. Selecting a capital structure which minimizes interest expenses is also an important factor when creating a debt policy. Selecting appropriate debt policy factors assist in maintaining control over an organization's borrowing decisions.

During the Certificate of Obligation 2013 approval and debt issuance process, First Southwest the City's Financial Advisors reviewed the City's debt profile at length. Compared to other cities with similar tax base, sales tax revenue, franchise tax revenue, and population the City of Kingsville is about in the middle of the pack or average (not too high or not too low) in levying debt.

<u>Other Finance Activities</u> - Budget transfers from City departments were received last week and 1<sup>st</sup> Quarter financials were sent to Directors for their review. In addition, department directors can review their current line-item balances and their current month financials on-line. The Finance Department currently has Luke Womack and his staff back in the Finance Office working on the City's audit. They had taken off a couple of weeks to work on the Kleberg County Audit that is coming due at this same time. Several Grant and Seizure reports are being prepared for submission to State and Federal Agencies. As usual the federal government seems to find 50 different ways they want you to report how you use their money.

<u>Working Together to Achieve More</u> - The Utility Billing Department worked with the Municipal Court Department in sending out "Texas Warrant Round Up" flyers with the water bills that were mailed out February 20<sup>th</sup> and 27<sup>th</sup>, 2013. Also, additional

copies were handed out to the public as they came in to pay their water bills.

Accounts Receivable - The Collections Manager sent out monthly invoices for the following:

Outstanding weed liens - 452 and Demolitions - 9. As outstanding weed bills are being filed and input into the A-sundry Accounts Receivable (A/R) packet recently acquired and implemented over the past year. This A/R packet continues to grow in significance and importance in delivering services for the City. The Collections Manager's goal is to have cross-train the Customer Service Specialist and the Billing Specialist in the maintaining and processing the files as they come in. Also, the Customer Service Specialist would be able to issuing release of liens as they are paid off and ensure the property owners understand the steps that are to be follow once the lien is paid off. Once a lien is paid in full it will be the Customer Service Specialist responsibility to ensure that the file is marked appropriately on the A/R packet as well as any spreadsheets to avoid double billing the customer. The Collections Manager is working on inputting all outstanding Abatement of Noxious Matter liens and awaits the decision from Commission on outstanding paving liens.

The Collections Manager will continue to provide a status on each set of invoices going out on a monthly basis as well as status on training.

<u>Storm Water Fee</u> - The Collections department would like to remind the public that the final passage of the Storm Water fee was approved by commissioners on September 17<sup>th</sup>, 2012 Special Meeting. The flat rate for residential services is \$1.25 month (\$15 per year) and for commercial properties it will be dependent on the number of ERU units per parcel using the Appraisal District information (provided by HDR Engineering). This fee became effective October 8, 2012.

<u>Paving liens</u> - The Collections Manager would like to remind all involved that the deadline to receive the principal amount of any paving lien is March 12, 2013 to qualify for the interest abatement program. The Collections Manager does request that when calling in for a payment over the phone or paying in person that the correct paving job number is provided to the cashier for correct posting. The Utility Billing office does accept Visa and/or MasterCard, checks, money order, and cash. The Visa and/or MasterCard payment can be made over the phone at no cost to the customer. Once payment is received in full, a release of lien will be processed that must be recorded at the Kleberg County Courthouse. A notice was sent out to those outstanding paving lien property owners to remind them of

the upcoming deadline on February 7<sup>th</sup>, 2013. Some property owners have taken advantage of the waiver of interest and have paid on the outstanding paving liens. <u>Water Billing Statements</u> - The billing statements that went out during February 2013 included the following:

<u>Additional duties</u> - The Collections Manager continues to address any additional issues or other items such as projects, and/or reports requested by other departments that may arise while also making sure all monthly Collections Reports are completed in a timely manner and ensure the upmost customer service is given to all customers that visit the Utility Billing Department.

#### **Municipal Court Division**

The Kingsville Municipal Court operations are committed to providing quality customer service to all who appear in the court while we diligently execute the administrative duties of the Municipal Court as set forth by law. We promise to be innovative in creating methods and techniques that allow us to be more responsive to the needs of the public.



The Municipal Court is the judicial branch of the government of the City of Kingsville. The courts adjudicate Class C misdemeanor cases most of which are

criminal, including traffic, city ordinance, state code, juvenile, parking and disabled parking. It is committed to administering justice in a fair, efficient, and timely manner. Court services are increasingly available online, by telephone, and through the mail which contributes to compliance in a customer service and eco-friendly way.

<u>Court business as of February 13, 2013 through February 26, 2013</u> - There were a total of 252 new cases filed: The Kingsville Police Department filed 157 new traffic violations and 1 parking citation plus 22 new state law charges. There were 59 new Failure to Appear violations filed by the state prosecutor office and the City Community Appearance and Health Departments filed 13 new city ordinance violations. Notifications have been mailed out to the defendants for their court hearing. Prior to this month's court hearing, there were 170 cases disposed by full payment and 73 cases disposed through compliance and probation programs.

There were 15 (42 violations) new orders of arrest for contempt of court orders (failure to pay on payment plans/extensions orders). In addition to the arrest orders, the court reported 356 new cases to OmniBase (Texas Department of Public Safety) for suspension or denial for renewal driver's license on violation of non-compliance. As of today, there has been 1,019 cases reported to Omnibase: Traffic Offenses 611, Non-Traffic Offenses 26, and Non-Appear Non-Pay 382.

There were 229 (304 violations) warrant orders disposed due to the execution by the Kingsville Police Department and Warrant Officer T. Davis, Badge #25 and updates processed by Mrs. Rosa Vela. The court has reported 15 (30 cases) driver license released of suspension or hold of violators driver's license through OmniBase, plus 157 payments made through the payment plan orders. A sum of \$ 58,559.11 collected.

<u>Court Cases</u> - February 14, 2013, court hearing consisted of 448 cases (187 people), a total of 46 defendants and 5 inmates made their appearance in court: There were 21 cases closed upon full payment, 47 cases were setup on a payment plan, 5 cases were placed to pay in full within 30 days, 6 cases were set on probation, 12 cases were dismissed upon compliance, 29 cases are pending before the court for further ruling, 12 cases were reset to another court date, and 316 cases forwarded to the warrant division for new orders of arrest for not appearing in court.

<u>Special Thanks</u> - The Municipal Court would like to thank the Kingsville Police Department for the security provided for the court date on January 31, 2013; Officer S. Benys #73, Officer R. Webb #76 and Officer T. Cervantes #78.

<u>2013 Texas Warrant Round-Up</u> - The Kingsville Municipal Court and Police Department have united to participate in the Texas State 2013 Warrant Round-Up. This court has over 8,000 warrants that are in need of execution and this is a perfect time to address these orders.

The State of Texas initiate's this event every year and its sole purpose is to execute all active warrants, may it be orders from Municipal Courts, Justice of the Peace Courts, County Courts or District Courts. This is the only time that all Texas Law Enforcement bodies join together and go out and execute active warrants for the local courts and from other counties and cities courts.

This year's event started February 15, 2013 and the operation will continue until March 10, 2013. Before the period of execution, there is a grace period (February 15, 2013 until March 1, 2013) which the State of Texas will allow the individual(s) to resolve the warrant order with the court before March 1, 2013, without being arrested. On March 2, 2013, the law enforcement entities throughout the State of Texas will engage in rounding up individuals with active warrants. This process will continue until March 10, 2013.

During these events, the Kingsville Municipal Court will extend its office hours for this <u>Friday, March</u> <u>1, 2013</u>, from 8:00 a.m. until 8:00 p.m. and <u>Saturday, March 2, 2013</u>, from 9:00 a.m. until 3:00 p.m. During this period an individual with active warrant(s) will still have the option to file for a 30 day extension or a 4 month payment plan. For details of your options, please stop by the court's office and speak to one of the deputy clerks for assistance without being arrested.

If the individual is not able to stop by the court office but wishes to take care of the active warrant(s), the person can go to the city's website, <u>www.cityofkingsville.com</u> and pull up the information and pay with a debit card or credit card.

Food Service Inspections (February 15, - February 28, 2013)

Food Service inspections are conducted on a quarterly schedule per year based on the risk category to insure compliance with the Texas Food Service Establishment Regulations and local food sanitation ordinances. Risk levels include low, moderate and high risk. Establishment scoring is based on a demerit system, as per The Texas Food Establishment Rules. There are two types of violations. Critical violations are 5 and 4 points demerits per violation and non critical violations are 3 points demerit violations.

<u>Critical Violations are improper practices and actions that directly contribute to food contamination and temperature abuse that may pose a potential risk to the public health, resulting in food borne illness.</u> Critical violations must be corrected immediately or as directed by the Health Department.

<u>Non-critical Violations</u> are unacceptable practices that normally relate to the physical condition of an establishment, including equipment, cleaning and storage. Non Critical violations must be corrected before the next routine inspection or as directed by the Health Department.

#### **Community Participation / Events**

<u>Controlled Burning</u> - The Fire Department has been assisting with controlled burning operations at NAS Kingsville. This is a program used to reduce the amount of vegetation/fuels that could cause damage to structures if a large fire were to develop in the area.

#### **Training and Professional Development**

Station Drills - Fire crews participated in various training

drills throughout the period that included hose operations and self-contained breathing apparatus (SCBA) drills.





<u>Texas A&M Kingsville Disaster Planning and Exercise</u> - The Fire Department participated in the TAMUK emergency operations plans meeting and exercise held on February 20-21. The planning and exercise scenario were based on a simulated terrorist attack on the campus that included radiological hazards. Other agencies that participated in the planning included representatives from Kingsville Police Department, Kleberg County Sheriffs Department, U.S. Border Patrol, County Emergency Operations Coordinator, and the Texas National Guard 6<sup>th</sup> Civil Support Team (WMD).



**Vertical Ventilation Training:** On February 23, the Kingsville Fire Department and Kingsville Volunteer Fire Department conducted joint training on vertical ventilation techniques. The Fire Chief presented training designed to prepare firefighters to cut holes in the roof of one story buildings that are under fire conditions. The training is designed to allow crews with less than 4 personnel or crews that do not have immediate backup, to enter a burning structure. Federal OSHA regulations do not allow firefighters to enter a building that has an IDLH environment unless there are at least 4 firefighters on scene. IDLH stands for immediately dangerous to life or health and refers to fire/smoke conditions that require the use of breathing apparatus. If it is too dangerous or there are not enough personnel to go inside the burning building, the use of quick attack ventilation can be used to rapidly remove smoke from the building and occupants and allow for immediate interior search and fire attack. This is a modified tactic designed to aid small fire crews on specific types of structure fires. There are additional classes scheduled for the next two Saturdays.

#### **Other Department Activities**

<u>City/County Emergency Operations Planning</u> - The Fire Chief met with City Risk Manager / Emergency Management Coordinator Melissa Perez and County Emergency Management Coordinator Tomas Sanchez. The Fire Chief toured the County Emergency Operations Center (EOC) and discussed emergency operations, organizational histories, current projects, and interagency cooperation for emergencies.

<u>Planning</u> - Over the last two weeks, the Fire Chief met with officials from the Alice Fire Department, Halo Medical Air Transport Services, Sensible Care Ambulance Service, and Naval Air Station Fire Departments. Discussions included mutual aid, level of services, communications, and organizational capabilities.

<u>Officers Meetings</u> - Currently, the Fire Chief meets with Captains, Lieutenants, Union officials, and program coordinators every Friday morning. The meetings are open to all Department personnel to attend.

<u>Wind Storm</u> - On Monday, February 25<sup>th</sup>, the area was hit with high wind and low humidity conditions known by the National Weather Service as a Red Flag Warning. We experienced humidity in the single digits and sustained winds over 40 mph. The Kingsville Fire Department responded to 24 incidents during the 24 hour period. There were 7 EMS calls, 2 power lines down, 8 power lines arching, and 4 vegetation/wildland fires. Two of the wildland fires and at least one power line down call were mutual aid responses into Kleberg County. One fire was east of Ricardo and the other fire was north of town near the Celanese plant. The Volunteer Fire Department was able to assist with personnel on this day and the help was appreciated.

#### Fire and EMS Response Statistics

Fire/EMS crews responded to fourteen (45) fire/other calls, one hundred forty (102) EMS calls, for a total of one-hundred forty six (147) emergency calls between February 15 and March 1, 2013.

January 2013 - 54 prescriptions filled under this program used by a total of 22 individuals for a monthly savings of \$ 388.26. The average price savings was \$7.19 per prescription which translates to a 14.1% savings on prescriptions.

As of date, the program has been utilized by 1682 individuals for a grand total savings of \$55,443.73 since the beginning of the program in August 2009. The plan has averaged a 20.5% savings in filling 6,037 prescriptions for persons in the Kingsville community.

#### Wildwood Trails Subdivision

City staff continues to work toward the completion of the preliminary plat phase of the proposed Wildwood Trails subdivision. Negotiations continue and are anticipated to wrap up with regard to the Economic Development incentive package to finalize this future development for Kingsville. Currently, the preliminary plat has been forwarded to the Planning & Zoning Commission for review and recommendation to the City Commission. This meeting will take place on March 13<sup>th</sup> and soon thereafter the preliminary plat will be submitted to the City Commission for consideration. Prior to that it is anticipated that the Economic Development Agreement will be completed or near completion to coincide with the plat approvals. Staff will keep you updated on the proceedings.

#### H.M. King High School Renovation

The City/Foundation Coordination Team met on February 27<sup>th</sup> and continued to progress in the planning and implementation of identified action items. The floor plan and space allocation will be complete the week of March 3<sup>rd</sup> with schematic design already underway. Additionally, the estimation process is near completion of the preliminary estimate. The estimation will be more finely tuned as the design drawings are completed and further testing is completed. The interior plaster removal and demolition work will be completed no later than the week of March 3<sup>rd</sup> with structural analysis to take place beginning that week as well. Lastly, the work toward the additional land acquisition is ongoing. We await further word from KISD at this point, but are hoping to have the agreement finalized in March. To date, we are maintaining our operational timeline and are on schedule.

#### **Corridor Enhancements & Beautification Projects**

Work continues on the corridor planning and landscape enhancements. The current projects consist of landscaped corridor improvements to Santa Gertrudis from Seale Street west to Highway 141 and along

6<sup>th</sup> Street from Alexander Avenue south to Escondido Rd. A request for quotes went out on February 19<sup>th</sup> and quotes were due on February 28<sup>th</sup>. Once the quotes have been reviewed a proposal will be made to the City Commission on March 11<sup>th</sup> to continue the corridor enhancements, specifically along Santa Gertrudis. Look for this item to be presented at the upcoming meeting with a design plan to illustrate the placement of the plantings.

In other news, Phase II of the Dumpster Enclosure program is in the final stages prior to being submitted to the City Commission for consideration. Currently a Request For Proposals has been advertised and is set to close on Tuesday March 12<sup>th</sup>. This round will consist of nearly 120 dumpsters which will provide screening for the dumpsters along each of our main thoroughfares. We'll keep you updated on this project as well.

#### Kingsville Day at the Capital

Mayor Sam Fugate, Commissioner Dianne Leubert, City Manager Vince Capell and Mike Kellam attended Kingsville Day at the Capital in Austin on February 26<sup>th</sup>. The event had great attendance by many local leaders and was a good networking tool for all who attended. The group was recognized on the floor of both the House and Senate and we heard from Senator Lucio, Representative J.M. Lozano, as well as representatives from the State Comptroller's office and Education representatives. Important initiatives being implemented by the City, NASK, TAMUK and many other entities in the area were discussed and feedback was provided.

#### **Community Appearance Activities**

Community Appearance has revved up their inspection strategy



using mobile devices to upload property owner information in the field. Inspectors previously wrote information down that was time consuming, a duplication of work and at times difficult to get accurate information. Using the mobile device will enable the inspectors to upload information directly to our code enforcement program "Citizen Serve" and create a notice letter while in the field. Once the letter is created in Citizen Serve inspectors print out and mail notices once back in the office setting. This will be an effective and efficient strategy for code officers.

Jennifer Bernal submitted an grant application for Keep Kingsville Beautiful (KKB) to the Union Pacific Railroad and was awarded a

grant of \$3000 for beautification projects within the City. KKB is working on identifying a project to put this money to use. Cyndi Flores-Falcon and Jennifer Bernal will be testing in Corpus Christi for Code Enforcement certification on Friday March 1.

#### **Demolition Initiative**

The Building Dept. presented four dilapidated structures to City Commissioners at the February 25th meeting. Three of the four structures were granted demo orders and will be scheduled for demolition in the month of March. The Demo team has five structures that will be submitted to Legal for final review and will be presented in the near future at an upcoming City Commission meeting.

#### Chief Torres Attends CompStat Meeting at CCPD Wednesday 2/27/13

Chief Floyd Simpson of the Corpus Christi Police Department hosted a meeting attended by over 30 law enforcement personnel from area and federal agencies. The issue that was brought to the forefront was that of police pursuits that go into the City of Corpus Christi that CCPD wanted to assist but their policy on police pursuits might not allow them to do so. The City of Corpus Christi has a strict pursuit policy where they chase violent offenders and they have had to inform agencies coming into their jurisdiction that they cannot assist.

Discussed during the meetings were also items such as increased activity with synthetic marijuana as well as 8-liners operating in the area. Chief Torres reports that due to the Kingsville PD's proactive approach the locations that are selling those products outright have greatly diminished. Unfortunately it is still a problem due to customers purchasing the synthetic drugs in other municipalities and then

bringing it in to Kingsville to use as well as starting up a new drug trade with locals who are dealing the synthetic drugs.

As for 8-liners we take a proactive approach and let those who are attempting to open such businesses in our city that we will watch them closely and should their establishment be operating outside of state statutes then investigations will take place and appropriate charges filed.

#### 02-17-2013 Fight Leaves Several Injured, Five Arrested

On Saturday morning, just after 4 AM, Kingsville Police officers were dispatched to the 100 block of East Lee Avenue in reference to a fight in progress. As officers arrived, three males were found seriously injured. Other officers stopped the suspect vehicle blocks away. Inside the vehicle were several subjects who were arrested.

Two males were transported to Christus Spohn Memorial by Halo Flight. Both are in ICU, one with a severe head and facial injuries and the other with a broken jaw and possible internal injuries. Both will undergo surgery on Sunday morning. A third male was transported to the Kingsville hospital with head injuries. The three were injured by the arrested males who used fists, feet and a baseball bat. Their names are not being released at this time.

The arrested include: Brothers Adan Garcia (22) and Omar Garcia (26), Jesus Munoz (19), Eligio Mireles (21) and Amanda Alaniz (24). All were charged with three counts of Aggravated Assault (2<sup>nd</sup> Degree Felony) and one count of Engaging in Organized Criminal Activity (1<sup>st</sup> Degree Felony). All are still in the Kleberg County Jail with bonds totaling \$185,000 each. The investigation continues in this case. The public is encouraged to call the Kingsville Police Department or Kingsville Crime Stoppers (592-INFO) with any information.

#### **Capital Improvement Project**

<u>Concrete Intersection Reconstruction Projects</u> - Elite General Contractors, LLC has finished the reconstruction/repair of ten worst concrete intersections in between 6<sup>th</sup> to14<sup>th</sup> Street and Kenedy to Ragland Avenue (Bid #12-39). Preliminary walk-thru was done on December 07. Final work-thru was done on February 08. Contractor has taken care of the final punch list items. This is project is done.

<u>Curb and gutter Projects</u> - Staffs have located several bad flooding areas. The city is working to resolve the ponding problem in these areas by constructing new inlets, repairing old curb & gutter, constructing new curb gutter and valley gutter, increasing inlet throat opening and constructing concrete flume. In all new curb and gutter job, the City is installing handicap ramp. Several curb and gutter projects have done. Staff has shot elevations on Lott Avenue from 14<sup>th</sup> Street to 16<sup>th</sup> Street and 16<sup>th</sup> Street from Huisache Avenue to Lott Avenue. Engineering Department has started designing the new curb and gutter in this location.

Street Improvement Projects - Armstrong & Ailsie: Staff drove and then walked along Armstrong



Street from Santa Gertrudis to Caesar Avenue on Thursday, December 06 to determine the worst areas. 28 bad areas were detected in this street. City crews have started working at these areas to rectify quality issues on

Armstrong and, to a lesser extent, Ailsie. Armstrong will be striped after all the other items are addressed.

Crews repaired the bad area on Armstrong, south of Santa Gertrudis intersection.

<u>Corral/ Santa Rosa Drainage Project</u> – A preliminary walk-thru was completed on October  $23^{rd}$ . The contractor made some corrections for final walk-thru in February. Staff met with the contractor on Wednesday, February 13 to discuss the status of this project. The contractor is waiting on Franchise contractor to relocate some of the utilities as it was promised earlier.

<u>South Wastewater Treatment Plant Secondary Clarifier</u> – Project is on schedule. Plumbing is done, Clarifier floor and wall has been poured Bridge installed by CSA Construction. New Bar Screen is installed. Currently they are working on the electrical panel.

#### **Public Works and Engineering**

Public Works and Engineering Department staffs are working with City Manager to develop a long range Street Improvement Plans for the City of Kingsville. City's streets, curb & gutter,

Storm system inventory, conditions, maintenance, construction and financing will be presented to the City Commission on March 04.

GIS division under engineering department is in the process on setting up and utilizing a geo solution (ESRI) to resolve City's mapping needs. The staff met with HDR engineering on Thursday, February 07 to discuss the server setup issues. Currently the City has a localized machine in-house utilizing our hardware and software. The staff is looking at using SAAS model that would utilize third party cloud based hardware and software. SAAS model is very robust. In addition it would be location independent and provide critical services in an emergency management situation. SAAS model will be able to set up dynamically linked commonly used maps for consumption.

The City bought Civil 3D drafting software this year. This software is designed especially for the civil engineering drafting. So far the City was using AutoCAD for its in-house drafting need. Civil 3D software is from the same company AutoDesk but it is much more advanced in the sense that it is designed in such a way that if one element of the design (for an example slope of the street) changes, the software updates automatically rest of the items related to the item changed, which drastically reduces the drafting time. Recardo Pedraza, a TxDOT employee taught the City employees Civil 3D software on February 9 and February 10 and will be teaching on Sunday 10 at his own time.

<u>Keeping the Lights on</u> - In the past, City's burned out Street lights were not replaced until those were noticed by the citizen or the staff. From November 2011, staff started doing the inventory for the burned out street light throughout the City. Street Division crews drive for several hours at nights and

collect the data every month and the information is sent to AEP for necessary action. The burned out street lights are taking care of immediately.

Also, since public works services a large majority of the city it is imperative that we develop a method for them to receive adequate services.

#### Library Hosts Bilingual Story Time

**Technology Projects Improve Library Computers** 

Several projects have begun on the library's overall network and show great promise of improving the library's recently updated computer labs. HBMG, Inc. of Austin, TX recently visited the library to provide a Technology Assessment that will offer insight to the safety, security, and reliability of the library's network. This assessment, which was provided as a "paid in full" service by the Texas State

Library & Archives Commission, has helped the library reevaluate the way its computers are setup and maintained. The assessment also offered new insight into improving computer maintenance, and has helped point the library in the right direction for maintaining its policies concerning computer and Internet access. Regarding maintenance, the library has also begun filing paperwork to receive E-Rate federal funding to help replace and create consistency with the computer hardware (i.e. switches, hubs, cabling) on the library's network. This project is expected to be ongoing, with an anticipated completion date in 2014.

#### Interdiction Training

On February 19<sup>th</sup> through February 22<sup>nd</sup>, 2013 Kingsville Task Force Interdiction Agents attended "Advanced Passenger Vehicle Criminal and Terrorism Interdiction" in Aransas Pass, Texas. #### Kingsville Task Force Assists with Counterfeit DVD/CD Investigation

On Thursday February 28, 2013 Kingsville Task Force Agents assisted with the arrests of seven Corpus Christi residents who had been indicted as a result of a multi-agency investigation into intellectual property rights violations. The indictments stemmed from a year-long investigation into the manufacture and distribution of counterfeit DVDs and music CDs in the Corpus Christi area. Agents had obtained federal search warrants in August 2012 for three residences and a local business, all located in Corpus Christi. The indictment alleged that during the execution of the search warrants, agents seized more than 58,000 pirated DVDs and CDs along with production materials including computers and DVD duplicators.

#### **Open House**

#### **HEB** Canopy

We began planning the next phases for adapting the HEB canopy for use as a City Downtown Pavilion. We envision adding decking, utilities, lighting, fencing, parking, sidewalks, and street furniture.

The initial move went smoothly and there has been site work and engineering completed, but seemed to reach a standstill. We are taking steps to put a deadline on the existing contractor and/or to replace him.

On Friday March 1, a subcontractor for the HEB canopy house-mover paid for a contractor license and picked up a permit for completion of the canopy installation. We met with him on the downtown park site and reviewed the actions needed to complete the project.

#### Downtown

The Kingsville Historic Downtown District Association had a meeting at the Depot on Tuesday, February 26. The meeting calls attention to our expanded use of the building and the partnerships among downtown entities and Tourism Department functions.

Cynthia Martin continues to work on the Grant-funded Historic Resources survey in partnership with the university. The City Commission approved a contract amendment in furtherance of that partnership. That project will give us up-to-date and accurate descriptive and mapping information to assist with historic preservation, building and planning responsibilities of the City, while encouraging community and economic development. This project was designed to support programs and capabilities of the university and to provide employment for students.

#### Murals

We continue to develop policies, procedures and partnerships that support downtown arts. We are working with the University and others to protect and to promote the Virgen de Guadalupe ground mural and we continue to pull the inherited KCVB mural into City systems and controls that will both protect our investment in that project and provide a basis for handling future projects.

We are scheduling several aspects of the projects to come before the City Commission: contract amendment, content approval and location approval.

We anticipate art becoming an important part of our downtown and our tourism.

#### Media

This department is in the business of promoting people, organizations, events and the community; this includes much media contact. We have developed protocols for requesting permission for some actions and for informing management.
