Celebrating Community Appearance Achievements

Congratulations to Mike Kellam, Jennifer Bernal, Charlie Cardenas, Bill Donnell, Luke Stevens and their respective staff for their successful work and effort to clean up 150 private lots. Thanks also to police officers for being vigilant in a few tense situations. This staff initiative started 15 months ago and has been successful in cleaning up the City's ten worst private properties each month for fifteen months for a total of 150 debris-strewn and unsightly properties throughout Kingsville. The City has been successful at cleaning up the properties and keeping them cleaned up and will continue this program and add to this total until it is no longer needed, which will be quite a long time from now. Staff estimates that there are between 1,000 and 2,000 private properties that need to cleaned up in Kingsville. The 150 lots is a strong down payment on our future efforts and successes.

Let me also congratulate these same crews for demolishing 45 dangerous structures in just the past 7 months – 20 Commission-approved involuntary demolitions and 25 staff-lead voluntary demolitions.

Food Service Inspections (May 3, 2013-May 16, 2013)

Food Service inspections are conducted on a quarterly schedule per year based on the risk category to insure compliance with the Texas Food Service Establishment Regulations and local food sanitation ordinances. Risk levels include low, moderate and high risk. Establishment scoring is based on a demerit system, as per The Texas Food Establishment Rules. There are two types of violations. Critical violations are 5 and 4 points demerits per violation and non-critical violations are 3 points demerits.

Critical Violations are improper practices and actions that directly contribute to food contamination and temperature abuse that may pose a potential risk to the public health, resulting in food borne illness. Critical violations must be corrected immediately or as directed by the Health Department.

Non critical Violations are unacceptable practices that normally relate to the physical condition of an establishment, including equipment, cleaning and storage. Non Critical violations must be corrected before the next routine inspection or as directed by the Health Department.

Mosquito Season - A Reminder to Protect Yourself from Mosquitoes

The past week has brought some rainfall into our area along with a possibility of mosquitoes. So what can you do to help reduce the number of mosquitoes around your home? Always remember that mosquitoes need water to breed, and they will use any source available. So be sure to:

- Drain any standing water around your home.
- Empty cans, buckets, rain gutters, tires and flower pots.

• Change the water in pet bowls, wading pools and bird baths several times a week.

Mosquitoes are simply annoying, but they can also be dangerous. It is important to protect yourself from a mosquito bite. To prevent any chances of becoming infected with a mosquito borne diseases please do the following:

- Apply insect repellant containing DEET.
- Dress in long sleeves and pants when outdoors.
- Stay indoors at dusk and dawn (these are the times when mosquitoes are most active).

It is important that everyone does their part to help prevent the breeding of mosquitoes. The City-County Health Unit will start mosquito surveillance this month, and will start to spray for mosquitoes if need be. Spraying is done at dusk, and the entire city is sprayed. Chemical pellets have also been placed in standing water to kill mosquito larva. If you have standing water you may soon have mosquitoes, so remember to drain after the rain.

<u>CAFR Update</u> - The Finance Department has been busy with completing the Comprehensive Annual Financial Report (CAFR) that is due May 31st, 2013. The Transmittal letter, the Management Discussion and Analysis, Footnotes, and the Statistical Section are the final requirements. A special THANK YOU to all the City Departments and Outside Agencies that assisted in providing current year information for the CAFR.

A Transmittal letter accompanies the report and informs readers of the CAFR's context. Typically, the letter includes information not found in the report. For example, the letter contains information about the particular project and/or due dates. A Transmittal Letter is a business letter and should be formatted accordingly.

The Management Discussion and Analysis (MD&A) is a section of the annual report in which management discusses numerous aspects of the entity, both past and present. Among other things, the MD&A provides an overview of the previous year of operations and how the entity fared in that time period. Management will usually also touch on the upcoming year, outlining future goals and approaches to new projects. The MD&A is a very important section of an annual report, especially for those analyzing the fundamentals, which include management and management style. Although this section contains useful information, investors should keep in mind that the section is unaudited

Financial statement footnotes are explanatory and supplemental notes that accompany the financial statements issued by an entity. The exact nature of these footnotes varies, depending upon the financial framework used to construct the financial statements (such as GAAP or IFRS). Financial statement footnotes are an integral part of the financial statements, so you must issue them to users along with the financial statements. They are extremely valuable to the financial analyst, who can discern from the footnotes how various accounting policies used by a company are impacting its reported results and financial position.

The Statistical Section presents detailed information as a context for understanding what the information in the financial statements, not disclosures, and required supplementary information says about the City's overall financial health. It contains information relating to financial trends, revenue capacity, debt capacity, demographics, and operating information. Unless otherwise stated the information in these schedules is derived from the CAFR for the relevant year.

<u>Vacant Accounting Positions</u> - The Finance Department has two positions posted for hire. They are the Accounting Department Supervisor and the Assistant Director of Finance. The Supervisor position requires a Bachelor's Degree in Accounting or Finance and 2 years supervisor experience in accounting, finance or a related field. The Assistant Director position requires a Bachelor's Degree in Accounting or Finance, 5 year experience in public, private or governmental accounting, 3 years supervisory experience to include areas of accounting, finance, and budget and CAFR preparation. <u>Time Clock Plus</u> - The Finance Director, Accounting Manager, and Payroll Department met with the Fire Chief and two members of his staff to discuss payroll software issues for the Fire Department. Time Clock Plus provided a webinar to discuss the viability of its program in handling the unique requirements of the Fire Department. A second Webinar with software provider Telestaff/Kronos was held to evaluate that programs ability to provide enhanced features as a comparison to what Time Clock Plus provides. The next meeting on this subject is scheduled for June 10th.

<u>Storage/shredding</u> - The Finance Department has been working with the City Secretary regarding the record retention and destruction of a few dozen boxes of financial information in an effort to provide additional storage space at City Hall and to improve overall appearances.



Storm Water Fee - The Collections Department would like to remind the public that the final passage of the Storm Water fee was approved by commissioners on September 17th, 2012 Special Meeting. The flat rate for residential services is \$1.25 month (\$15 per year) and for commercial properties it will be dependent on the number of ERU units per parcel using the Appraisal District information (provided by HDR Engineering). This fee became effective October 8, 2012.

<u>Paving liens</u> - On March 11, 2013 the Commissioners voted to extend the waiver of interest on paving liens for another year. The Collections Department will continue to accept principal payments through March 11, 2014. Property owners that have received a release of lien must record the release of lien at the Kleberg County Courthouse.

The Collections Manager does request that when calling in for a payment over the phone or paying in person that the correct paying job number is provided to the cashier for correct posting. The Utility Billing office does accept Visa and/or MasterCard, checks, money order, and cash. The Visa and/or MasterCard payment can be made over the phone at no cost to the customer. Once payment is received in full, a release of lien will be processed that must be recorded at the Kleberg County Courthouse.

<u>Additional Collection Manager Duties</u> - The Collections Manager continues to address any additional issues or other items such as projects, and/or reports requested by other departments that may arise while also making sure all monthly Collections Reports are completed in a timely manner and ensure the upmost customer service is given to all customers that visit the Utility Billing Department.

Municipal Court Division

<u>Court business during the period May 3, 2013 through May 15, 2013</u> - There were a total of 189 new cases filed as of May 14, 2013: The Kingsville Police Department filed 98 new traffic violations, 16 new state and city law charges and 14 city ordinance offense on junk vehicles. The State Prosecutor's office filed 46 new Failure to Appear charges.

As of May 2, 2013 there were 159 cases adjudicated by full payments, compliance dismissals and probation programs. A total amount of \$24,534.22 in court fees and fines was collected. In the warrant section of the court there were 82 arrest warrants served by the Kingsville Police Department officers and Warrant Officer T. Davis, Badge #25.

<u>Cases Heard in Open Court-During this update</u> –

April 25, 2013, there were 300 court cases set of which a total of 174 people were to make their court appearance. As the final adjudication for these cases, the court ruled as follow: 9 cases for full payment within 30 days, 65 cases were approved for payment plans, 37 cases were closed out due to full payment being received, 2 individuals were ordered to perform community service hours with the city, 3 cases were dismissed for providing proof of compliance, 7 reset for trial, 64 cases were reset for another court date, and 113 cases were forwarded to the Warrant Department for process and reporting these individuals to the State Ominibase for suspension or withhold of the their driver license.

May 9, 2013, there were 405 court cases set of which a total of 183 people were to make their court appearance. As the final adjudication for these cases, the court ruled as follow; 85 cases were approved for a payment plan, 2 cases were ordered to pay the penalty within 30 days, 7 cases set for trial, 2 individuals were ordered to perform community service hours with the city, 22 cases were dismissed due to compliance of probation program, 35 cases were close out by receiving full payment and 78 cases were set for another court day. For the non-appearance individuals there were 174 cases forwarded to the Warrant Department for process and reporting these individuals to the State Ominibase for suspension or withhold of the their driver license.

Participation in Community Events Update

The Human Resource office is preparing information to go out for self-funded insurance bids - Periodically the City will go out for formal bid to get the best value for employee health plans and administration.

Planning & Administration Division

Texas Theatre Renovation

The interior demolition of the theatre, which included seat removal and other later additions to the theatre when it served as a church, has been completed. The owner has submitted plans for review, and they are currently under review by the Development Review Team for approval prior to permit issuance. Exterior plans have been received as well which will restore the exterior character to what it was when it served as a theatre including the poster cabinets, ticket booth and the neon signage and marquee. It's anticipated that the plans will be reviewed by the Historic Development Board at their next meeting. Upon approval, the owner intends to begin exterior work on the marquee and signage.

H.M. King Adaptive Re-Use Project

The door and window installation will soon begin. The anticipated delivery of the windows is in early June, with the restored doors to follow shortly thereafter. Currently, the window frames are being reconstructed to allow a seamless installation. The architectural and project management contracts are still yet to be signed, but the coordination committee is hopeful this will take place soon. Until the contracts are signed no further work can be performed. Once the contracts are completed the structural work can be bid out with subsequent commencement of work. From that point contracts will be awarded for the interior design of the mechanical, electrical and plumbing among other design related activities. Once design is complete bids and contracts can be awarded to which construction will begin.

Santa Gertrudis Landscaping Installation

Preliminary work is still underway due to the gift of rain in the area. The utilities are marked and a test dig has been performed to determine what lies beneath the top soil. The test dig found what was suspected in that the soil contained caliche and remnants of asphalt paving. Due to this finding the contractor is suggesting digging larger diameter holes and bringing in topsoil to allow for appropriate drainage and growth of the trees. It's anticipated that the hole digging will begin the week of May 20th with planting to follow.

Dumpster Enclosure Phase II

Phase two of the enclosure plan is underway. Luke Stevens has conducted a visual survey of the sites with the contractor and they are nearing the construction phase. They've separated the construction into phases based on location and surface type to ensure a smooth process. Construction should begin on the first enclosures the week of May 20th as well.





<u>Concrete Street Evaluations</u> - Engineering evaluated 20 sections of concrete roadways. These sections

of roadways are part of the 2013 Street Construction program. The evaluation consisted of existing conditions, drainage, service life and ride quality.

Street Division (04/28-05/12)

<u>Paving</u> – The Street Division completed road construction on Calvin Street from 21st Street to the end of the Cul de Sac (about a block and a half), totaling over 175 tons of Hot Mixed Asphalt Concrete (HAMC, or Hot Mix). Construction consisted of placing elevation stakes (blue tops), a new concrete curb and gutter for drainage, watering base material and rolling the base material. Due to rain on 04/28/13, construction was delayed.



However, water was pumped from the job site, blue tops were placed and the base was rolled. Street crews is applying limestone and seal coat on 5th Street between Lemonwood to the dead end, 4th Street between Lemonwood to the dead end and 2nd Street from Lemonwood to the dead end (each Street about half a block).

Summer is right around the corner, and the library and its staff are currently making preparations for its



annual Summer Program which draws in on average over 500 kids each year. This year, the library is offering program attendees a wider range of activities for all age groups to participate in, including having the opportunity to be exposed to and explore the worlds of science and engineering. The Texas Alliance for Minorities in Engineering, a statewide, non-profit organization that provides programs in Science, Technology, Engineering, and Mathematics, in conjunction with the Central Texas Library System, is teaming up to provide a mobile science and engineering exhibit this year to help libraries draw in students to their summer programs. The exhibit, called the Trailblazer, is a 60-foot long trailer that

houses a variety of engineering and science exhibits targeted for students in grades 3 through 7. It is the only interactive science and engineering museum-on-wheels in Texas, and the first of its kind to cover such topics as, magnetism, aerodynamics, space science, weather, and medical sciences, just to name a few. The library is planning on having the Trailblazer setup from 10 AM until 4 PM, as a public exhibit, where residents can stop by at any time and tour the trailer and interact with the individual stations. Some of the highlighted exhibits of the trailer that the public will have the opportunity to see and touch will include a robotic arm, an ion-powered rocket engine, a Van de Graaf generator, a Luminglass display, and the Kalliroscope tank demonstration. Since the Trailblazer covers several areas of science and engineering, the library is planning on utilizing summer students from Texas A&M University – Kingsville's College of Engineering and College of Arts and Science to serve as trained volunteers that can add an enhanced experience for visitors to the trailer. The Trailblazer trailer is scheduled to be on display at the library on Tuesday, July 23, 2013 and will be a part of the final activities for the 2013 Summer Program.






