As spring break 2016 begins many of our young citizens who make their homes in Kingsville



either as residents or here while attending school or serving our country will be taking advantage of the time off. Unfortunately, many times people engage in behavior that is not always in their best interest, so I searched for some online tips regarding how to be safe during this time. I located some information which is directed at females but can also prove useful to males. Please drink responsibly and make good choices if you plan to partake during spring break and follow the tips listed below:

Spring Break Tips

On the go . . .

- Take turns behind the wheel. Rotating drivers can keep everyone rested with the added bonus of taking turns deciding on the music.
- Whoever sits shotgun should stay awake to keep the driver company. Two alert drivers are always better than one.
- Make sure everyone has a valid driver's license and the vehicle registration and proof of insurance are in the car before driving off. If you are in a foreign country, know ahead of time if your license and insurance will be valid in that country.
- Take a map. These days everyone relies on their phones for navigation, but in some places, where service isn't strong, you can lose that ability. Having a map is always a nice backup plan when on a road trip. There are just plain old maps. Do a search for the city you are travelling to. There are a number of apps on Google Play and in the App Store that don't require an internet connection or GPS.
- Never leave valuables in plain view in your car. Lock items in your trunk before reaching your destination.
- If you are in a foreign country, take some time before your trip to familiarize yourself with basic road signs and rules of the road for that country. Travel books by <u>Frommers</u> and <u>Lonely</u> <u>Planet</u> are great resources as are your rental car facilities.
- If you are hailing a taxi, ask ahead for a typical price. This is especially important in countries where taxis don't have meters. If there is no meter, you must negotiate the fee before you agree to the ride. The front desk of your hotel is a great resource to tell you how much a ride should cost.
- Before leaving your hotel, take a card from the front desk with the name of the hotel, phone number, and address, just in case you need help getting back. Also, put this information in your phone to be extra sure you have it.
- Calling a taxi is a better bet than hailing one. And at the airport, always use approved taxi services. Ignore people who approach you offering rides.
- All genuine taxis will have some sort of ID or badge. You can check for this before accepting a ride.

- Stay alert during any taxi, Uber, Lyft, etc. rides. Follow along on google maps or a navigation service, if you can, to ensure they are taking you the right direction.
- Keep your belongings together during a ride to ensure you don't leave anything behind.
- If you ever feel unsafe, it is completely within your rights to abandon a taxi or any other ride service at a safe stop. Leave money behind on the seat and get out of there if you don't feel safe.
- When using Uber or Lyft, you will see the driver's name, license plate number, and photo on your phone when you request the ride. Check for a match when you ride arrives to be sure you are getting in the right car.
- Never get in a car with someone you suspect is intoxicated. There is always a safer alternative.
- The often crammed conditions of a subway or metro can be an ideal place for pickpockets to strike and is definitely time to up your awareness.
- If you are going to carry a backpack, consider getting a small lock for your zipper and keep the key in your pocket. Another theft reduction is to carry your backpack on your front instead of your back in crowded areas.

In hotels . . .

- When you check in at the front desk, use discretion in saying your room number out loud for anyone in the lobby to hear. No one outside of your group of friends needs to know your exact location.
- Reserve a room that's above the 1st floor but below the 6th floor. First floor rooms are easier to break into, and rooms above the sixth floor are sometimes too high for fire ladders to reach.
- Choose awareness! Make a mental note of where the nearest fire exits and stairwells are located in case you need to evacuate.
- When you get to your room, check that all of the window and door locks are secure.
- Almost all hotels offer safes. Use them! This is a great place to store any cash or credit cards that you don't want to have on hand when you are out of the hotel and any other easy to steal items such as Ipads, Ipods, jewelry, laptops, backup ID (DL or passport).
- Close your door tightly when entering or leaving your room. Some doors have a slow release and could remain open after you leave.
- Do not place ski gear, dive gear, or anything valuable on your balcony.
- Using the Do Not Disturb sign won't prevent housekeeping from being able to enter your room, but will highly reduce the likeliness of that happening. If you are going to have housekeeping in your room, leave your valuables in the safe when you are gone.

At the ATM ...

- Try to go the ATM in groups, but avoid getting overly complacent about safety just because you're traveling in numbers.
- When you approach the ATM, do a full 360 degree scan, looking completely around you to see if anyone is hanging out where they shouldn't be. If someone is creeping you out, go to another ATM.
- When entering in your pin number, use your other hand or your body to cover the keypad. Just because you don't see someone watching you doesn't mean there couldn't still be a camera capturing what you type.

While drinking ...

• Do us all a favor, especially yourself, and party smart. Be responsible.

- Decide before you go out what your limits should be. When you are sober and making clear-headed decisions is the best time to consider what you feel your personal boundaries should be. Do I want to drink tonight? If so, how much? Do I want to have sex tonight? If so, do I have protection? Deciding up front will make it easier for you later to make choices that you will be happy with after the party is over.
- If you do decide to drink, know the liquor laws of wherever you'll be vacationing.
- Always keep an eye on your drink. If you go the bathroom, take your drink with you! Date rape drugs can be put into any drink, including non-alcoholic drinks. It is also important to remember that while drugs being slipped into drinks is something you should be aware of and guard against, alcohol itself is the most common date rape drug. In a 2007 study by the National Institute of Health, it was reported that 89% of female undergrad sexual assault survivors reported drinking before their assault. No survivor is to blame for their assault, but the links between alcohol and victimization are staggering and cannot be ignored.
- Do not drink from open beverage sources like punch bowls, pitchers or tubs.
- If you or one of your friends sees or feels the signs of predatory drugs: extreme wooziness, confusion, difficulty standing, or slurred speech, get to a safe place immediately and if the symptoms are severe, go to a hospital.
- Drinking and driving is always a dangerous situation and illegal, so avoid this by having your safe mode of transportation home planned before you go out. Having a designated driver before the night starts can be great for driving and for keeping an eye out for everyone as well.
- Avoid binge drinking. NIAAA (the National Institute of Alcohol Abuse and Alcoholism) defines binge drinking as a pattern of drinking that brings blood alcohol concentration (BAC) levels to 0.08 g/dL. This typically occurs after 4 drinks for women and 5 drinks for men—in about 2 hours. Binge drinking can lead to irreversible consequences.
- Pace yourself if you choose to drink. If you are new to drinking or have very limited experience, a party setting away from home isn't the best place to start figuring out your limits. Remember in pacing that while you can feel the effects of alcohol in as little as 10 minutes, sometimes it can take longer so, go slow, and see how you feel before ordering a second drink.
- Don't try to match friends drink for drink. The way alcohol affects your body will be different than everyone else based on how often you drink, what kind of alcohol, your weight, and how much you ate.
- Eat before drinking. Drinking on an empty stomach can cause alcohol to affect you much quicker and can make you sick and those bowls of snack mix aren't much substance to go on.
- Be aware that some types of alcohol have stronger and faster effects, i.e., one beer is not going to have the same impact as one Long Island Tea. A standard drink in terms of consumption is 12 ounces of beer, but only 5 ounces of wine, or 1.5 ounces of hard liquor.
- Some of the most common side effects of alcohol usage are: reduced inhibition, slurred speech, motor impairment, confusion, and memory and concentration difficulties. In other words, you aren't going to be at your most aware when drinking which can put you in the position of being targeted by criminals. Is this fair? No. Is it your fault? Never. However, if a mugger is looking for someone to steal a purse from and they have to choose between someone who is obviously intoxicated and someone who is not, the choice is simple. This applies to all forms of crime, including sexual assault.

• For this reason, when drinking, is even more important to follow the golden rule of partying safe: **Come with your friends. Leave with your friends.** We need to look out for each other and if you see someone not in your group in a potentially bad situation, look out for them too. Being an active bystander is the best way we can work together to end violence of all kinds.

In the water . . .

- Drinking + sun can equal a bad sunburn and an even worse hangover. Sun can maximize the effects of alcohol so keep this in mind when you party poolside or at the beach.
- Take it slow and stay hydrated by drinking lots of water. If you start feeling faint or light headed, get shade and water immediately.
- Use waterproof sunscreen at least SPF 30 and reapply often. Pay extra special attention to ears, nose, face, feet, and shoulders.
- Avoid sun exposure during the hours when UV rays are the most intense (between 10 am and 4 pm) and remember you can burn even when it's cloudy.
- Jumping into the ocean without a lifeguard is putting yourself at risk. Always swim with a buddy. Even the most experienced swimmer can get caught in an undertow. If you are caught in a rip current, don't bother swimming against it. Instead, swim parallel to shore until the rip passes.
- Know the flag system for water safety:
 - Red Flag: Stay out of the water because of strong undertow and riptides.
 - Yellow Flag: Use CAUTION in the water. There are some undertow and riptides possible.
 - o Blue Flag: Calm water. Swim safely.
- Drinking in the hot tub might sound like a good idea, since pretty much every MTV video makes it look glamorous. But lo and behold, MTV is not an educational resource. (shocker!) Alcohol can dialate blood vessels and lower blood pressure to dangerous levels. The effects of alcohol are felt sooner and stronger in a hot tub. It can lead to unconsciousness and drowning.
- In any natural body of water, be aware that you can't always tell how deep the water is. Don't dive if you don't know for sure how deep the water is. Diving in too shallow of waters can lead to serious accidents.

Let's talk about sex . . .

- First, don't believe the hype about our hook-up culture. Not everyone is hooking up. Choices to have sex or not to have sex are extremely personal and shouldn't be influenced by anyone's mandates but your own.
- Know what consent is and respect it for all forms of intimacy. At Girls Fight Back, we define consent as giving permission for something to happen and that permission must be given freely and is never coerced. Consent must be given verbally. Silence NEVER equals consent. Consent can never be implied or assumed regardless of any previous history of sexual contact. No matter what a person verbalizes, consent can never be given when a person is severely intoxicated or impaired or at any point in the encounter after the person has said NO. Really, I think we should raise the bar a bit, consent should be ENTHUSIASTIC and that applies to all kinds of contact. If it's not a YES, it's a definite no.
- Talk about it. In order to obtain consent, you have to have a verbal exchange regarding the sexual encounter before it takes place. Sound awkward? It shouldn't be. If you are uncomfortable talking about sex with someone, you shouldn't be having sex with them in the first place. But, consent, can be obtained as part of foreplay, "Do you want to have sex with

- me tonight?" can be a huge turn-on and some form of that question should be incorporated into all sexual encounters.
- Decide before even head out for a party or on a trip, what you want your personal boundaries to be in regards to intimacy. Then set your boundaries early and reinforce them often. If you meet someone and decide to get cozy, but don't to have sex, be up front with them. You can say something like, "I really want to make out with you, but that's as far as things are going to go. Cool?" Don't ever let anyone talk you into doing something you're uncomfortable with.
- If you do choose to have sex, make sure it's protected. Stock up on protection before you leave home so you never find yourself in a compromised situation. While other methods of birth control may avoid accidental pregnancies, condoms are the best way to prevent STD's. Always carry two in case one breaks. The responsibility for having safe sex is equal for men and women. Anyone who plans on engaging in sex should have protection.
- Don't abuse alcohol or drugs if you think things might get physical. Alcohol and drugs interfere with decision making which can lead to the lowering of inhibitions and forgetting to use protection. And, for many biochemical reasons, too much alcohol actually makes sex less enjoyable for both men and women.

Leaving the country . . .

- If you're leaving the country you'll need a passport. You might also need a Visa depending on your destination. You can check that here (U.S. State Department Website). These are not quick and easy documents to attain, so file your application at least 6 months before going on a trip abroad.
- Safety has a lot to do with what you pack when traveling abroad. Don't bring flashy valuables like expensive jewelry or watches.
- Do your homework beforehand about your destination, keeping in mind you are subject to the laws of the country you visit. You should also check here (U.S. State Department Website) for any travel warnings or travel alerts by the US government.
- Do not carry large quantities of cash. These days ATM's are everywhere so you can replenish if you need to. If you do have mostly cash, always keep part of your cash in your hotel safe and the rest of it in two locations on your person. That way if you are mugged or robbed, you won't lose everything.
- Take at least two credit cards or debit cards with you. Keep one on your person and one in the hotel safe. Make photocopies of the front and back of all cards and keep in your safe and/or leave this with someone at home. If your card is stolen or lost, this will make canceling the card much easier.
- You will want to have ID on you when you are on the go in a foreign country, but you will want a back up ID also left in your safe at your hotel. If you do lose your main ID, you can use your back up ID to assist you when getting it replaced by the US Embassy.
- Be aware of local scam artists. The best way to avoid scams is to know some common ones ahead of time. These two sites have many of the common scams listed: Wikitravel and Lonely Planet. Once you know these scams are happening, you are likely to see them from a mile away before you fall for one.
- Always inform others of your travel plans including hotel and contact information while you are away. Give someone back at home a copy of your passport as well just in case yours is lost or stolen. This will help you if you have to get a replacement passport from the US Embassy.

- If you are mugged or robbed, remember that the only thing irreplaceable is you.
- Keep your camera hidden until you are ready to use it.
- Avoid viewing maps in wide-open spaces.
- Do not take shortcuts. Stay on well-traveled streets.
- Check your phone before you leave the US to be sure that you are enabled to use it overseas in case of emergency.
- Learn the customs before you go and a few common phrases if you are headed to a destination where the primary language is foreign to you. Knowing how to say: "Hello," "Thank you," "Please," "How Much," "Where is" . . . will go a long way to making your experience a positive one.
- Know your local equivalent to 911. Who do you call in an emergency?

Patrol Division Activity

February 25 – March 12, 2015

Patrol Division officers responded to hundreds of calls for service and wrote over 170 reports. Patrol officers wrote 81 citations and gave 50 written warnings. They responded to three private property accidents, two major accidents, twelve minor accidents, and seven "hit and run" collisions.

Patrol officers took 21 assault reports, six harassment reports, one terroristic threat report and three reports for criminal trespass. There were three residential burglaries, three business burglaries and four vehicle burglaries reported. Two reports were taken for credit card abuse, two reports for lost/stolen property, two reports for stolen vehicles and thirty-one theft reports. Ten reports were taken for criminal mischief and eight reports for damaged property. Seven disturbance reports and one loud dog report were taken.

Five arrests were made for DWI, one for failure to identify and two for reckless driving. Four people were arrested for public intoxication and two for consumption of alcohol by a minor. Two arrests were made for possession of a controlled substance and four arrests were made for possession of marijuana. Two items were taken in as found property, one juvenile was entered as a runaway and one unattended death was investigated.

On February 25th, an officer stopped a vehicle because the driver was not wearing a seat belt at 6th and King. The driver and passenger were each arrested for Possession of Marijuana, less than two ounces, and for Possession of Drug Paraphernalia.

On February 28th, in the early-morning hours, officers observed a vehicle parked on the frontage road to Highway 77. Officers pulled over to assist and found a couple fighting. The female had a black eye and bloody nose. The male had cuts on his face and was missing teeth. An ambulance was called. The male was transported to the local hospital, then put in jail for Assault. The female was released but will be arrested in the future.

On March 2nd, officers responded to an address on West Mesquite in reference to a disturbance. A female had come home from her boyfriend's house and began looking through her husband's

cell phone. When she found pics of other women, she began to assault her husband. She was arrested.

On March 2nd, officers responded to a grocery store where two females had been detained for shoplifting. The amount of the theft was over \$79 and most of the items were sushi rolls and party supplies. They were both taken to jail and issued trespass warnings.

On March 4th, officers were dispatched to a fast food restaurant for a driver asleep in the drivethru lane. Officers woke the male driver and asked him to perform sobriety tests. He was arrested for DWI and taken to jail, where he provided a breath sample.

On March 6^{th} , an officer had finished assisting with an arrest when he observed a disturbance across the street. An intoxicated male was angry because another male would not move his vehicle. The officer intervened before the intoxicated male assaulted the other male. He was arrested for Public Intoxication. It was also determined that he had outstanding municipal court warrants.

On March 10th, an officer stopped a vehicle for speeding on East Corral. The driver had an outstanding warrant out of Nueces County and was arrested for that Theft warrant. The arrestee contacted a friend who picked up the vehicle.

On March 11th, officers responded to a major accident on Business 77, just north of Sage Road. A male driver possibly fell asleep and left the roadway, striking a tree. He was pinned in the vehicle with broken bones. The driver was eventually flown to a Corpus Christi hospital. While clearing up the scene, a DPS unit was damaged when the Trooper opened his door while a truck was driving past. DPS handled that case.

Six patrol officers received SCBA training while in their SWAT training time.

Several officers have completed their required TML online courses.

Criminal Investigations Bureau Activity Report

Detectives Supervisor assigned 127 cases and inactivated 35 cases as of March 12, 2015th. Along with these cases there were also 2 DWI's and 23 Crash reports.

We have had three stolen vehicle cases during this period in which the vehicles were also recovered. Two of these cases turned out to be civil matters. The other vehicle was located in another county and two subjects are in custody. Always make sure you remove your keys from your vehicles.



For the last couple of weeks, there have been no major events to report. This is a great thing detectives can attempt to catch up. It will only stay quiet for so long.

Detectives have filed 57 cases during this period. There were 19 cases filed in District Court, 27 cases filed in Court, 7 cases filed in City Court, and 4 filed in Juvenile Court.

We have had one detective on FMLA leave, and another detective assisting patrol during their shortage. We are glad to have them back to the team.

The last couple of weeks have actually been mild. Each Detective is currently working a case load of about 50 to 70 active cases.

Our new Detective units have arrived.

Communications Division

The Kingsville Police Department is still having issues with our Radio System. Daily Wells, along with High Man Towers replaced the amplifier on the tower with the new box. Once the amplifier was replaced, we notice the radios were still having problems. Daily Wells found that the lighting arrester now needed to be replaced as well. At this time, they have received the new lighting arrester and are hoping to replace it within a week.

Training:

Lead Telecommunications Operator Marcus Munoz traveled to Clear Lake, TX to get certified as a Communications Training Officer. Mr. Munoz is now in the process of reviewing our training material to improve or replace what we have in place at the moment.

Telecommunication Supervisor Monica Flores and Lead Telecommunications Operator Rosa Munoz-Martinez traveled to Austin, to get some training in Records Management, Emergency Preparedness, and Managing Electronic Records. We will continue the process of maintaining our records properly. We will work together is reviewing our records and dispose of the records that have already met the retention period. We will also review and revise, if needed, our emergency plan to ensure our access to essential records.

On March 5, 2015 the Kingsville Police Department's Street Level Operations Team conducted two separate search warrants for narcotics. The first search warrant took place at 1315 East Senator Carlos Truan #26 for the distribution of marijuana. Trevor Arnold who is 25 years of age was arrested for Possession of marijuana 4 ounces or fewer than five pounds which is a State Jail Felony. Approximately five ounces of marijuana and a digital scale were seized. This narcotics investigation has been ongoing for several months. This was the second search warrant investigation conducted on Arnold; the first was approximately one year ago, also conducted by the Street Level Operations Team.

The second search warrant took place at 1235 East Kleberg Street. John David Zarate who is 42 years of age and Ludivina Garcia who is 35 years of age were both arrested. The subjects were charged with Possession of Controlled Substance Penalty Group #1 (Cocaine) 1gram < 4grams a 3rd Degree Felony, Possession of Marijuana four ounces or less than five pounds a State Jail Felony and Possession of Controlled Substance Penalty Group #3 (Alprazolam/Xanax) under 28 grams. This investigation has been ongoing for several months.

On 03-09-15 the Street Level Operations Team conducted a narcotics search warrant at 219 E Kleberg for the distribution of marijuana. Jacob Garza a 25 year old male was arrested at the residence and charged with Possession of Marijuana > 2oz < 4oz a Class A Misdemeanor and Possession of Drug Paraphernalia a Class C Misdemeanor.

They are analyzing funding and considering options for what they want to do next.

Torres Estates

This is an 11 lot project for single family homes. It is located on the south side of Kenedy between 15th and 16th. Since the action by the City Commission on February 9th, staff has had the oppoortunity to meet with the developer, Mark Dizdar. He has decided that he wants to rezone the property to RP-2. This item is planned for the March 18th Planning and Zoning commission agenda.

La Quinta Hotel

The DRT (development review team) has reviewed the plans for this project. It is located in the area of the Highway 77 Bypass and Sen. Carlos Truan Blvd. It will be an 80 room hotel with a value of \$4.6 million. The DRT met and has approved a full permit for them. The hotel will be located at 2151 S. Highway 77, between Phil Neeson Chevrolet and the Hampton Inn. We do not know yet when they will be breaking ground.

Wells Apartments

Plans have been submitted for this apartment project located at 625 W. Avenue F. There will be eleven-2 bedroom units. The DRT met with the owners recently and discussed issues concerning the plans that they submitted. The team was able to get answers and asked for more information. The owners have since supplied the DRT with the additional information as requested and have been given a full permit in regards to construction of this project.

FEMA Domes

The City has issued a full permit to the contractor, TB Commercial Construction, for starting the work on this project. The project has a value of \$14.4 million. Expected completion date of this project is January 2016.

Wildwood Trails

With the break in the weather the last couple of weeks, they have started on a number of houses in this development. City crews finished the street work recently, which was a part of the economic incentive agreement for this project. The amended plat reducing the front yard setback from 40 feet to 30 feet was recently approved by the City Commission.

Lake View Villas

Even though a preliminary plat was approved in June of 2013 a final plat was never submitted. Because of the time period that has passed the preliminary plat has to be approved again along with the final plat. The street improvement has been completed. This will be on the March 18th agenda for the Planning and Zoning Commission and the March 23rd agenda for the City Commission.

6th Street Corridor Planting Project

Proposals were due to the City in January. This project was about planting approximately 179 trees along the 6th Street Corridor, from the north end to the south end. No proposals were submitted for this project. There is sentiment that the funds for this project be directed toward other beautification initiatives, such as improvements to Corral Park as demonstrated by the pharmacy students at a recent City Commision

meeting. Staff will be putting some numbers together for the Interim City Manager to review.

New City Hall

The Foundation issued a Notice To Proceed to the contractor Rusty Van Fleet Construction which took effect, Monday, January 5, 2015. He will have 330 days to complete the project with an expected completion date of December 1, 2015. At a recent team meeting, it was decided that we would have one meeting a month for construction items and one meeting a month for administrative issues such as pay, etc. These meetings started in January and February, respectively. At the first meeting in January, the work by the city crews for water sewer and storm drainage was discussed. Right now it is intended for city crews to start work on these items by the end of February or March. Work is progessing well on this project.

Joint Airport Zoning Board

This board has start meeting again. The late January, County appointed Chuck Schulz to replace a vacancy left by Anse Windham. The JAZB met in February and reviewed the lighting regulation and the Notice To Buyer form. They also discussed the Schubert pond project which has not been started. Staff will be following up on the Notice To Buyer form and Schubert's pond issue. The City Attorney gave a presentation on the JAZB's organization and authority at the meeting. The next meeting is set for Thursday, March 19th.

TAMUK – Tree Planting

Staff has been working with Dr. Brent Hedquist on the planting of trees at Corral Park. The trees were purchased by TAMUK and planted by his students. The City has been watering the trees since they were planted in February. Staff has also been working with Susan Ivy and Charlie Cardenas on some other improvements for Corral Park in conjunction with some pharmacy students. Dr. Hedquist may plant some more trees there on Earth Eay, April 22nd. We appreciate all of their assistance on this community improvement project.

TAMUK- GSC Building

Staff was approached by the folks there to assist them with an economic development grant application. The grant will be requesting money for the renovation costs of making and improving the office space for the incubator businesses that they hope to originate from the research. Since the City owns the building we will be reponsible for submitting the grant application. At some point this will be brought before the City Commission for approval. University staff will be conducting a student driven research symposium for oil and gas operations, April 23rd at this facility.

Cayetano Villas of Kingsville

This is the proposed tax credit development at the 500 block of General Cavazos. While it was tentatively planned to be on the March 18th Planning and Zoning Commission agenda for a rezoning review. The developers have decided to withdraw their rezoning application until they know for sure if they will receive tax credits for this development. They may know by sometime in May or June.

Flato School Project

The Planning Director, along with Cynthia Martin and Maggie Salinas have met with the folks who are buying this property from KISD. They told us what their tentaive plans are and that they are in the process of hiring an architect to help with the design of what they want to do with the property. They did tell us that they want to keep the main building and turn that into an event center and build apartments on the rest of the ground. Once the transaction is completed, we will do a walk through of the buildings and property with them. We are excited about this project and look forward to be working with them on this endeavor.

Legend's of Kingsville

As you read in the paper recently, they are 100% leased for the school year starting in the fall of 2015. Progress is going well on the rest of the buildings. Staff has been working with Domus Development and a resident on Seale Street pertaining to the fence that will be going up to separate the development and the neighborhood. We met with an engineer for Domus Development this week pertaining to Legends Phase II. The meeting went well. Phase II will have 486 beds with 207 units. They hope to start construction in June of this year. They do plan to do a replat of the final plat which will require a public hearing notice. Once both phases are done, they expect approximately 1,000 students to be living in the apartment complex.

Top 30 Initiative

As the beautification effort of our city continues, the Planning and Development Services Department has implemented a new list of the city's Worst 30. The Worst 30 are categorized in three different categories of ten each. The purpose of this new initiative is to eradicate unsightly and unhealthful property conditions. The first category of ten is businesses that do not have hard surface parking or the parking lot is in disrepair. The second category of ten will focus on unfinished exterior of buildings. The third category of ten will be comprised of various types of property code, building and other violations that are especially intractable and will need the coordinated efforts of various departments. Some, perhaps most, of the Worst 30 will take months or perhaps a year to resolve. The length of time allowed for repairs will depend on the nature of the project and approval by the Planning and Development Services Director.





Food Service Division

Food Service Inspections

Food Service inspections are conducted on a quarterly schedule per year based on the risk category to insure compliance with the Texas Food Service Establishment Regulations and local food sanitation ordinances. Risk levels include low, moderate and high risk. Establishment scoring is based on a demerit system, as per the Texas Food Establishment Rules. There are two types of violations, critical and non-critical. Critical violations are 5 and 4 points demerits per violation and non-critical violations are 3 points demerit violations. Critical Violations are improper practices and actions that directly contribute to food contamination and temperature abuse that may pose a potential risk to the public health, resulting in food borne illness. Critical violations must be corrected immediately or as directed by the Health Department.

Non-critical violations are unacceptable practices that normally relate to the physical condition of an establishment, including equipment, cleaning and storage. Non-critical violations must be corrected before the next routine inspection or as directed by the Health Department.





Call Before You Dig. It's The Law!



Because even relatively minor excavation activities like landscaping or fencing can cause damage to a pipeline, its protective casing, and/or buried utility lines, always contacts your state's One-Call Center before engaging in any excavation, construction, farming, or digging. Most states require two working-days' notice to the One-Call center to allow the utility companies to mark their pipelines and utilities at your proposed digging site. In fact, most serious damage done to pipelines is done when a third party inadvertently excavates, blasts, or drills within a pipeline right-of-way. By contacting the One-Call Center first, this type of damage can be prevented. Sometimes pipeline companies will require a representative to be present to monitor the safe excavation. One easy, free phone call to 811 starts the process to get your underground pipelines and utility lines marked. When you call 811 from anywhere in the country, your call will be routed to your state's One-Call Center. Once underground lines have been marked for your project, you will know the approximate location of your pipelines and

utility lines and can dig safely. More information regarding 811 can be found at www.call811.com.

Winter Walking





Although it generally does not last long, cold weather is once again upon us in Texas. Oftentimes with the cold comes the unforgiving north winds, freezing rain, sleet, and snow that can catch us off guard. Being prepared for winter weather events can reduce injuries and accidents and even save lives. It is critical to create an awareness of hazardous conditions and provide training regarding the proper methods to walk on or around ice and snow. Some important safety reminders include:

- Walk slowly and wear slip resistant footwear. Avoid wearing heels and footwear with slippery soles during ice and snow events.
- Avoid carrying large or bulky items on ice or snow. Wait for the ice or snow to melt or find assistance.
- Be cautious when getting in and our of vehicles. Maintain at least three points of contact (two hands and one foot or two feet and one hand) with a handle, stair/step, or ground.
- Be aware of slippery floors. Use salt or other ice melting methods at entrances to buildings and walk without your hands in your pockets so you can use your hands to grip handrails.

How Time Change Affects Our Health



At 2 a.m. Sunday morning March 8th, we finally recaptured that lost hour of sleep from last March as we marked the end of daylight saving time. And for the 47 million Americans who are sleep

deprived, that extra hour is a chance to literally make up for lost time. The welcome counterpart to the hour of sleep we lose at the beginning of spring, which can take up to a week to adjust to and send those who are already sleep deprived over the threshold of "crashing and burning." In fact, some studies have found a link between the spring-forward clock change and an increase in accidents and heart attacks.

Mold Remediation and A/C System Update

The library recently received encouraging news as remediation efforts slowly begin winding down. On Monday, March 9, 2015, Mrs. Veronica Hare, Kleberg County Insurance Coordinator, informed Library Director Robert Rodriguez that the air samples taken from the building on

Monday, March 2, 2015, came back negative for mold. Mrs. Hare notified Ramos Refrigeration that their technicians had the clearance to begin the next phase of the A/C upgrade. This phase includes installing the new air handlers and dehumidifier, which is expected to take approximately five weeks to complete. Once the new equipment has been installed and a stable air temperature has been maintained, technicians with GCI Remediation (Gerloff Company) will return to complete their remediation services by



disassembling their equipment and returning the library's collection and furniture from offsite locations. While the library is empty and closed, the Library Board feels this is an opportune time to replace the carpet, which was installed in 1978. In those 37 years, the carpet has seen a lot of traffic and is now stained, torn, and lifting up in areas. The library is working with City

and County officials to explore the possibility of replacing the carpet before the library reopens to the public. The library is tentatively scheduled to reopen the latter part of April 2015. To keep the public informed, the library has posted a few pictures of the process on its Facebook page.

Library Outreach Programs Continue

The library's outreach coordinator and members of staff had an opportunity to visit with local students at a recent community events, the *South Texas Career Expo* on March 6, 2015, at the J. K. Northway Exposition Center. Library staff was on hand to answer questions and provide



brochures about the library's online services to students, their parents, and educators. Over 500 visitors stopped by the library's outreach table to visit with staff and learn more about the library's services. The library's next outreach is the *Dual Credit Enrollment Meeting*, on Tuesday, March 24, 2015, at H.M. King High School from 6:30-7:30 p.m. That event is followed by the *County Wide Eggstravaganza* on Saturday, March 28, 2015, on the Kleberg County

Courthouse grounds from 2-4 p.m. The bookmobile's *Library on the Go* staff will be on hand for these events. January 2015 - 27 prescriptions filled under this program used by a total of 14 individuals for a monthly savings of \$ 245. The average price savings was \$9.09 per prescription which translates to a 18.1% savings on prescriptions.

The driver was identified as a Hispanic male from Harlingen, Texas. The substance was field tested and identified as Methamphetamine. The weight of the contraband was 2.2 lbs. which equals 1 kilo – approximate street value of \$28,000.00. The subject was booked and incarcerated in the Kleberg County Jail without incident. The commercial truck and tanker trailer were released to the registered company.






KTF Administration Hosts Appreciation BBQ for Its Employees


Annual Audit

Utility Billing Division



The month of March is water conservation month so the staff at Utility Billing would like to provide you with the following tips for saving water and money:

Kitchen

- Plug up the sink or use a wash basin if washing dishes by hand.
- If you use a dishwasher, make sure it is fully loaded before you turn it on.
- While you're at it, scrape that plate instead of rinsing before loading it into the dishwasher.
- Keep a pitcher of drinking water in the refrigerator instead of letting the faucet run until the water is cool.
- Thaw food in the refrigerator overnight rather than using a running tap of hot water.
- Add food wastes to your compost pile instead of using the garbage disposal.
- When washing dishes by hand, don't let the water run. Fill one basin with wash water and the other with rinse water.
- Dishwashers typically use less water than washing dishes by hand. Now, Energy Star dishwashers save even more water and energy.

- If your dishwasher is new, cut back on rinsing. Newer models clean more thoroughly than older ones.
- Designate one glass for your drinking water each day, or refill a water bottle. This will cut down on the number of glasses that need washing.
- Soak pots and pans instead of letting the water run while you scrape them clean.
- Wash your fruits and vegetables in a pan of water instead of running water from the tap.
- Install an instant water heater near your kitchen sink so you don't have to run the water while it heats up. This also reduces energy costs.
- Cook food in as little water as possible. This also helps retain more nutrients.
- Select the proper pan size for cooking. Large pans may require more cooking water than necessary.
- If you accidentally drop ice cubes, don't throw then in the sink. Drop them in a house plant instead.

Customer Service Representatives

The staff at Utility Billing have to deal with answering the phones, taking payments, applying mail payments, answering customers' questions, addressing customer issues, and other miscellaneous duties. Some of these duties are time sensitive especially on disconnect days; Tuesdays and Thursdays. The Customer service representatives include Gina Salinas (1st window), Elvia Rodriguez (2nd window), and Worthie Gonzales (3rd window, Monday, Wednesday, and ½ day Friday). All are ready to assist customers with their needs.

Many times the Customer service representatives have to multi-task to get the job done. This is not uncommon. Many of the staff have years of experience in dealing with customers. We have two billing specialists in the department. Erica H. Bruce handles Utility Billing and Aileen Escamilla handles the Account Receivables Billing. Aileen Escamilla also works the third window on Tuesdays, Thursdays, and ½ day on Friday. All the staff is assigned additional duties and is knowledgeable in their field.

Staff is ready to assist you from Monday-Friday, except holidays between the hours of 8:00 a.m. and 5 p.m. The department is open during lunch hours. Staff is happy to assist you over the phone as well by calling 361-592-5281.

Reminders: Any payments dropped off in the night drop need to be in check, money order, or cashier check form. A utility bill stub should be included in order to process your payment to your account or a referenced service address and account number will suffice. If you are in jeopardy of having your services disconnected for non-payment on Tuesday and Thursday, then your payment in full, including penalties, needs to be dropped off before 8 a.m. that Tuesday or Thursday to avoid a disruption in water service as well as additional penalties. This information is also listed on the red notices. ***no temporary checks accepted***

All roll outs must be out by 7 a.m. for trash pickup. Once your roll out has been serviced, it must be removed immediately from the curb or street and moved out of public view.

I just got a traffic ticket. Now what do I do?



Do I Have To Appear In Court?

The law requires you appear in court on your case. You must appear either in <u>person or by attorney</u>, within ten days after receiving the traffic ticket.

** A TELEPHONE CALL IS NOT A MANNER OF COURT APPEARANCE**

What If I Am A Juvenile?

The Municipal Court has jurisdiction over juveniles, 16 years or younger, charged with Class "C" misdemeanor offenses except public intoxication. All juveniles are required to appear in open court for all proceedings in their cases, along with the parent or guardian of the juvenile. Juveniles who fail to appear or who fail to pay their fine will be reported to the Department of Public Safety. The Department of Public Safety will suspend your driver's license. If you do not have a driver's license you will not be able to obtain one until you appear in court to dispose of the case.

Special Notice to those under age 17:

Article 45.057(h) of the Texas Code of Criminal Procedure states, in part:

A child and parent required to appear before the court have an obligation to provide the court in writing with the current address and residence of the child. The obligation does not end when the child reaches age 17. On or before the seventh day after the date the child or parent changes residence, the child or parent shall notify the court of the current address in the manner directed by the court. A violation of this subsection may result in arrest and is a Class C misdemeanor. The obligation to provide notice terminates on discharge and satisfaction of the judgment or final disposition not requiring a finding of guilt.

Can I Take a Driving Safety Course or Deferred Disposition (over 25 of age)?

If you are charged with a "moving" traffic offense and <u>do not hold a CDL</u>, you may ask the Judge, within 10 days after receiving the ticket, to take a Driving Safety Course or file a motion for Deferred Disposition. If you were operating a motorcycle and request to take a Driving Safety Course you may take a motorcycle operator's training course. At the time of either request you must do the following:

- 1. Present a copy of your valid driver's license;
- 2. Present a copy of your current vehicle insurance policy.
- 3. Plead either guilty or no contest; and
- 4. Pay court costs, administration fee (exception on the deferral request) and post a cash bond for the fine up of to \$200.00 dollars; for offenses committed in school zone an additional \$25.00 dollars is required.

Prosecution of the traffic offense will be postponed for 90 days to allow you time to complete the course or comply with the Deferral order.

**You are required to attend a Driving Safety Course approved by the Texas Education Agency or a motorcycle operator's course approved by the Department of Public Safety and present the completion certificate within 90 days, and provide to the court a Texas Department Driver's License Report, and file an sworn affidavit of compliance for the Driving Safety Course or the Deferral court order. **

You are eligible to request this course only if you:

- 1. Have not requested and taken a driving safety course for a traffic offense within the last 12 months.
- 2. Are not currently taking the course for another traffic violation;
- 3. Have not committed the offense of speeding 25 mph or more over the speed limit; and
- 4. Have not committed one of the following offenses:
 - a. Accident-damages and or injuries;
 - b. Leaving the scene of an accident;
 - c. Failing to stop/render aid;
 - d. Failure to report an accident;
 - e. Reckless driving;
 - f. Overtaking and passing a school bus;
 - g. Fleeing or attempting to flea a peace officer.

If you fail, within 90 days, to provide proof you have completed the Driving Safety Course Court Order you will be required to: 1) Request a hearing before the court, and 2) Forfeiture of the fine amount, which will result in a conviction. In addition, the conviction will be reported to the driver's license division of DPS. Failure to be present at the hearing will result in a Failure to Appear charge being filed and a warrant being issued for your arrest.

What Are My Options?

Under our American system of justice all persons are presumed to be innocent until proven guilty. On a plea of not guilty a formal trial is held. The State is required to prove guilt of the

offense charged in the complaint "beyond a reasonable doubt" before a defendant can be found guilty by a judge or jury.

Right to Appeal

In certain circumstances, you have the right to appeal <u>a conviction</u> in Municipal Court. All appeals from Municipal Court result in a new trial in County Court. A bond is required to be posted which is <u>valued</u> at twice the amount of fines and costs assessed by the city court.

How Much Will It Cost Me?

This is a current list of fines, including court costs, for some of the most common offenses. The fines for other offenses are available by contacting the court.



Purchasing Department

Purchasing/Technology Department was busy with RFP openings for Executive Search Firm for City Manager position, BID opening for Centrifuge sludge de-watering system and evaluation of said BID. Staff should be prepared to pay \$7.00 at the inspection site and \$7.50 +\$1.00 (processing fee) total of \$8.50 at the Title Dept. This is for all City Vehicles and City Trailers. Technology Division Golf Course Cabling

In order to better facilitate the new layout of the golf course club house, Technology staff moved the existing cabling to the new location. They consolidated the number of network devices and provided POE switching for future expansion of wireless or cameras. Technology staff also identified the current location of all telephone and internet lines. They hope to have everything in working order when the new flooring is installed to avoid down time for the Golf Course Staff.

Test Site for New Application Control Software

In order to deal with future threats we are evaluating products that provide more robust defense against malware and viruses.

We have begun the testing phase of a new application control software that will enable Technology staff to more adequately address new and evolving threats to the network and functionality. The current test system is provided by a reputable player in the software and security market. It has the ability to limit and control the amount of installed applications on a computer. This has many advantages. Firstly, it provides us the transparency needed to see what is installed on the network and if compliance is met. Secondly, it acts as antivirus anti-malware stopping threats as they occur in real-time. Some of the key features of the product include:

- Security architected from the ground up to reduce the hassles of managing complex environments
- Unified security control across virtualized, physical, and mobile endpoints
- Delivered as a virtual appliance for simple turn-key deployment
- Built in redundancy and scalability
- Security management integrated with Active Directory, VMware vCenter, and Citrix XenServer

This endpoint protection solution performs remote installations, administers policies, creates reports and provides alerts for critical incidents. It can manage remote workstations and apply policies to unconnected PCs. It can scan emails, downloads and chat conversations for malware. It also includes a two-way configurable firewall. Administrators can control how employees interact with the internet by applying filters, blocking websites and controlling time spent online.

Staff can create a rule to block information shared by email using the software's filtering rules. The software also includes identity control tools via rules, which Technology staff will have to configure. These rules can lock down information such as credit card numbers, names, and Social Security numbers.

VDI

VDI or Virtual Desktop Infrastructure provides a secure, safe expandable method to application delivery. It shares a host computer on a network resource and provides better access and accountability. This type of technology is commonly used in banks and other kiosk where full computer access is not necessary or can cause compliance risks.

Technology staff has begun the research and deployment of VDI environment for the cashiers in the cash collections area. This will allow for more flexibility in the coming move from the existing city hall building to provide services across sites. Additionally, it will aid in ensuring that full compliance is met by those computers. The VDI currently being reviewed is called Xen Desktop provided by Citrix.


