The Commission met together with the Kleberg County Commissioner's Court in a workshop to discuss the budgetary agreements for Fiscal Year 2000-2001.


The budgets for the parks, library and health departments were discussed as well as City services.

2. CITY MANAGER'S REPORT. (CITY MANAGER).


No report was given at this time.
