A motion was made by Commissioner Garcia and seconded by Commissioner Laskowski to establish the property tax rate at \$0.70145 for the purposes of notices and publications in accordance with the Texas Property Tax Code. The motion passed by a 3/2 vote. Commissioner Pecos and Mayor Esquivel cast the dissenting votes.

Another motion was made by Commissioner Villarreal and seconded by Commissioner Laskowski to set and schedule the public hearing for August 30, 2001. The motion passed by a 4/0 vote. Commissioner Garcia was not present for the vote on this item.
