I. PRELIMINARY PROCEEDINGS.

OPEN MEETING:

City Commissioner Rene "Mr. V" Villarreal led the Commission and members of the audience in an invocation. Immediately thereafter, Mrs. Carolla Serrato, Executive Director of the South Texas Water Authority, led the Pledge of Allegiance.

IV. PUBLIC COMMENT ON AGENDA ITEMS.

1. COMMENTS ON ALL AGENDA AND NON-AGENDA ITEMS.

Mrs. Serrato, Executive Director of the South Texas Water Authority, addressed the Commission regarding item number two on the agenda. She stated that the Water Authority has submitted a counter proposal to the Commission for their consideration. She requested that the Commission give consideration to the proposal.

Mr. Oscar Castillo, Board President of the South Texas Water Authority, also addressed the Commission regarding the same item. He stated that the counter proposal is an attempt to fulfill their current obligations. Mr. Castillo stated that they are relying on the City of Kingsville to purchase 40% of water.

V. ITEMS FOR CONSIDERATION BY COMMISSIONERS.

1. <u>EXECUTIVE SESSION</u>: UNDER SECTION 551.071 OF THE TEXAS OPEN MEETINGS ACT, THE CITY COMMISSION SHALL CONVENE IN EXECUTIVE SESSION TO SEEK LEGAL ADVICE FROM THE CITY ATTORNEY REGARDING POTENTIAL LITIGATION REGARDING ADMINISTRATION AND ENFORCEMENT OF CITY OBLIGATIONS UNDER THE SOUTH TEXAS WATER AUTHORITY SUPPLY CONTRACT. (CITY ATTORNEY).

The Executive Session began at 6:10 p.m. and ended at 7:50 p.m.

The Commission reconvened into open session.

2. CONSIDER AUTHORIZING THE CITY MANAGER TO TAKE ANY AND ALL NECESSARY STEPS TO PROTECT THE INTERESTS OF THE CITIZENS AND RATEPAYERS OF THE CITY OF KINGSVILLE IN THE WATER SUPPLY CONTRACT WITH THE SOUTH TEXAS WATER AUTHORITY. (CITY MANAGER).

A motion was made by Commissioner Stanley Laskowski and seconded by Commissioner Arturo Pecos to reject the South Texas Water Authority proposal because the proposal exceeds the amount the City of Kingsville budgeted for water purchase from South Texas Water Authority, and authorize the negotiating committee to continue discussing any counter proposal presented by the South Texas Water Authority Team. The motion passed by a 4/0/1 vote. Mayor Esquivel abstained from voting

Another motion was made by Commissioner Laskowski and seconded by Commissioner Pecos to authorize the City Manager to solicit proposals for professional services for establishing water rates for surface and ground water sources, and pass through costs for South Texas Water Authority. The motion passed by a 4/0/1 vote. Mayor Esquivel abstained from voting.
