#### OPEN MEETING:

Mrs. Dora Byington, Director of Purchasing, led the Commission and members of the audience in an invocation. Immediately thereafter, City Commissioner Horacio (Hoss) Castillo led the Pledge of Allegiance.

1. <u>COMMENTS ON ALL AGENDA AND NON-AGENDA ITEMS.</u> There were no comments made at this time.

### V. ITEMS FOR CONSIDERATION BY COMMISSIONERS.

1. <u>CONSIDER AUTHORIZING THE CITY MANAGER TO ENTER</u> INTO A PROFESSIONAL ENGINEERING SERVICES AGREEMENT TO RENDER CERTAIN SERVICES IN CONNECTION WITH THE 2001 <u>TEXAS CAPITAL FUND INFRASTRUCTURE GRANT PROJECT</u>, CONTRACT #721092. (CITY MANAGER).

A motion was made by Commissioner Arturo Pecos and seconded by Mayor Filemon "Phil" Esquivel, Jr. to discuss this item at this time.

Mr. Hector M. Hinojosa, City Manager, stated that the staff members that had previously ranked the proposals submitted by the engineering firms, have specified that their ranking is the same as previously ranked, with Alpha Engineering receiving the highest score. Upon a question raised by Commissioner Charles E. Wilson, Mr. Hinojosa responded that he is basing his recommendation to award the proposal to Alpha Engineering as staff has recommended.

A motion was then made by Commissioner Pecos and seconded by Mayor Esquivel to authorize the City Manager to enter into a professional engineering services agreement with Alpha Engineering to render certain services in connection with the 2001 Texas Capital Fund Infrastructure Grant Project, Contract #721092. The motion passed by a 3/1/1 vote. Commissioner Al Garcia cast the dissenting vote and Commissioner Horacio (Hoss) Castillo abstained from voting.

2. <u>CITY MANAGER'S REPORT. (CITY MANAGER).</u>

2.1 UPDATE ON BUDGET PROCE3SS FOR FISCAL YEAR 2002-2003 ANNUAL BUDGET.

Mr. Hinojosa stated that he has met with Department Heads and Supervisors regarding the proposed budget. He stated that the proposed budget will be a tight budget.

Mr. Hinojosa also stated that Mr. Tomas Sanchez, Emergency Management Coordinator advised him that a grant was recently awarded to the Kleberg County Emergency Management Department for the installation of a radio transmitter antenna in Rivera.

(CITY ATTORNEY).
