Commissioner Pecos made a motion to approve the minutes, seconded by Commissioner Castillo. The motion was passed 5/0.

II. Public Hearing - (Required by Law).1

1. Public Hearing for an alcohol variance application for Kiddo's Pizza located at 2021 South Brahma Boulevard. (Interim City Manager).

Commissioner Castillo made a motion to approve the variance, seconded by Commissioner Garcia. The motion passed 4/1, with Commissioner Wilson voting "Against".

3. Consider approval of an alcohol variance pursuant to §11-3-5 of the Code of Ordinances for on-premise consumption to allow the sale of alcoholic beverages for a restaurant / food establishment dba as Rancho Grande Bar & Grill, located at 2209 South Brahma Boulevard. (Interim City Manager).

Commissioner Pecos made a motion to approve the variance, seconded by Commissioner Castillo. The motion passed 4/1, with Commissioner Wilson voting "Against".

4. <u>Consider awarding bid for annual contract for road materials.</u> (Bid #24-05) (Director of Purchasing).

Commissioner Pecos made a motion to approve staff recommendation, seconded by Commissioner Garcia. The motion was passed 5/0.

9. Discuss and consider action on collective bargaining negotiations and contract between the City of Kingsville and the Kingsville Professional Fire Fighters Association Local Union #2390. (Director of Human Resources).

Commissioner Wilson made a motion to extend contract as is until new contract is approved, seconded by Commissioner Castillo. The motion was passed 5/0.
