Mr. Luke Womack addressed the commission. He stated a freeze on spending and hiring was put in place at the request of the interim city manager for the next 15 to 30 days to assess this year's budget. He stated sales taxes have decreased, along with water revenues due to the recent rains, as did fines and ambulance revenues. Overall, we are looking at a shortfall of around \$270,000.

He stated the upcoming fiscal year will be most challenging as sales taxes are down throughout the state and the City is losing \$200K from Celanese as they decreased their payment from \$300K to \$100K. He stated new personnel and the capital outlay are in excess of \$1.5M and that we need to keep expenses in line with previous years in order to find \$600K in lost revenues.

1. Consider authorizing letter to the Governor's Office Criminal Justice Division for approval to utilize all assets and

# unexpended funds for continued efforts at narcotics enforcement until those funds are exhausted. (City Attorney).

Mrs. Alvarez stated she recently spoke with Mr. Tim Nowell, Director of the Criminal Justice Department to determine asset distribution. On June 27, 2003 the City received a letter indicating the CJD would award the Chapter 59 funds to the Kingsville Police Department as the STNTF grant was not renewed. Mrs. Alvarez stated if the City is interested in continuing their efforts and wants to maximize the amount of dollars, then the City would be wise to go ahead and send a letter to them requesting approval to utilize all assets and unexpended funds for narcotics enforcement until funds are exhausted. Mayor Esquivel asked the city attorney to assist Mr. John Garcia in drafting a letter requesting the CJD to reconsider our request for renewal of the South Texas Narcotics Task Force grant.

A motion was made by Commissioner Garcia and seconded by Commissioner Wilson authorizing staff to send a letter to the CJD to utilize all assets and unexpended funds for the continuation of narcotics enforcement until all funds are expended. Motion carried, 4/0.
