- 1. Motion to approve final passage of an ordinance amending the zoning ordinance by changing the zoning map in reference to 2.47 Acres out of Christopher Addition, Lot C from "I-1" Light Industrial to "C-4" Commercial District, applicant T.J. Dobson. (Public Works Director).

Motion to approve a resolution of the City of Kingsville City Commission requesting the members of the 80<sup>th</sup> Legislative Session of the State of Texas support increased funding for the Texas Recreation & Parks Account Local Park Grant Program and the Texas State Park System. ### **CONSIDERATION OF MOTIONS, RESOLUTIONS, AND ORDINANCES:**

- VI. Items for consideration by Commissioners.4
  - 3. Consider authorizing the City Manager to enter into an Interlocal Cooperation Contract between the Texas Department of Public Safety and the City of Kingsville to enhance border security along the Texas-Mexico border. (Police Chief).

Chief Ricardo Torres stated that the Kingsville Police Department has been asked to participate in this project, Operation Wrangler. He stated there will be five phases; this agreement is for the first step, Operation Wrangler #1 for the target date of January 22<sup>nd</sup> through 29<sup>th</sup>. He stated two officers on overtime will participate for a 24 hour period during the length of the particular operation. The Department of Public Safety will reimburse certain operational expenses incurred by the City of Kingsville Police Department. These expenses will include overtime for two officers assigned to this operation as well as overtime for an additional dispatcher and reimbursement for fuel cost at the rate of .445 cents per mile. This is a reimbursement grant which should be reimbursed in 30 to 45 days if all paperwork is processed correctly. He stated officers will be doing criminal interdiction for illegal aliens, narcotic trafficking, and US Currency. He stated that any seizures will be kept by his department and will follow the department's normal process for those seizures. He stated that multiple officers will be assigned to this project and will not be taken away from providing services to the citizens of Kingsville.

Mayor Pro-Tem Wilson announced Mayor Fugate's arrival at 10:37 A.M. At this time, Mayor Fugate presided over the meeting. Chief Torres provided an overview of the agenda item for the Mayor. Chief Torres stated that it is unknown if it is going to be inclusive of other operation dates or a separate contract for each particular grouping of dates. He stated that each will be brought to the Commission for their consideration.

Mayor Fugate called for any other questions. Commissioner Garcia made a motion to enter into this agreement, seconded by Commissioner Pecos. The motion was passed and approved by the following vote: Fugate, Wilson, Laskowski, Pecos, Garcia voting "FOR".
