I. Preliminary Proceedings.

OPEN MEETING

Mayor Fugate called the meeting to order in the City Commission Chambers at 11:32 A.M.

Mayor Fugate announced he would like to waive all preliminary proceedings, if there were no objections. He then proceeded to the section "Minutes of Previous meeting".

INVOCATION / PLEDGE OF ALLEGIANCE – (Mayor Fugate)

MINUTES OF PREVIOUS MEETING(S) - Required by Law

Mayor Fugate called for consideration of the minutes of the regular meeting of Monday, October 11th and special meeting of Tuesday, October 19th, 2010. Commissioner Laskowski made a motion to accept the minutes, as presented, seconded by Commissioner Wilson. The motion was passed and approved by the following vote: Fugate, Garcia, Pecos, Wilson, Laskowski voting "FOR".

III. Reports from Commission & Staff²

"At this time, the City Commission and Staff will report/update on all committee assignments which may include, but is not limited to the following: Planning & Zoning Commission, Zoning Board of Adjustments, Historical Board, Housing Authority Board, Library Board, Health Board, Convention and Visitor's Bureau, Chamber of Commerce, Coastal Bend Council of Governments, Conner Museum, Keep Kingsville Beautiful, and Texas Municipal League. Interim City Manager Alvarez announced the City Secretary advised that the Charter Amendment Election results will be posted tomorrow on the City's and County's website; the County will canvassing on the 10th and the City would like to have a special noon meeting to do the same; provided a weather update; and reminded Staff about the time change on Saturday night. She reported that the City engineer advised there are nineteen (19) Engineering

Department students and their professor will visit the landfill; she thanked all volunteers that helped during the Halloween events; provided an update on City positions that are available; the landfill working on methane gas remediation so the west entrance will be used; and on street lights being upgraded by AEP with additional expense on energy consumption.

Commissioner Pecos voiced his concern on citizen complaint regarding street lights being on during the day and off during the night. There was a brief discussion on street lighting.
