

## Public Works

### Street maintenance fee leads to continuation of street improvements

Although the Street Maintenance Improvement Fee is new to the City of Kingsville in 2016, our current Street Maintenance Improvement Program (SMIP) has been ongoing since 2013.

In 2013, the City of Kingsville Public Works department started a 20 year program to address the potholes and failing streets. Many questions arose leading up to the development of the program such as: Which streets do we do first? Should the work be contracted out or done by City staff? If so, does staff have the appropriate equipment? And more importantly, how are we going to fund fixing our streets?

Engineering staff evaluated every street in Kingsville and gave a score to each block of street. The score is called a "Pavement Condition Index" (PCI) and ranges from 0 to 100, 100 being the best condition. Streets were then broken down into categories based on the score, "good" (100 – 76), "fair" (75 – 51)

and "poor" (50 – 0). In order to control the amount of work and be flexible in which streets would be fixed, it was decided that in order to be more efficient and maximize money available to use city equipment and city work crews. Additionally, engineering staff would perform construction quality control, inspections and surveying. In 2013, funding was available to begin the program through Certificate of Obligation Funding, which is a mechanism in which the City incurs debt. In 2013, 29 blocks (2 miles) were completed by city crews and equipment. In addition to street improvements, when streets were being reconstructed the City also addressed underground utilities and street curb and gutter, which help with drainage.

After 2013, the program was evaluated and it was determined that the production rate was not sufficient since it was calculated that the failing rate of a street in Kingsville (the rate where a "fair" street drops



to a "poor" street) was 26 blocks (or 2 miles) per year. Therefore, better equipment was purchased in order to increase production to 40 blocks (3 miles) a year. Equipment included: a surveying total station, oil distributor, asphalt laydown machine and a pad foot roller for lime stone compaction. The production rate would be in line with the SMIP program, where the "poor" streets in Kingsville will be fixed in 10 years, and all streets would be addressed and maintained in the 20 year cycle. Consequently, in 2014, city crews fixed 49 blocks (3.75 miles) of street, surpassing the estimated rate of 40 blocks per year.

In 2015 city crews completed 46 blocks (3.5 miles), once again surpassing the calculated average of 40 blocks a year. Throughout 2015, however, the City began thinking of ways to ensure funding was available for the life of the improvement plan since the original dollars allocated from Certificate of Obligations were running out and it was estimated that beginning in 2016 that money would run out. The funding need was estimated at a little over \$1 Million a year for the next 18 years (two years into the SMIP program), so throughout 2015 the City worked on developing the Street Maintenance Improvement

Fee to take effect January 2016.

The city started collecting the fee in February of 2016. Now that the funding source has been established and is being received, city crews will continue to produce street construction and improvements.

Since the implementation of the overall program in 2013 the City has fixed over 130 blocks which equates to nearly 9 miles. This doesn't account for the work that the City of Kingsville has coordinated with the Texas Department of Transportation (TXDOT) to do within our community within the same three year period. Those road

enhancements included:


- King Ave (from US 77 to Santa Gertrudis)
- 14th Street (from Corral Street to General Cavazos)
- General Cavazos (from 14th Street to 6th Street)
- Brahma Blvd/ FM 1717 (From General Cavazos to US 77)
- University Blvd (From King Street to Santa Gertrudis)
- Corral Street Seal coat (From US 77 to Armstrong Street)

Overall, once we include the TXDOT coordinated improvements, in the last three years 20 miles have been fixed. The map shows the areas that have been completed as well as the ones scheduled to be completed for the rest of 2016, including improvements to 6th Street which are being funded through Certificate of Obligation Funding the City recently approved.

## Housing in Kingsville primed for record growth

The City of Kingsville has seen an increase in residential growth that it hasn't seen in quite a while. As an example in 2015 there were 45 building permits issued for new residential housing. As of this calendar year we are at 18 permits for residential housing which if we stay on that track or near it we could have 72 building permits issued in 2016. Just five years ago, as noted in the bar graph above, the new houses being constructed in Kingsville were in the single digits. There are three developments in Kingsville that can fit most if

not all of the markets for home affordability, they are: Wildwood Estates, Lake View Villas and Torres Estates. Recently, Paulson Falls Subdivision was built out. Part of the City's push for increased housing options has been a conscious effort to make new homes at varying prices available so that more people have the option to purchase a new home.

Along with growth in single family residential homes there has also been increase in multifamily units (apartments). This growth coincides with the growth in the

community, particularly the growth at Texas A&M University as well as an increase in people who work in Kingsville and are choosing to live closer to work. Both residential and multifamily (apartments) help the City address its leakage problem. The City estimates that 3,500 people work in Kingsville and do not live in Kingsville. Improving

housing options is one factor that helps the City retain individuals and families in our community. More people living in Kingsville results in an increased tax base which then leads to improved City services.

The aforementioned growth only includes the increases in residential housing options within the City limits but there is also residential

growth occurring outside our City limits that also helps our community overall since these individuals shop and dine within our City limits.

# New ordinances, plans for Downtown

The first quarter of 2016 has marked the beginning of some rather large and positive changes that bode well for our downtown district. These include ordinance changes designed to create positive change downtown, money for infrastructure improvements, a newly revitalized Main Street Board and a possible fresh start for the Texas Theater renovation. It has brought some not so dramatic but important changes to the face of downtown. There are new businesses downtown - King Barber, Live2Dance Studio, Krafts N Beads, Mindless Ink and two businesses that have expanded Salon de Lis and Downtown Divas. And it has seen the first birthday of what has become a downtown staple - the Kingsville Farmers

Market.

### DOWNTOWN VISION PLAN

The City of Kingsville will undergo the development of a Downtown Vision Plan that will assist with overall Downtown revitalization efforts. The Vision plan will help identify, not only, infrastructure improvements but strategies on redevelopment.

### KINGSVILLE MAIN STREET RECEIVES TEXAS CAPITAL FUND GRANT

The City was awarded a \$58,000 grant to fund construction of handicapped ramps at each corner of 8th and Kleberg and replace 150 ft. of the worst section of sidewalk and curbing in the entire downtown district. The city is providing \$22,300 in matching funds about

1/3 of which is in-kind donations in the form of engineering services. Construction is set to begin in the next few months.

### KINGSVILLE MAIN STREET ADVISORY BOARD

A newly refreshed Main Street Advisory Board is providing valuable advice to city staff by sharing their vision and insight and their time and talent to create a better downtown. The group consists of general community members as well as downtown property owners. The group has weighed in all changes that would affect the Main Street District such as the proposed ordinance changes and the proposed expansion of the Main Street District along West Kleberg Avenue to the new City Hall.

### CITY TAKES AIM AT VACANT UNDERUTILIZED BUILDINGS DOWNTOWN

City staff has proposed two new ordinances that aim at resolving issues with vacant and underutilized buildings in our downtown. One is a vacant building ordinance that would no longer allow the boarding up of windows, asks that the exterior and interior of the building be kept free of accumulations of junk and trash and that parking areas behind the buildings be kept in good condition, and any landscaping be maintained. The downtown living ordinance opens the door for the creation of living spaces above businesses and the practice of the shop owner living in the back of

or on top of their business. Vacant buildings, besides being a drain on the economy, if not properly maintained can hurt adjacent businesses and pose a safety threat. Buildings with boarded up windows send the wrong message to potential investors and visitors. Loft living could fill the vacant second floors of downtown buildings and fill the downtown streets with more people increasing demand for downtown goods and services and overall increasing the vitality of Downtown.

## TEXAS THEATER

The historic Texas Theater is up for sale. A much loved local landmark, the theater sat vacant before being purchased in May 2013 and restoration begun. To assist with

the sale of the theater the city is partnering with the Texas Historical Commission to develop a feasibility study for the project. Many people would love to see the Texas Theater restored to save its history, the key to success for the project is having a clear vision of the final project, how it will be programmed and operated and a plan of action to get there. Research is key. The feasibility study will provide a market analysis of the property, a program analysis to guide decisions about theater's use and make operating recommendations. The restoration of this downtown landmark has not only the potential to benefit the community but to be an economic engine as well.

Participants will walk from the courthouse down Yoakum to the KISD offices at 3rd & Henrietta where they will be rewarded for their participation with free BBQ, live music, bouncy houses and free games and prizes. The annual walk is a show of support for those youth who choose to say no to drugs and remain drug free.

## KINGSVILLE FARMERS MARKET

The Kingsville Farmers Market celebrated their first birthday last month by giving out several baskets of fresh produce, jams & jellies and other items donated by

market vendors. The market is held the fourth Saturday of every month from 9 am – noon at the downtown Pavilion. The number of vendors

is growing and there is an amazing variety of foods and crafts for sale. Cooking demonstrations and live music add to the fun.



# Parks & Recreation Ready for Spring!

The City of Kingsville is in the second year of managing the Parks within the City limits of Kingsville. Since the City took over in October of 2014 the City has made it a priority to invest dollars into the improvement of Parks. That continued this year when the City Commission approved utilizing 2.3 Million for Park Improvements out of the Certificates of Obligation

Funds they recently approved. This funding will be spent on improvement projects to include repairs to the Pier in Dick Kleberg Park, athletic field improvements, building improvements and significant work on the streets and parking areas in Dick Kleberg Park and neighborhood parks.

Priorities for 2016 include continuing the improvements at

Brookshire Pool prior to the 2016 Pool Season. Last year a new metal roof was installed on the pool house and chemical building with funds from the City's Park Budget. This year the City has already addressed some leakage issues and currently we are reviewing options for new surfacing, tile, depth markers and shade structures. Additionally, 2016 will see the preparation of a revised Master Plan for Parks which will qualify the City for grant funding with Texas Parks & Wildlife and guide us through budgeting for improvements and additions to the Parks System. The City selected a Parks Master Planner this month and more information will be made available through the newspaper when the plan is finalized which will include dates and times for community input. The City currently has a survey available online, if you wish to participate in this input process electronically. This survey will be taken into account as part of this year's Parks Master planning process.

## Additional Park Updates

### Spring Leagues:

Kingsville Parks & Recreation is preparing athletic fields for spring leagues which kick off in April. Boys & Girls Club of Kingsville will host Little League Baseball, Thunder Girls Softball League will host Pony Girls Softball, Kingsville Youth Soccer Organization will host youth soccer and the Adult Softball League is preparing to start a spring league, potentially, under new management. We would like to thank the approximately 75 volunteers from Texas A&M Kingsville came to Dick Kleberg Park in March to offer assistance in preparing the field for spring leagues.





# Partnerships helping to increase animal adoption

The City-County Health Department has been experiencing some wonderful and exciting changes lately. Our most exciting changes have been our ability to increase our adoption and rescue rates. In fiscal year 2010-2011 236 dogs were reclaimed by owners, 172 dogs were adopted and 17 dogs were rescued. This past fiscal year 2014-2015 we had 297 dogs reclaimed, 262 dogs adopted and 316 dogs rescued. This is a major improvement for the City-County Health Department. More people as of late have been adopting dogs from the Animal Control Center. A big factor has been our ability to work with 501 C (3) rescue groups in rescuing dogs from our shelter. Our rescue rates have increased tremendously.

Our greatest asset is our website,

which has allowed us to showcase our dogs with a picture and a brief description of our animals available for adoption or rescue. It also serves as a searching tool for those individuals who might have lost their pets. The website has a lost & found section where all impounded animals are posted. This feature will help reunite animals with their owners, if the pets happened to get impounded by the City-County Health Department/ Animal Control. The website also has a section for livestock animals that are impounded. Not only can individuals see what dogs and cats are up for adoption, they can also see our schedule of fees; for adoptions, impoundment and daily impoundment boarding fees and other animal related fees. You can come by the City-County Health Department Animal Control Center Monday through Friday between the hours of 9:30 AM to 11:30 AM and 1:00 PM to 4:30 PM. We also will be opening the first or second Saturday of every month sponsoring our monthly pet adoption day, animal releases, rescues and for any other animal control related issues. The Center will be open from 9:30 a.m. to 1:30 p.m. Come by and see our variety of dogs, puppies, cats and kittens waiting to be adopted and have a second chance at life in a forever home! Our remaining monthly schedule is as follows:

Adoption fee is \$25.00 (dogs) and \$20.00 (cats) and a \$20.00 refundable vaccination fee.

Dates and times are subject to change. This event allows potential adopters and rescue groups the opportunity to adopt and rescue animal on the weekend. Besides our monthly pet adoption day, the Animal Control Center has joined forces with our local Tractor Supply Company to co-sponsor a quarterly pet adopting event at our local Tractor Supply Company located at 2405 S. Brahma Blvd. This joint venture allows us to go out into our community to present some of our dogs and cats up for adoption and rescue. It's a great opportunity for the City-County Health Department/ Animal Control Center employees to interact with citizens from our great community and speak to them about the benefits of adopting a sheltered animal. Give the animal an opportunity at second chance at life in forever home.


The City-County Health Department recently hired a

company to construct 10 outside bay kennels. Each dog kennel is 4'x8'. The kennels are constructed on a 40' X 8' X 6" foundation with a metal roof over it. The construction of the 10 outside bay kennels was a joint effort between the City of Kingsville and Kleberg County. This new improvement will help with the overcrowding of dogs being impounded. The Animal Control Center will now have 22 inside kennels and 10 outside kennels for a total of 32 dog kennels.

The City-County Health Department/Animal Control Division would like to remind the citizens of Kingsville that the city does have a leash ordinance and any animals running at large and/or stray will be impounded. Also, all dogs and cats by age of 4 months should be rabies vaccinated

by a licensed Veterinarian and every year thereafter as per City Ordinance and Health & Safety Code Title 10, Health and Safety of Animals Chapter 826, Rabies. It's always best to have your pet's rabies tag securely attached to their collar. It's also recommended for your pet(s) to be seen by a
