I. Preliminary Proceedings.

OPEN MEETING

Mayor Fugate opened the meeting at 5:00 P.M. with four Commission members present. Commissioner Torres arrived at 5:49 P.M.

INVOCATION / PLEDGE OF ALLEGIANCE – (Mayor Fugate)

The invocation was delivered by Ms. Courtney Alvarez, City Attorney, followed by the Pledge of Allegiance and the Texas Pledge.

MINUTES OF PREVIOUS MEETING(S)

Regular Meeting February 13, 2023

Motion made by Commissioner Lopez to approve the minutes of February 13, 2023, as presented, seconded by Commissioner Alvarez. The motion was passed and approved by the following vote: Hinojosa, Alvarez, Lopez, Fugate voting "FOR".

II. Public Hearing - (Required by Law).1

1. <u>Public hearing for the submission of a Main Street Grant Application to the Texas Department of Agriculture as part of the Texas Community Development Block Grant Program.</u> (Director of Planning & Development Services).

Mayor Fugate read and opened this public hearing at 5:01 P.M.

Ms. Alvarez reported that the notice for this public hearing was published in the newspaper on February 16, 2023.

Mr. Kwabena Agyekum, Interims Director of Planning & Development Services stated that the community development needs for Main Street are sidewalks, lighting, road construction, renovation, and curb and gutter. The target areas are Kleberg between 6th and 7th street intersections. The amount of funding available is \$500,000 with a cash match required of \$18750.00. Staff would like to submit for this grant to go towards these needs. Mr. Agyekum further displayed a sketch map of the location where the project would take place.

Mayor Fugate asked that on the map there is a star in the middle of red brick on the road, and asked if the star was going to be located in that area.

Mr. Agyekum stated that paving would form the star in the middle of the brick area. The star can be of any color that is chosen.

Mr. McLaughlin commented that this is the intersection of Kleberg and 7th Street which is concrete that has been cut multiple times, so if the city will be replacing any part of the street, this will be the first part of it.

Commissioner Lopez commented that this is good but she would have wished that it would have gone a bit further down the road as the worst part is on 8th street.

Mr. McLaughlin stated that bids have already been received for the street which is well over \$1 million.

Commissioner Alvarez asked if the curbs will be lowered. Mr. McLaughlin responded that wherever it exceeds the height of the standard step, one or two steps will be placed. He further stated that the north side of Kleberg will probably have one step up to the sidewalk with the south side having two steps.

Mr. Agyekum stated that there is room for ADA compliance. He further stated that the funds needed are \$500,000 with a match of 3.5% cash match which totals \$17,500 with in-kind of \$30,000 for engineering services and in-kind of \$8,500 for administrative services.

Commissioner Alvarez asked for clarification on the cash match, as one slide showed \$18,500 and the other shows \$17,500.

Mr. McLaughlin stated that the correct amount is \$17,500.

Mr. Agyekum further stated that what is also being proposed are bollards.

Ms. Alvarez commented that bollards are installed at Texas A&M University-Kingsville on Santa Gertrudis and University Boulevard which are used when they want to close down the university from Santa Gertrudis to the main building. These bollards are the type that is screwed on and off.

Mayor Fugate asked if the bricks would be higher than the original road. Mr. McLaughlin responded that the bricks would be blended into the same level of the existing road.

Mayor Fugate announced that this is a public hearing and if anyone would like to speak on behalf of this item they may do so now with a five-minute limit. Additional time cannot be extended by City Commission.

There being no further comments Mayor Fugate closed this public hearing at 5:05 P.M.

Mayor Fugate read and presented the Key to the City and a proclamation to Mr. Glen Jones, NAS Kingsville Community Liaison Officer. Mr. Jones will be retiring at the end of March 2023, and therefore the City of Kingsville would like to acknowledge all his hard work while in Kingsville.

Mr. Mark McLaughlin, City Manager complimented Mr. Glen Jones for all the hard work he has done within the community. He further introduced the city's new Building Official, Ms. Berlinda Tarver. Mr. McLaughlin further stated that a Wine Walk was held this past weekend and was very well attended. He also reported that the greens at the Golf Course will open for tournaments in March, 8 tournaments are scheduled for the upcoming month. The street sweeper contract will begin this Wednesday. Mr. McLaughlin gave a brief update on the TML Region 11 Quarterly Meeting that was held in Yoakum. There are several House Bills and Senate Bills that the city would need to keep an eye out for, as they could bring some changes to the city. He further stated that House Bill 2127 and Senate Bill 814 are companion bills that are going through. These bills would give the state exclusive authority over any activity contained in the agricultural code, finance code, insurance code, labor code, natural resources code, and occupation code. Some of those areas include drought, weedy lots, which the city deals with all the time, the raising of animals and predatory lending, and pawn shops. What this means is that unless the state law expressly authorizes the city or county to act in these fields any local ordinance or order that attempts to regulate any activity within these codes will be voided. Mr. McLaughlin further stated that if these were to pass then the city would need to look into its ordinance and see what the impact on our city would be.

Commissioner Hinojosa stated that most of the losses that have occurred have been an act of nature. The cyber attack is a human error as we go in and go phishing the web. He further stated that staff is doing a great job as everyone has to go through cybersecurity training.

Mr. McLaughlin further reported that the next TML Region 11 Quarterly meeting will be held in Victoria, but no date has been announced.

Mr. Ricardo Torres, Chief of Police gave an update on the situation that transpired at H.M. King High School on Thursday, February 23, 2023, where it was reported by students that someone may have been carrying a weapon on campus. He further discussed the timeline from the time the call was received to the first officer arriving on campus. Within 15 minutes from the initial call coming into dispatch, 100 law enforcement officers responded to the location of possible threat. He further stated that officers were deployed inside the campus to clear every room with the school. After the clearing the room students were dismissed to a safe location located across the street from the campus. At that point, students were reunited with their parents or put on the school bus to go home. He further stated that law enforcement closed down a section of Brahma Boulevard, in front of the school so that

school buses could pick up those students riding the bus home. Chief Torres stated that although a weapon was not found, this was a great exercise for everyone involved. A plan was put in place by all law enforcement agencies that responded and worked very well to insure the safety of the students and faculty. He further stated that he would like to thank all law enforcement agencies that responded on a job well done and further thanked the parents of the students for being patient while waiting for officers to clear the location before releasing students to their parents.

Mayor Fugate thanked KPD Officers and all law enforcement agencies for their quick response in this situation.

Ms. Courtney Alvarez, City Attorney reported that the next scheduled Commission meeting is set for Monday, March 13, 2023. The deadline for staff to submit their agenda items is scheduled for Friday, March 3, 2023. Ms. Alvarez further reminded everyone that March 13th is the start of Spring Break for our students and encouraged everyone to drive a little slower through our city streets, as children will be home. She further stated the Police Department is having a Warrant Roundup. Voluntary compliance period where one can go to Municipal Court and take care of their citations without being arrested runs until the end of this week, March 3rd. Beginning on Saturday, March 4th, active enforcement will begin.

Commissioner Lopez stated that although she was confused with the location that was discussed during the public hearing, she would like for the location between 9th Street and 10th Street to be looked into as a lot of citizens have fallen in this area during parades. She further stated that she would like something to be done to prevent our citizens from falling and getting hurt.

Mr. McLaughlin stated that he will have the Street Department look into this and see if there is a fix for this.

Commissioner Alvarez asked for a brief update on water meters, as it had been mentioned some time back.

Mr. McLaughlin responded that it has been about a year since the city had an outside agency to assess the city and they came back with a price of over \$10 million to replace all of the water meters. This information was briefed to the Commission and at that time Mayor Fugate asked for staff to get a second opinion. Staff has received a second opinion which dropped by a few million dollars, but the costs were still considerably higher than if we did it a different way. Staff worked with its financial advisors and they advised us on a better way to do it. He further stated that staff has informed the company that did the second assessment that we have complied with the contract and cut them off at a certain point and paid them for the first part of the assessment. Staff had a meeting last week to see what the different options are on paying for it using the meter company that can install it themselves. He further stated that this will be in the \$6 million range to do all the meters in the city. He further stated that what also needs to be done is a lead and copper, which is required by law where an assessment needs to be done for every pipe coming in and out.

Commissioner Alvarez further asked if some meters could be done this fiscal year and the rest the following fiscal year.

Mr. McLaughlin responded that staff has talked about possibly doing residential meters first, as they are smaller pipes and easier to do. He further stated that the issue would be is finding a larger meter and it having cast iron on the city side and is supposed to be a 4

inch but when it's opened there is only about 1 inch left on the inside. The question then is what does the city do, place a brand new meter on a bad pipe or fix the entire line? He further stated that there are a lot of things to take into consideration.

Mayor Fugate asked for the status of the demolition of the gas station located on King Street and Hwy 77.

Mr. McLaughlin responded that the property had been sold and the new owner is not aware that this location had been condemned. Staff will need to get with the new owner and see what the plans are for this location. He did state that the old hospital located on Caesar Street will be demolished soon, and a budget amendment will be brought forth to the Commission for this project. He further stated that no matter how hard they tried, the experts could not get the asbestos count below 1%, which would have been cheaper to demolish. The count, in some areas, is 5% to 8% asbestos. This will increase the price to about \$200,000. Once the funds are secure, the demolition can begin, as 75% of the hospital will be easy to demolish as parts of the building don't have asbestos. The area that has the asbestos will be done at the very end of the project.

IV. Public Comment on Agenda Items.³

Mrs. Mary Valenzuela, City Secretary read a public comment submitted by Ms. Jozannah Quintanilla, 201 Jay Vee Lane, Kingsville, TX. Public comment read as followed:

Dear Mayor and Kingsville City Leaders, I'm writing to discuss my concerns on an issue and incident involving my father, Joe Quintanilla. I also want to inform the mayor and city leaders of the disrespect and treatment shown to my father, an upstanding loyal citizen who has lived in this town all his life. Not to mention he is an elderly man who should be shown compassion like you would any of your elderly loved ones. My father has been trying to get a permit for a shed he bought for his home that was authorized by the city on January 6th. He has been given the run around at the permit department and was never issued one. Now Fast forward to February 7th where an incident occurred at my father's home at 201 Jay Vee. My father was inside his home cutting an apple with a very small paring knife when he saw what he described as suspicious activity at his property. He described a man in ordinary clothes with a fishing hat, holding something in his hand and looking onto the property. My father, who has had lots of things stolen from his property, ran outside not even realizing he still had the apple and the paring knife in his hand.... asked the guy what he was doing? The man we now have identified as Uche did not show a city badge and was rude and yelled to my dad he was with the city. That's all he said. Again, he was in ordinary clothes like a citizen and wearing a hat. He would not tell my father what he was doing there and was holding a camera where my dad said he was taking pictures of the property. Again, my dad asked what do you want... the man never spoke clearly and was pointing to possibly the shed and then got into his car and sped off. He did not explain anything about what he was doing and did not even offer to give his information to call his office. When my father went back to the permits office again to try to figure out what was happening with his permit and was denied again came to find out the man taking pictures was Uche with the city permits office. That brings us to the concerns I have with how city leaders handled this situation. When my brother posted on Facebook about what happened and the way my father was treated ... Anne Marie Torres who neither of us know personally was the one who responded and said she would send the concern to the appropriate person with the permits department. The most disturbing response was from city manager Mark McLaughlin. I could not believe he would email back that my father should have been arrested because my elderly father had come at

Uche with a knife. I was like this has to be a joke.... absolutely absurd in this matter. To put the blame on an elderly man who was simply scared and ran out thinking there was possibly a suspicious person looking onto his property and even taking pictures. A man who never made it clear who he was or what he was doing. How dare Mr. McLaughlin make my dad out to be a criminal and slander his name. Instead of resolving the issue and helping an elderly citizen he acted like a bully. He only heard Uche and his lie and never talked to my dad or the family. Nobody has helped my dad to figure out what to do to get this permit he sped off in front of him. More like that car could have been called a weapon if he had hit my dad on the street when he sped off so fast. You all should be ashamed of yourselves treating the great citizens of Kingsville this way. As a former news journalist of 16 years. I know wrong within a city government or city practices when I see it. This is just wrong all the way around. Change your practices on how you get permits...in today's day and age with all the shootings and crime happening you can't expect elderly citizens to trust any suspicious activity. For God sakes... when there are people being shot in shopping malls and churches and elderly people being shot and carjacked in daylight. You think this is, okay? I have called to talk to Uche since my dad started experiencing stress and chest pains from all the distress. Uche would not return my calls. Mr. McLaughlin has not reached out to my father also. This is not even about a permit anymore...it's the thought of these ridiculous and unsafe practices for a permit. Also, if this happened to an upstanding citizen like my father... then how many other citizens will be mistreated and not helped. Thank You, Jozannah Quintanilla, His Devoted Daughter.

CONSIDERATION OF MOTIONS, RESOLUTIONS, AND ORDINANCES:

- VI. Items for consideration by Commissioners.4
 - 1. Consider a resolution of the City Commission of Kingsville, Texas authorizing the submission of an application to the Texas Department of Agriculture for the Texas Community Development Block Grant Program, Main Street Grant Application; and authorizing the City Manager to act as the City's Executive Officer and Authorized Representative in all matters pertaining to the City's participation in the Texas Community Development Block Grant Program for improvements in the downtown area. (Director of Planning & Development Services).

Motion made by Commissioner Lopez to approve the resolution of the City Commission of Kingsville, Texas authorizing the submission of an application to the Texas Department of Agriculture for the Texas Community Development Block Grant Program, Main Street Grant Application; and authorizing the City Manager to act as the City's Executive Officer and Authorized Representative in all matters pertaining to the City's participation in the Texas Community Development Block Grant Program for improvements in the downtown area, seconded by Commissioner Alvarez. The motion was passed and approved by the following vote: Alvarez, Lopez, Hinojosa, Fugate voting "FOR".

2. Consider a resolution authorizing participation in 2023 State Homeland Security Grant Program-Regular Projects with the Office of the Governor, Public Safety Office, Homeland Security Grants Division for law enforcement equipment; authorizing the Chief of Police to act on the City's behalf with such program. (Police Chief).

Mr. Ricardo Torres, Chief of Police stated that the Kingsville Police Department is applying for equipment under the 2023 State Homeland Security Program. The grant amount is \$29,365.00 with no cash match. Staff is looking into a drone program and the drones that they are looking at purchasing have been tested by our officers and flown inside a building where they can provide live feeds of the subject as well as audio of anything the suspect may be saying. These drones are small enough that officers on patrol can have them at the ready and deploy them to assist in locating absconders from their pursuits.

Motion made by Commissioner Lopez to approve the resolution authorizing participation in 2023 State Homeland Security Grant Program-Regular Projects with the Office of the Governor, Public Safety Office, Homeland Security Grants Division for law enforcement equipment; authorizing the Chief of Police to act on the City's behalf with such program, seconded by Commissioner Alvarez. The motion was passed and approved by the following vote: Lopez, Hinojosa, Alvarez, Fugate voting "FOR".

3. Consider authorizing purchase of Rotary Broom for Street Department via BuyBoard as per staff recommendation. (Purchasing Manager).

Mr. Charlie Sosa, Purchasing Manager stated that this item authorizes the purchase of a new Broce Rotary Broom RCT-350 from Nueces Power Equipment through BuyBoard Purchasing Cooperative Contract #685-22 for the City of Kingsville Street Department. The existing Rotary Broom is 20-plus years old and has been sent in for repairs frequently. The Street Department rotary broom is used for the construction of hot mix materials and seal coating for the city's street program. Frequent repairs have caused the Street Department to use rental equipment thus increasing maintenance and operation expenses. The purchase of a new Broce Rotary Broom will increase productivity and decrease operating expenses. Mr. Sosa further stated that funds are available through 115-5-3050-71200 of which \$74,791.00 are available this fiscal year. The purchase price is estimated to be \$73,931.66.

Motion made by Commissioner Alvarez to authorize purchase of Rotary Broom for Street Department via BuyBoard as per staff's recommendation, seconded by Commissioner Lopez. The motion was passed and approved by the following vote: Torres, Hinojosa, Alvarez, Lopez, Fugate voting "FOR".

4. Consider out of state travel for Mayor, City Manager, and Economic Development Director to attend the International Council of Shopping Centers (ICSC) Conference in Las Vegas, Nevada from May 20-24, 2023. (City Manager).

Motion made by Commissioner Alvarez to approve the out-of-state travel for the Mayor, City Manager, and Economic Development Director to attend the International Council of Shopping Centers (ICSC) Conference in Las Vegas, Nevada from May 20-24, 2023, seconded by Commissioner Lopez. The motion was passed and approved by the following vote: Hinojosa, Alvarez, Lopez, Torres, Fugate voting "FOR".

5. Consider a resolution authorizing the City Manager to execute a Consulting Servicers Agreement with Evergreen Solutions, LLC for a compensation and benefits study. (Purchasing Manager).

Mr. Sosa stated that this item authorizes the city to approve a contract with Evergreen Solutions LLC to conduct a classification and compensation study for the City of Kingsville. The request for proposal was published in the newspaper on December 22, 2022, and January 5, 2023. Responses were accepted until 2:00 P.M. on January 31, 2023. The city received six responses from Gallagher Benefit Services, McGrath Human Resources Group, PayPoint HR LLC, Baker Tilly US, LLP, JER HR Group, and Evergreen Solutions LLC. The compensation review committee reviewed proposals and found the information received to be responsive. The review committee scored the firms based on understanding the task, related experience, references, cost of services, and time to complete tasks. Based on the criteria listed the review committee selected Evergreen Solutions LLC. The review committee consisted of Diana Gonzalez, Human Resources Director for the city. Mr. Sosa further stated that at a duly posted City Commission meeting on February 13, 2023, the City Commission awarded RFP #23-03 to Evergreen Solutions, LLC. A professional services agreement has been negotiated and needs to be approved by the City Commission. Funds are available through General Fund Amendment Reserves of which \$42,500 are available. The total cost of services is anticipated to be \$34,500.

Commissioner Torres asked if they are the only ones that came in under \$42,000. Mr. Sosa responded no, but they have the most experience.

Motion made by Commissioner Alvarez to approve the resolution authorizing the City Manager to execute a Consulting Servicers Agreement with Evergreen Solutions, LLC for a compensation and benefits study, seconded by Commissioner Lopez. The motion was passed and approved by the following vote: Alvarez, Lopez, Torres, Hinojosa, Fugate voting "FOR".

6. <u>Discussion regarding potential ordinance requiring spay and neuter of animals.</u> (Commissioner Torres).

Commissioner Torres stated that we have received a copy of the City of Corpus Christi ordinance regarding spaying and neutering. She stated that with everything that is out there and what she has seen which are a lot of dogs. She stated that she purchased an electric fence, which is humane, to keep her dogs within the property. She also stated that she took advantage of the spay and neuter in Corpus Christi through PAAC and paid a \$50.00 deposit and paid \$100.00 to get her dog neutered. For some, this cost may be expensive, but if our citizens aren't going to be responsible for their pets, then we must do something. She knows that the Animal Control Division is trying its best and doing a good job at the rescues and trying to get them adopted, but she doesn't feel that this will be successful if they continue having puppies.

Mr. Emilio Garcia, Health Director stated that the city has partnered with People Assisting Animal Control (PAAC) as they have received a grant on September 2022 for an amount of \$125,000. These funds are to be used for free spay and neutering, for both dogs and cats, within seven counties. He further stated that his department contacted Ms. Martinez who explained how the program was to work. Our part was to

identify target areas in the community where staff felt that the need for spay and neutering was needed. Once the targeted areas were provided the organization came in and spoke to individuals regarding the free sterilization program. The animal would need to be transported to Corpus Christi to be spayed or neutered. The service would not only be the sterilization of the animal but also comes with other grooming services and vaccinations as well as a small kennel for the dog or cat. In the first phase of this program, we had 28 animals that were sterilized and during the second phase, there were 68 animals sterilized. Phase three has just begun with about eight or nine streets that are on the target list. Once those areas are taken care of, Ms. Martinez contacts staff for any other targeted areas that need to be focused on. Mr. Garcia stated that the grant came from the Council of Governments (COG) which assist communities in getting animals spayed and neutered.

Commissioner Torres commented that the spay and neuter ordinance, after reviewing it, would be an option for us to move forward with and asked if it would help.

Mr. Garcia responded that it could help and cannot help. If you are not offering an incentive to assist the citizens in getting their animal spayed or neutered they may say to have the animal control pick up the animal, which will then fill up the animal control shelter. If we then can't get the animals adopted or rescued, then it leaves no other choice but to euthanize the animal when the shelter is over capacity. He further stated that the ordinance from Corpus Christi is not mandatory for every animal within that city. If the animal gets impounded, then a letter of violation is sent, then once the animal is released to the owner the owner has 30 days to sterilize that animal.

Commissioner Torres commented that one thing is that the shelter is overpopulated.

Mr. Garcia commented that the shelter is up to capacity most of the time. If we can get animal owners to get their animals sterilized, then it would slow down the shelter.

Commissioner Alvarez commented that on TV, there was a gentleman from Alice where they showed a large black bus that is used to load animals and take them to other cities and states that are wanted. What they were asking for is for citizens to donate to cover the cost of fuel.

Mr. Garcia stated that this individual goes around the surrounding counties and sees what is available to transport for rescue.

Commissioner Torres asked if the city was going to look into one of the mobile buses at one time.

Mr. Garcia responded that they were going to look at STARR but they buddied with PeeWees in Nueces County for that service. He further stated that he did speak with Ms. Martinez, once their spay and neuter program started if she was willing to bring down her mobile unit to Kingsville for one day and park at the Health Department facility and sterilize animals for our citizens, but she hasn't responded just yet.

Commissioner Torres further asked if the Health Department is eligible to take the pets that are in the shelter in for sterilization.

Mr. Garcia responded that if the city took animals to sterilization, Ms. Martinez would provide so many sterilizations for the animals in our shelter.

Mayor Fugate asked about Phase 3 of the program. Mr. Garcia stated that Phase 3 is in the area by Perez Elementary School. Mayor Fugate further asked if our city had an Page 9 of 10 - FEBRUARY 27, 2023

ordinance in place that if the owner of an animal was to go pick up their dog or cat from the shelter, they would be required to sterilize that animal within 30 days.

Mr. Garcia responded this is the ordinance that is currently in Corpus Christi. The City of Kingsville does not have that ordinance in place, but it is something that our city could implement.

Mayor Fugate stated that he would like for staff to look into possibly setting aside some funds and see if the city can start a program for spay and neutering animals.

7. Mayor Fugate read and convened the meeting into executive session at 6:41 P.M.

Mayor Fugate convened the meeting into open session at 6:48 P.M.

9. <u>Consider approval of compensation adjustment for City Attorney position.</u> (Mayor Fugate).

Motion made by Commissioner Lopez to approve the compensation adjustment for the City Attorney position to \$150,000 annually, seconded by Commissioner Torres. The motion was passed and approved by the following vote: Lopez, Torres, Hinojosa, Alvarez, Fugate voting "FOR".





There were no public


comments and the consent motions, resolutions, or-dinances, and ordinances from the previous meet-ings were all approved.



RESOLUTION AUTHORIZING PUBLICATION OF NOTICE OF INTENTION TO ISSUE CERTIFICATES OF OBLIGATION

- **Section 3.** The Mayor and the City Secretary are hereby authorized and directed to execute the Certificate to which this Resolution is attached on behalf of the City Commission and to do any or all things proper and necessary to carry out the intent thereof.

NOTICE OF INTENTION TO ISSUE CERTIFICATES OF OBLIGATION

NOTICE is hereby given that it is the intention of the City Commission (the "City Commission") of the City of Kingsville, Texas (the "City") to adopt one or more ordinances providing for the issuance of one or more interest-bearing obligations of the City presently contemplated to be designated and known as the "CITY OF KINGSVILLE, TEXAS CERTIFICATES OF OBLIGATION" (the "Certificates of Obligation") for the purpose of providing for the payment of contractual obligations to be incurred in connection with the design, planning, purchasing, acquisition, construction, equipping, expansion, repair, renovation, and/or rehabilitation of certain City-owned public property, including (i) improvements to the water and sewer system including water meters and related technology; and (ii) payment of contractual obligations for professional services in connection therewith (to wit: consulting, engineering, financial advisory, and legal).

The City Commission tentatively proposes to authorize the issuance of the Certificates of Obligation (one or more series) at its regular meeting place at 400 West King Avenue, Kingsville, Texas, at a meeting of the City Commission to be commenced at 5:00 p.m. on May 8, 2023, in a maximum total amount expected not to exceed \$6,500,000. In the event the City Commission will be unable to meet at this location on May 8, 2023, the City will post information on its website for attending the meeting by telephone, teleconference, or other electronic means. The City Commission proposes to provide for payment of the Certificates of Obligation from a pledge of an annual ad valorem tax, as well as a subordinate lien pledge of the net revenues of the City's waterworks and sewer system. The City Commission reasonably expects to provide for payment of debt service on the Certificates of Obligation from a subordinate lien pledge of the net revenues of the City's waterworks and sewer system, but in the event such self-supporting source of revenues is inadequate for such purpose, the City will be obligated to levy an annual ad valorem tax to pay debt service due on the Certificates of Obligation. The Ordinance in which the City makes a self-supporting designation is available upon request.

Market conditions affecting interest rates vary based on a number of factors beyond the control of the City, and the City cannot and does not guarantee a particular interest rate associated with one or more series of the Certificates of Obligation. RESOLUTION DECLARING INTENTION TO REIMBURSE CERTAIN EXPENDITURES

WHEREAS, the City of Kingsville, Texas (the "City") desires to pay expenditures in connection with the design, planning, acquisition, construction, equipping, expansion, repair, renovation, and/or rehabilitation of the project or facilities described in Exhibit A attached hereto (the 'Project');

WHEREAS, Chapter 1201, Texas Government Code (the "Code") permits the City to use the proceeds of obligations to reimburse the City for costs attributable to the Project paid or incurred before the date of issuance of such obligations; and

WHEREAS, the City finds, considers, and declares that the reimbursement of the City for the payment of such expenditures will be appropriate and consistent with the objectives of the City's programs and, as such, chooses to declare its intention, in accordance with the provisions of Section 1.150-2 of the Treasury Regulations, to reimburse itself for such payments at such time as it issues obligations to finance the Project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF KINGSVILLE, TEXAS THAT:

Section 1. This Resolution declares the intention of the City to reimburse the expenditures for the Project with the proceeds of obligations. The City presently intends to reimburse the expenditure by incurring obligations issued under Texas law, the interest on which is excludable from gross income under section 103 of the Internal Revenue Code of 1986, as amended.

Section 2. The City reasonably expects to incur debt, in one or more series of obligations, in an aggregate maximum principal amount now estimated to be \$6,500,000 for the purpose of paying the costs for the acquisition of certain property and related improvements for the City.

Section 3. The City intends to reimburse the expenditures hereunder not later than 18 months after the date the original expenditure is paid or the date the Project is placed in service or abandoned, but in no event more than three years after the original expenditure is paid unless the Project is a construction project for which the City and a licensed architect or engineer have certified that at least five years are necessary to complete the Project in which event the maximum reimbursement period is five years after the date of the original expenditure.

Section 4. The City intends that this Resolution satisfy the official intent requirement set forth in Section 1.150-2 of the Treasury Regulations and evidences its intentions under Section 1201.042(c) of the Code.

Section 5. This Resolution shall be liberally construed to evidence the intent of the City to comply with state law and federal income tax law in the issuance of tax-exempt obligations for the Project.

Summary: CenterPoint Energy Entex and CenterPoint Energy Texas Gas-South Texas Division ("CenterPoint" or "Company") filed notice of its 2023 Annual GRIP Adjustment for the South Texas Division with the City of Kingsville on March 2, 2023, seeking to adjust its gas rates starting May 1, 2023.

The resolution authorizes the City of Kingsville ("City") to suspend the date the rate increase takes effect for a period of no longer than forty-five (45) days, which means the new rates would start about June 14, 2023. The City proposes the delay to examine the GRIP Rate Increases to determine its compliance with the Texas Utilities Code.

Background: Cities used to have authority to contest any type of rate increase, the but the Legislature has limited that ability over the last few years. Now cities are not able to contest rate increases filed as GRIP Rate Adjustments. (GRIP stands for gas reliability infrastructure program.) Currently, cities can only delay the start date of the new rate to ensure compliance with the statutory process and Texas Railroad Commission procedures. Cities may still contest applications for full rate case increases, but this is not one of those.

The City of Kingsville has previously delayed the start of GRIP Rate Adjustment filings and has participated with other Cities served by CenterPoint in prior gas rate case and cost recovery filings. As there is no individual or agency that reviews the rate cases and recovery requests on behalf of the affected parties/citizens, the Legislature has given cities authority to do so with the utility company paying for the expenses involved in the review of full rate increase filings.

Financial Impact: This action has no financial impact to the City.

Recommendation: Approve the resolution as presented.

CenterPoint Energy Resources Corp., d/b/a CenterPoint Energy Entex and CenterPoint Energy Texas Gas ("CenterPoint" or the "Company"), files the tariffs and supporting documents in electronic form, with the City of Kingsville ("City") consistent with Section 7.7101 of the Railroad Commission of Texas ("Commission") Gas Services Division Rules and Section 104.301 of the Texas Utilities Code to establish the annual gas reliability infrastructure program ("GRIP") interim rate adjustment ("IRA") for the Company's South Texas Division, which includes the City. The proposed IRA will affect rates for natural gas service customers located in the City. Simultaneously with this filing, CenterPoint makes the same GRIP filing with the Commission for customers located in the City's environs and cities of the South Texas Division that have ceded original jurisdiction to the Commission.

CenterPoint consistently supplies its customers in the South Texas Division with safe and dependable natural gas service by prudently investing in additions and upgrades to its delivery system. The Company will continue to prudently invest in its infrastructure in order to improve its natural gas service to its customers and to anticipate and meet their needs under all operating conditions. The GRIP program enables a gas utility such as CenterPoint to begin recovery of its incremental capital investment in the system, subject to a prudence review in its next rate case. This reduces regulatory lag and incentivizes needed investment. Consistent with Section 104.301 of the Texas Utilities Code and Commission precedent, the City's review of this GRIP filing is limited to a ministerial review to ensure compliance with the GRIP statute.

Pursuant to applicable law, the proposed IRA will become effective on May 1, 2023, unless the City suspends that date for a period of no longer than forty-five (45) days. The approved IRA will be applied to the monthly customer charge and will remain in effect until superseded by the earlier of (1) the effective date of the Company's next annual GRIP adjustment for the South Texas Division; or (2) the issuance of a final order in a rate setting proceeding for the South Texas Division.

As detailed in the attached schedules and supporting material, the Company invested \$68,292,974 in its South Texas Division in calendar year 2022, and the applicable IRA is:



Whereas, the City passed and approved an Economic Development Grant Program and Manual to spur new economic activity within the Kingsville city limits on January 10, 0222 via Resolution #2022-03;

Whereas, an Economic Development Grant ("EDG") Administrative Board was created to review and make recommendations on grant applications;

Whereas, the grant was widely publicized in the local newspaper, regional television, social media, newsletters, and speaking directly to community organizations, which resulted in several applications for the EDG Administrative Board to review and three were recommended for approval to City Commission;

Whereas, at a duly posted meeting of the City Commission on November 14, 2022 the Commission approved the three grant applications as recommended in a revised manner by the Board;

Whereas, the need for economic development exists within the City based on current demand and the City desires to increase the sales tax and ad valorem tax base of the City to the benefit of citizens and other local taxing entities;

Whereas, the City believes the offering of local economic incentives like this grant will stimulate new development and economic activity within the city;

- 2.1.1. Projects must be completed within twelve (12) months of Commitment Letter signature.
- 2.1.2. Assuming compliance with all requirements, funds shall be distributed by the City of Kingsville Finance Department to the banking institution established by the recipient at a rate equal to the recipient's expense of private resources until all EDG funds for the recipient have been transferred, or until the project is completed, whichever comes first.
- 2.1.3. Funds not expended within the terms of the Commitment Letter shall be retained by the City for use in future EDG applications.

- 2.1.4. Funds may not be used for projects listed in the Economic Development Grant Program and Administrative Manual, Part I. B. 3: Anticipated EDG Investments, nor may funds be used for items other than those approved by Commission as noted above.
- 2.1.5. Funds are distributed in a semi-reimbursement method. Funds may either be for a reimbursable expense or with prior proof of invoice and City Manager approval funds may be forwarded to assist in the purchase of the approved project expense. Recipient is responsible for providing all receipts, or invoices, highlighting approved project expenses prior to any City transfer of funds for reimbursement within thirty (30) days of paying for such project expenses. Recipient is responsible for providing all receipts for approved project expenses within seven (7) days of purchase for items where funds are forwarded to assist with the purchase.
- 2.1.6. No EDG funds shall be used for insurance related to labor including workman's compensation, long or short term disability, social security, Medicare, public or private insurance, or paid time off, etc..
- 2.1.7. The City of Kingsville City Manager has final authority on approval of funds for release. Project costs in dispute between the City and the Recipient shall be forwarded to the City Manager for final adjudication.
- 2.1.8. Drawdown requests shall be in writing to the City of Kingsville City Manager, dated, with information explaining the nature of the expense and receipts (if reimbursed) or an invoice (programed expenses). Lack of necessary information to support compliance with the Economic Development Grant Program and Administrative Manual shall result in the City's withholding the release of funds, and possibly result in the Recipient paying back funds previously received from the City.
- 2.1.9. The City shall provide approved funding in the form agreeable by both parties and payable to the Recipient. Quarterly reports from the Recipient to the City shall show proof of all City funds deposited and expenses incurred.
- 2.1.10. The total drawdown request submitted to the City should be equal to or less than the total of all attached documentation for said request.
- 2.1.11. The Recipient shall keep records of all expenditures relating to economic development grant funding. Documents consisting of bills, invoices, canceled checks, receipts, quotes, estimates, etc., will be retained by the Recipient for three (3) years after the submission and acceptance of a final closeout of the EDG grant by the City.
- 3. **Report(s):** Recipient shall submit a written report monthly to the City summarizing and evaluating the accomplishments of their project covering the preceding thirty (30) days. Within sixty (60) days of the completion of the project, or no later the 60 days following the completion date shown on this Commitment Letter, Recipient shall provide a summarized report of the entire project, funds received, expenses incurred and reimbursed, and proof of the final building inspection (if required) per the City's adopted version of the applicable International Building Codes and Fire Code.

- 4. Applicable Laws, Legal Advice, and Licenses: Recipient shall comply at their own expense with all laws of any municipal, county, state, federal or other public authority regarding the use of economic development grant funds, which may include public contracting laws. The Grant Recipient shall be responsible for obtaining their own legal advice, if necessary, concerning the applicability of such laws and/or compliance with such laws. The Grant Recipient shall be solely responsible for any licenses or permits required by law, and shall pay all costs, required taxes, fees and charges prescribed by law. The Grant Recipient, throughout the duration of this Agreement and any extensions, shall comply with all federal, state and local laws, regulations, and ordinances applicable to this Agreement or to the Grant Recipient's obligations under this Agreement, as those laws, regulations and ordinances may be adopted or amended from time to time.

 - Termination of this Agreement, in whole or in part;
 - Exercise of the right to withhold any grant amount not yet paid; and,
- Initiation of an action or proceeding for damages, specific performance, declaratory or injunctive relief. The City may seek reimbursement of funds provided to the Recipient. The City shall be entitled to recover any and all damages suffered as the result of Grant Recipient's breach of this Agreement, including but not limited to direct, indirect, incidental and consequential damages, costs of cure.
- 4.2. These remedies are cumulative to the extent the remedies are not inconsistent, and the City may pursue any remedy or remedies singly, collectively, successively, or in any order whatsoever.
- 4.3. This Agreement shall comply with the requirements of the Civil Rights Act of 1964, including the following provisions:

- 10. **Termination:** This Agreement may be terminated or modified upon the occurrence of the following circumstances:
- 10.1. Either party may terminate this Agreement upon thirty (30) days written notice to the other party. Failure to comply with the conditions of the Agreement is cause for the City of Kingsville to terminate and seek reimbursement of all funds provided to Recipient through every legal means available, and for the Grant Recipient to become ineligible for grant funds for the next five (5) years.
- 10.2. In the event of termination prior to project completion, the City of Kingsville shall cancel all unpaid installments of the project and will be entitled to return of any funding provided to Recipient by the City.

All requests for funds and required supporting documentation must be received no later than twelve (12) months following this agreement signature date.

- 13. **HIPAA Compliance:** If the services funded in whole or in part with financial assistance provided under this Agreement are covered by the Health Insurance Portability and Accountability Act or the federal regulations implementing the Act (collectively referred to as HIPAA), Grant Recipient agrees to deliver the services in compliance with HIPAA. Without limiting the generality of the foregoing, services funded in whole or in part with financial assistance provided under this Agreement are covered by HIPAA. Grant Recipient shall comply and cause all providers to comply with the following:

Privacy and Security of Individually Identifiable Health Information. Individually Identifiable Health Information about specific individuals is confidential. Individually Identifiable Health Information relating to specific individuals may be exchanged between Grant Recipient and City for purposes directly related to the provision of services to Grant Recipient's clients, which are funded in whole or in part under this Agreement. Purpose:

The purpose of awarding this project is to meet lease agreement requirement with Kleberg First National Bank for parking lot maintenance. The parking lot is located north of the City's Municipal Building at 200 E. Kleberg.

Summary:

On February 21, 2023, three (3) bids were received which included Danny's Paving, Donald Hubert Construction, and Precision Construction and Contracting. RFQ # 23-04 for 2023 Municipal Building Parking Lot Maintenance Project was advertised on February 2, 2023, and February 9, 2023, in the local newspaper and on the City's website. Sealed Bids were due February 21, 2023. Two (2) bids met the bids requirements, and one (1) bid was rejected because of missing documentation. First bid was Donald Hubert Contracting Co. Inc. from Kingsville, Texas. The second bid was Precision Construction and Contracting from Lee's Summit, Montana. The bid totals ranged from \$68,876.00 to \$93,390.00.

Contractor's references were verified. We recommend awarding the project to Donald Hubert Construction Inc., in the amount of \$68,675.00. Hubert Construction has completed several projects and has a great working relationship with the City.

Background:

The project includes asphalt repairs, overlay, and parking lot striping as required per the parking lot agreement between the City and Kleberg Bank.



LEASE AGREEMENT

This Lease Agreement made and entered into as of <u>April 1, 2021</u> by and between KLEBERG BANK, N.A. hereinafter called Lessor, and the CITY OF KINGSVILLE, a municipal corporation, hereinafter called Lessee.

WITNESSETH:

- Premises. Lessor hereby leases to Lessee upon the terms and conditions hereinafter stated thirty (30) parking spaces of a parking lot located at the corner of Sixth Street and Yoakum Street in Kingsville, Texas. The parking spaces are designated as City Manager's Parking, City Commissioner, and spaces 30A, 31A, and 18A through 43A as indicated on Exhibit A which is attached hereto and made a part hereof.
- Use. The leased parking spaces are to be used exclusively for personal vehicles of Lessee's
 employees working in the adjacent building and Lessee's vehicles used by departments located
 at the adjacent building.
- 3. Term. The Term of this Lease is ten (10) years, commencing on April 1, 2021 and ending ten (10) years from the date of commencement under the terms and conditions as set forth herein or March 31, 2031. As consideration for the use of the leased Premises, Lessee agrees to maintain the asphalt parking lot as indicated on Exhibit A, excluding Lessor's concrete ATM drive through, including seal coating and striping of the parking lot when needed, but no less frequently than once every five (5) years. The Lessee also agrees to provide Lessor water for irrigation of plants in and around the parking lot at no charge.
- 4. <u>Liability and Indemnity</u>. Lessee agrees to indemnify and hold Lessor harmless from all claims (including costs and expenses of defending against such claims) arising from any act or omission, customer, or invitees, or arising from any injury or damage to any person or the property of any person occurring within the leased spaces during the term of this Lease. Lessee agrees to use and occupy the leased Premises at its own risk and hereby releases Lessor, its agents and employees from all claims for any damage or injury except as may be caused by Lessor's negligence.
- Assignment and Subletting. Lessee will not assign this Lease or sublease the Premises or any
 part thereof or mortgage or pledge its leasehold interest or grant any concession or license
 within the leased Premises without prior express written consent of Lessor.
- 6. <u>Cancellation</u>. It is agreed that this Lease may be canceled by either party upon ninety (90) days written notice to the other party.

7. Entire Agreement. This instrument and any attached addenda or exhibits constitute the entire agreement between Lessor and Lessee; no prior written or prior contemporaneous oral promises or representations shall be binding. This Lease shall not be amended, changed, or extended except by written instrument signed by both parties hereto. Paragraph captions herein are for convenience only, and neither limit nor amplify the provisions of this instrument. The provisions of this instrument shall be binding upon and inure to the benefit of the heirs executors, administrators, successors and assigns of the parties, but this provision shall in no way alter the restriction herein connection with assignment and subletting by Lessee.

This Lease Agreement made and entered into as of <u>April 1, 2021</u> by and between KLEBERG BANK, N.A. hereinafter called Lessor, and the CITY OF KINGSVILLE, a municipal corporation, hereinafter called Lessee.


WITNESSETH:

- Premises. Lessor hereby leases to Lessee upon the terms and conditions hereinafter stated
 thirty (30) parking spaces of a parking lot located at the corner of Sixth Street and Yoakum

Lessee agrees to indemnify and hold Lessor harmless from all claims (including costs and expenses of defending against such claims) arising from any act or omission, customer, or invitees, or arising from any injury or damage to any person or the property of any person occurring within the leased spaces during the term of this Lease. Lessee agrees to use and occupy the leased Premises at its own risk and hereby releases Lessor, its agents and employees from all claims for any damage or injury except as may be caused by Lessor's negligence.

This item authorizes the City to approve a contract with R.L. Abatement Inc. for the asbestos removal, air monitoring and demolition of the old Kleberg County hospital for the City of Kingsville though Tips Purchasing Cooperative Contract #210205.

Background:

City staff has been directed by the City Commission to search for an economical solution for the demolition of the old hospital, which is owned by the City. The first priority was to have an independent asbestos detection company perform a test of the building. After asbestos was detected, further testing was needed but all the debris in the building prevented that, so removal of all the debris was done. You may recall that the old hospital was most recently used as a storage facility prior to the City purchasing it. After the removal of debris, staff located another asbestos company from a purchasing cooperative list to perform an updated asbestos report. The information in the report still showed signs of the asbestos being over the state regulated amount thus requiring abatement by the company prior to demolition of the building.

The company, R.L. Abatement Inc., is a member of the TIPS purchasing cooperative and can perform the asbestos removal, air monitoring, demolition, and disposal of the old hospital. The TIPS Purchasing Cooperative Contract number is #210205. As the vendor is a member of the Purchasing Cooperative, the procurement of their services meets Local Government Code Chapter 271 Subchapter F, which allows for the use of a cooperative purchasing program. Specifically, section 271.102(c) states, "A local government that purchases good and service under this subchapter satisfies any state law requiring the local government to seek competitive bids for the purchase of goods and service." Therefore, competitive bidding statutes have been met. After numerous meetings and negotiations with the abatement company, City staff negotiated the best value for the City with the vendor.

Financial Impact:

Funding is available through a Budget Amendment for line item 121-5-1030-31400, which is the General Fund (GF) ARP Funding-City Special-Professional Services line item. The total cost of services is \$683,750.00. Currently, \$400,000 exists in the line item. A budget amendment for \$283,000 is needed to transfer funds from the Utility Fund ARP funding to this line item in the General Fund ARP funding in order to cover the full cost of the project. Funding is available through a Budget Amendment for line item 121-5-1030-31400, which is the General Fund (GF) ARP Funding-City Special-Professional Services line item. The total cost of services is \$683,750.00. Currently, \$400,000 exists in the line item. A budget amendment for \$283,000 is needed to transfer funds from the Utility Fund ARP funding to this line item in the General Fund ARP funding in order to cover the full cost of the project. Please see attached Bid Proposal and budget amendment.

Recommendation:

It is recommended that the City Commission: 1) award the project and approve a contract with R.L. Abatement Inc. for asbestos removal, air monitoring, demolition, and disposal of the old hospital, which is City-owned property located on E. Caesar Ave., Kingsville, Texas; and 2) approve a budget amendment to cover the project cost.

Summary:

This item authorizes approval to use ARP Funds for the installation of 1) an Access Control System for the City's Dr. Pepper Building by American Integrated Solutions of Corpus Christi, Texas, through GoodBuy Purchasing Cooperative Contract # 22-23-7A000 22 and 2) a new Double Gate System on the West Lee Side of the building by D&C Fence Company of Corpus Christi, Texas, for the City of Kingsville Police Department.

Background:

Currently the Dr. Pepper Building has locksets on all doors throughout the building. The new access control system will allow the Police Department to isolate offices used for Slot and provide access for City Employees to enter the building. The Police Department also has a gym in the building that can be used for fitness for all city employees. The new access control system will allow city employees to access the gym using their current ID badges. The project will consist of a two-component purchase 1) Access Control System for all doors and 2) new Double Gate on the West Lee Side of the building.

Financial Impact:

Funds are available through General Fund ARP line item121-5-2000-71200, of which \$45,000.00 are available this fiscal year. The purchase price is estimated to be \$43,703.63, so there is adequate funding for this item.

Recommendation:

It is recommended the City approve the use of ARP funds for the installation of an Access Control System for the Dr. Pepper Building with American Integrated Solutions of Corpus Christi, Texas and the installation of a Double Gate System for the City's Dr. Pepper Building with D&C Fence Company of Corpus Christi, Texas.
